TERMS OF REFERENCE

Development of a Roadmap:

At the Berlin Process Summit held in Sofia in November 2020, the Western Balkans (WB) Leaders endorsed the Green Agenda for the Western Balkans (GAWB), thereby committing on this way to, among many other objectives, achieving carbon-neutrality of their respective economies by 2050. As a response to the obvious climate change the WB Leaders committed to integrate the EU climate policy into the strategic framework of the WB economies and create an adequate context to properly address the change of climate by undertaking necessary mitigation and adaptation measures adjusted to the reality of WB economies, but with the same objective and time frame as the EU MS. Through these initiatives, the Leaders pledged to net-zero emission by mid-century.

However, besides the overarching climate goal, in the Sofia Declaration, the WB Leaders also set ambitious objectives in the field of Circular Economy and committed to implementing certain sectoral measures. These measures should support a comprehensive transformation of the industry sector and the way we produce and consume today. This includes improving the sustainability of the production of raw materials, developing circular economy strategies, developing waste management frameworks and improving the practice and addressing pollution particularly addressing plastics and microplastics and marine litter. The new circular economy framework also focuses on the car industry, production of batteries, the construction sector as well as textile sector. Having in mind that 80% of the environmental impact of a product during its life cycle is determined in the design phase, one of the backbones of the circular economy will be developing of an adequate eco-design framework.

Another important initiative and pledge from the WB Leaders is to curb pollution of water, air and soil as one of the most important challenges in the WB. These measures should support better protection of resources and ecosystems we depend on in the WB, complete processes of ratification of international agreement and initiatives, and spur processes of development of relevant strategies for the protection of air, water and soil.

The WB Leaders also invited RCC to coordinate the development of the Action Plan for the Implementation of the Sofia Declaration they signed, and to design roadmaps for its implementation. Therefore, the subject Roadmaps to be developed under this assignment should be an integral part of the Green Agenda Action Plan for the implementation of the Sofia Declaration on the GAWB.

PURPOSE AND BACKGROUND

Purpose

The purpose of this assignment is to perform an analysis of the situation in the Western Balkan economies (Albania, Bosnia and Herzegovina, Kosovo*, Montenegro, North Macedonia and Serbia) as well as the most recent developments in the EU regarding the European Green Deal (EGD) including policy, legal framework and strategic objectives, to develop Roadmaps for the implementation of the Sofia Declaration in the areas of Circular Economy, Depollution and Climate Action and to analyse financial mechanisms to support the implementation of the GAWB.

Background information

In December 2019 the European Commission (EC) launched the European Green Deal as the EU's long-term growth strategy which should put the continent on the way towards climate-neutrality by 2050. The EGD is a new development strategy to ensure economic progress through an ecological transition which will lead towards a modern, resource-efficient and competitive economy where economic growth is decoupled from resource use and pollution. This strategic plan provides a framework for developing new, more ambitious policies, for reviewing and revising existing legal frameworks and creating preconditions for reaching net-zero emissions by 2050 as a flagship goal.

For this to be achieved, a thoughtful and comprehensive overhaul of all economic sectors and transformation of the way we produce and consume will be necessary. The EGD puts focus on:

- i) The main drivers of pollution;
- ii) CO₂ emissions and depletion of resources;
- iii) Energy and transport as the sectors with the highest contribution to emissions;
- iv) Industrial development and linear production and consumption model (take-make-use-dispose) with the view of introducing circular economy principles;
- v) Agriculture sector focusing on sustainable food production;
- vi) Irresponsible behaviour towards nature and its ecosystems.

The EGD then proposes profound reforms of all these sectors which should contribute to decreasing emissions and achieving the objective of the Paris Agreement on Climate Change. However, it turned out that the objective set in the form of the National Determined Contribution of 40% in emissions reduction, as previous European Union's (EU) goal for 2030, will not be enough for achieving the climate neutrality envisaged by the EGD. Namely, analyses showed that this, nowadays rather modest target, will lead the EU towards reductions of emissions by only around 60%. Therefore, the EC is now preparing the "Fit for 55%" legislative package expected to be launched in July, which will provide a coherent policy framework to support the implementation across sectors.

In the previous period, the EC also adopted the new Climate Law setting into legislation the objective of a climate-neutral EU by 2050, the new EU Climate Adaptation Strategy as well as the EU Climate Target Plan. This comprehensive policy and legal framework should put the continent on the right track towards achieving net-zero emissions objective by mid-century. Regarding the sectoral policies, the EC has already adopted the new EU Circular Economy Action Plan and the new EU Industrial Strategy.

However, the foreseen transformation will require significant financial investments and support in order to provide a balanced transformation of the regions which differ in the level of economic development. Recognising the need for big financial strains, and the need to support expected processes of economic transformation which won't be without social consequences and risks, the EGD identifies and proposes mechanisms to ease the whole process. One of them is the Just Transition Fund (JTF), established taking into account the ever-growing need for energy as one of the main obstacles to achieving climate neutrality, and bearing in mind that the energy sector is still heavily dependent on coal. Therefore, the EC recently adopted the regulation to establish JTF, a 17.5 billion € fund aimed at ensuring that the EU's shift to a net-zero economy over the coming decades is fair and inclusive, particularly concerning its impact on communities that are heavily dependent on fossil fuels or greenhouse gas-intensive industries. The JTF will be the main instrument to support the EU in coal phasing-out, and leaving no one behind in this challenging process.

Recognising the risks that can negatively impact the EU economy and competitiveness, in case other regions whose economy will remain carbon-intensive do not follow the decarbonisation pace of the EU, the EC proposed introducing a Carbon Border Adjustment Mechanism (CBAM) as another instrument. This carbon tax should protect EU products and services from competitors which may undermine the market by placing their carbon-based

and “dirty” but still cheap products on the EU market. These products and services will represent unfair competition and may invalidate EU efforts at the global level. Therefore, the CABM will be designed to prevent carbon leakages and transfer of production from the EU into the regions with lower and unsatisfying environmental ambitions and standards.

In order to motivate and involve the neighbours, the EGD envisages the development of the GAWB as one of its 47 concrete measures, showing in this way that the WB region is an integral part of the EU efforts and a partner in global ambitions. To support the implementation of the GAWB the EC adopted the comprehensive Economic and Investment Plan for the Western Balkans in early October 2020. On this occasion, the EC pledged to invest € 9 billion for funding of projects in the area of energy, transport, green and digital transition and to support job creation in the sustainable development sector. As an integral part of this Plan, the EC also launched the Guidelines for the Implementation of the Green Agenda for the Western Balkans identifying key areas and concrete measures to be undertaken, where the Commission will provide support in order to quickly bring the WB region on the same carbon-neutrality path as those of the EU MS.

Taking all these into account, and the fact that the GAWB is one out of 47 priority measures of the European Green Deal, it will be the main development strategy and a driver for the necessary transformation of the WB region. Its implementation will be a priority for the economies in the region, while concerted work will be ensured through the Action Plan and sectorial Roadmaps to pave the way toward carbon neutrality as the overarching goal of the entire continent. Being part of the EGD, the GAWB will be the priority not only for the region but also for the entire EU, since the potential failure of the GAWB will not be without impact on the overall implementation of the EGD.

Regarding the regional context relevant for the implementation of the GAWB, in 2015, the RCC has established a Regional Working Group on Environment (RWG Env) as a platform for permanent regional dialogue on environment and climate issues. This regional body consists of high-level representatives from the ministries of environment from the WB economies that meet regularly to discuss issues of regional importance. In addition to this, and under the auspices of the RCC, ministerial meetings take place annually to provide overall guidance for the implementation of the environmental policy at regional level. So far five Ministerial meetings have been organized, while the last one that marked the kick-start of the implementation of the Sofia Declaration took place in December 2020.

The

Roadmap should be realistic but ambitious enough to ensure reaching of the same objectives in the same time frame as the EU MS, taking into account certain lagging behind present in the WB region in relation to enforcement of the Circular Economy legislation. The assignment will also include defining the implementation deadline/timeframe for every single point of the Sofia Declaration (Circular Economy part), identifying the main regional coordinator(s) as well as potential funding sources to support the implementation of respective measures. In addition to this, the consultant is expected to identify and propose indicators to be used for monitoring the implementation of the Sofia Declaration in the future. In this regard, the consultant has to take into account the present and future availability of data in each WB economy, and ensure that the indicators are relevant for progress tracking of concrete elements of the Sofia Declaration. Also, each indicator should be developed following the “SMART” concept and available annually.

The scope of services under this assignment includes the following main activities:

Also, each indicator should be developed following the “SMART” concept and available annually.

Based on this work the consultant is expected to develop a depollution component roadmap for the next ten years, which will be part of the Sofia Declaration Action Plan. The Roadmap should provide a clear, step-by-step guide on what the region has to do to comply with the policy and legal objectives and ensure initial adjusting to the carbon neutrality by mid-century overarching objective. The Roadmap should be realistic but ambitious enough to ensure reaching of the same objectives in the same time frame as the EU MS, taking into account certain lagging behind present in the WB region in relation to enforcement of the relevant legislation addressing air, water and soil pollution. The assignment will also include defining the implementation deadline/timeframe for every single point of the Sofia Declaration, identifying the main regional coordinator(s) as well as potential funding sources to support the implementation of the respective measure. In addition to this, the consultant is expected to identify and propose indicators to be used for monitoring the implementation of the Sofia Declaration in the future. In this regard, the consultant has to take into account the present and future availability of data in each WB economy, and ensure that the indicators are relevant for progress tracking of concrete elements of the Sofia Declaration. Also, each indicator should be developed following the “SMART” concept and available annually.

For each measure of the Sofia Declaration under the depollution area, identify regional coordinator(s), propose a deadline for the implementation and identify potential funding sources.

Task 3:

Based on the previous two tasks, the consultant is expected to develop indicators for monitoring the implementation of the Sofia declaration in the respective policy area, strictly taking into account the present and future data availability and geographical coverage of the whole region.

Task 4:

Propose changes to the draft Action Plan, other measures to be implemented or additional mechanisms to be established in order to support the implementation of the Sofia Declaration on the GAWB in the depollution area.

The consultant is also expected to develop the draft document which will be reviewed by the RCC. After receiving comments the consultant is expected to incorporate them or provide justification in case he/she decides to reject certain comments.

Activity 4: Financing options for the implementation of the Green Agenda for the Western Balkans**DESCRIPTION OF RESPONSIBILITIES****Objectives and Scope of this Assignment**

The objective of this assignment is to conduct an analysis of the situation in the WB economies related to the implementation of the Sofia Declaration on the GAWB and analyse existing financing models as well as potential funding opportunities to support the entire foreseen ecological transformation of the region. The consultant should take into account the Economic and Investment Plan for the Western Balkans, IPA III funding opportunities and WBIF as an important instrument and should also review key bilateral assistance programmes and other projects and activities of donors and IFIs. The consultant is also expected to screen SPPs for key environmental projects and the relevant flagship projects and compile a regional repository of GAWB-relevant projects. The consultant is also expected to retrieve any costing projections in WB6 in terms of meeting relevant GAWB objectives.

Based on this work the consultant is expected to develop a document outlining all existing and potential financial opportunities that will help the WB region in this demanding process

during this decade. The consultant should not only identify financing instruments and options, but also explore and present information on project priorities (within SPP, sectoral strategies, national programmes for approximation ,etc). and try to collect information from the WB economies on estimation of costs needed for the green transformation in the WB economies (individually and at regional level).

Specific Tasks

The scope of services under this assignment includes the following main activities:

Task 1:

Analysing the situation in the WB on available and potential funding opportunities and recommendations on how to support the implementation of the Sofia Declaration on the GAWB through energy, transport, climate, environmental protection, agriculture and biodiversity sectors' measures. These recommendations should constitute an integral part of the GAWB Action Plan. The consultant is also obliged to make a research of available data and estimations of costs of the green transformation in all the areas covered by the Green Agenda in the WB economies, and to present these estimations in a systematized way.

Task 2:

Propose changes to the draft Action Plan, other measures to be implemented or additional mechanisms to be established in order to better reflect the available financing mechanisms and ensure the more effective implementation in the future.

The consultant is also expected to develop the draft document which will be reviewed by the RCC. After receiving comments the consultant is expected to incorporate them or provide justification in case he/she decides to reject certain comments.

Lines of Communication

The consultant will submit all reports and timesheets to the RCC Secretariat for review and approval of deliverables. The consultant will work closely with the RCC which will provide guidelines for efficient finalisation of the assignment. The Team Leader will be responsible for the coordination of the team (if applicable) and communication with RCC staff. In addition to the results of the technical and financial evaluation, a competency-based interview will be held with the selected bidder.

Information on selection of the most favourable bidder
