

Methodology on monitoring and reporting on the Multi-annual Action Plan for a Regional Economic Area in the Western Balkans (MAP)

1. Purpose

This draft Methodology on monitoring and reporting is intended to serve as the basis for preparing regular (Annual and Semi-Annual) reports on the progress achieved in implementing the actions and meeting the objectives of the Multi-annual Action Plan for a Regional Economic Area in the Western Balkans (MAP). This Methodology is prepared by the RCC and CEFTA Secretariats in close cooperation with the MAP Coordinators. The methodology is consulted with National Administrations, the Regional platforms and working groups, the Western Balkan Chamber Investment Forum (WB CIF) and other partners working on regional initiatives relevant to the Regional Economic Area.

2. Introduction

The Multi-annual Action Plan for a Regional Economic Area in the Western Balkans Six (WB6) was endorsed on 12th July 2017 at the occasion of the Trieste Western Balkan Summit. It puts forward a structured agenda for regional economic integration in four main areas, aiming to (i) promote further trade integration, (ii) introduce a dynamic regional investment space, (iii) facilitate mobility, and (iv) create a digital integration agenda. The MAP stems from the commitments undertaken within the framework of the Central European Free Trade Agreement (CEFTA) and the SEE 2020 Strategy. Actions introduced in MAP offer synergies to the reform agendas undertaken in all WB6 driven by the EU integration process, based on EU rules and principles and following the commitments deriving from Stabilization and Association Agreements.

The implementation of MAP actions is intended to result in a rules-based and EU-compliant Regional Economic Area in the Western Balkans enabling unobstructed flow of goods, services, capital and highly skilled labour, making the region more attractive for investment and commerce, accelerating convergence with the EU and bringing prosperity to all its citizens. Adequate monitoring of progress made in attaining these results is crucial to understand where and when the progress is being made as well as to inform any possible adjustments in approach to implementation.

3. Monitoring principles

This Methodology has been prepared with several guiding principles in mind, including:

- All-inclusiveness - The principle of ‘all-inclusiveness’ will be promoted in all structures involved in the monitoring of the activities within the MAP. The successful implementation and monitoring of MAP process requires strong partnership between the WB6 governments, the private sector, the regional and international organizations, donors active in providing support in the policy areas of the MAP, and the European Commission.

- Pragmatism and expediency – Monitoring of MAP implementation will rely, wherever possible, on existing structures, institutions and mechanisms. Qualitative and quantitative assessments and indicators used will be guided by availability and comparability of data with the understanding that the introduction of new indicators beyond those already available in the Western Balkans statistical systems will require clear assessments in terms of costs and feasibility of data acquisition. The MAP monitoring will be reinforced by already existing monitoring processes, such as the one for SEE 2020.
- Simplicity and accuracy – The need to communicate the results of MAP implementation to wide audiences within and outside the region requires the monitoring reports to remain clear, simple and accurate. Progress should be measured in terms that are understandable to broad and heterogeneous group of stakeholders.

4. The Approach to Monitoring MAP implementation

The following section identifies the institutions participating in the monitoring process along with their roles and responsibilities, the types of qualitative and quantitative data used, the frequency and scope of the reporting and the governance architecture to support the ongoing monitoring process.

The MAP monitoring will use both qualitative and quantitative assessment. The quantitative monitoring will be based on the list of indicators listed in Annex 1, whilst the qualitative assessment will be sourced from MAP Coordinators and MAP Component Contact Points who will provide narrative assessment of progress. Additionally, the quantitative and qualitative assessment will be complemented with perception-based assessment – Balkan Barometer being the most relevant source with most indicators collected by the RCC will be included in the assessment.

The monitoring of MAP implementation will enable the WB6 leaders to review the progress and understand back lagging in each component. The insights from the monitoring will offer proposals for better formulation and fine-tuning of the actions, new timelines, realistic and achievable¹.

4.1 Participants in the monitoring process

As noted above, implementation of the MAP process is a comprehensive endeavour and the monitoring of progress should follow closely the implementation structures at both national and regional levels. The institutions participating in the monitoring process include:

- (i) Western Balkans Six administrations:
 - MAP Coordinators and MAP Component Contact Points;
 - Ministries in charge of trade, investment, education, research/science and innovation, and digital economy;
 - Central banks;

- Border and customs authorities, including Veterinary, Phytosanitary Authorities;
- Competition authorities;
- Securities Commissions, Stock Exchanges;
- EURAXESS, ENIC/NARIC offices;
- Electronic Communications Regulators;
- Other relevant ministries, agencies and institutions at the national level;
- National Statistical Offices.

(ii) Regional stakeholders:

- Regional Cooperation Council Secretariat, CEFTA Secretariat and other regional organizations and structures engaged in coordination and implementation of MAP.

4.2 Data to be used

The quantitative data will be sourced from the national statistical systems and the international sources, based on availability, relevance and comparability. The data collected through the SEE 2020 monitoring cycle will also be used where appropriate. To ensure the indicators presented have an inner coherence and to provide a comprehensive overview of the relevant aspects of MAP implementation, each indicator will have to serve a clear role within the broader monitoring system.

4.3 Scoring

MAP monitoring system will introduce scoring per each of the activities and objectives to indicate the level of completeness of each individual action and progress made towards the desired objective. The purpose of scoring will be to convey the progress in simple and clear terms converting qualitative information into quantitative indicators. For the actions having a “continuous” principle for implementation the monitoring process will flag the state of play and factor, to the maximum extent possible, the implementation status at a given period

The progress in the implementation of any action will be assessed based on the following scoring:

4.4 *The monitoring and reporting cycle*

Following on the Guidelines on Governance, Coordination and Reporting, the MAP reporting will be implemented in the following cycles:

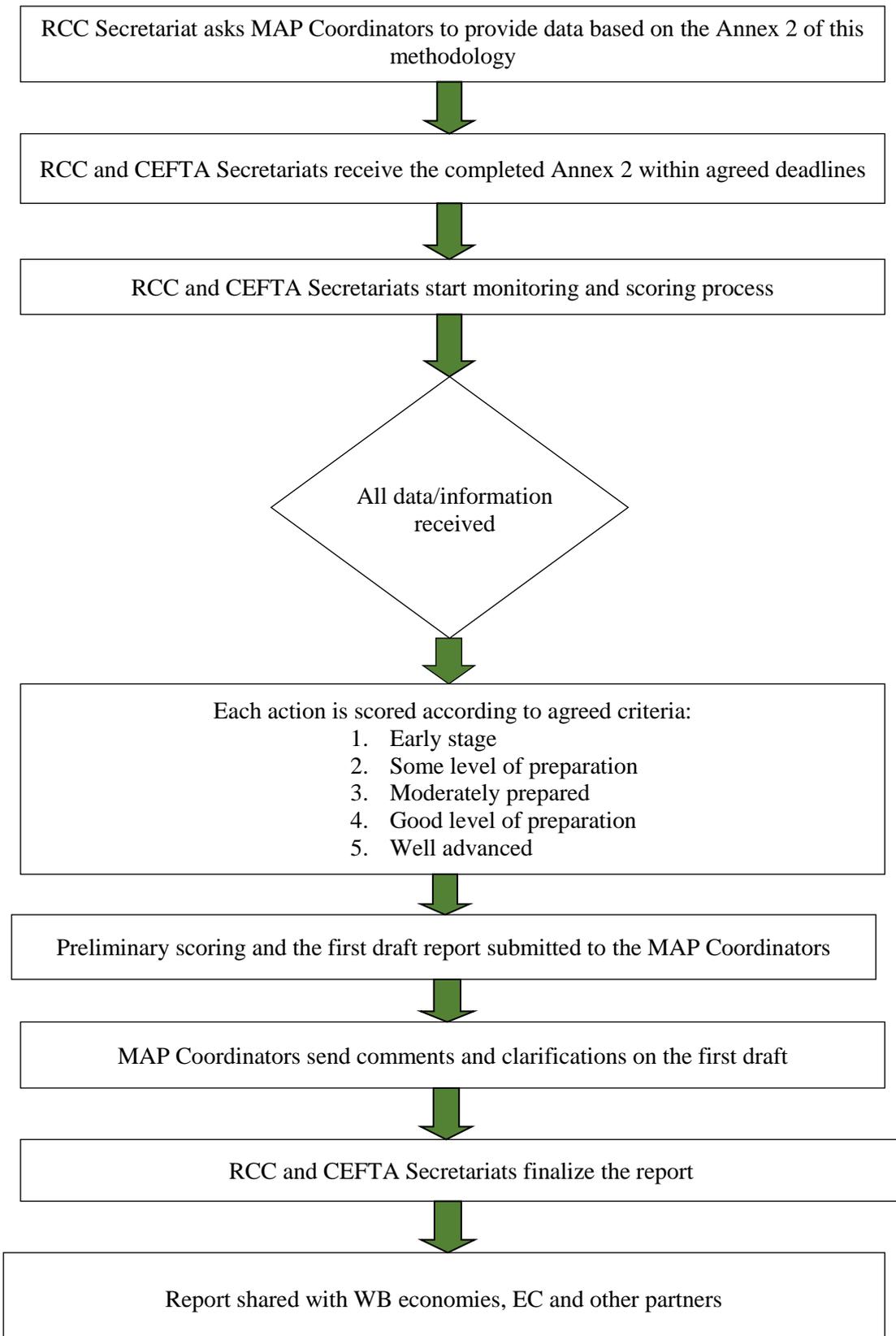
- i. Annual Report - prepared mid-year to inform the WB6 Prime Ministers Summit - to include detailed annual assessment of progress made in each component and each economy. The assessment will cover the period between two Summits of the WB6 Prime Ministers; and
- ii. Abridged Report - prepared at the end of each calendar year – to include a summary of key developments in each component. The assessment will cover the period from the Summit until the end of the year.

The Annual Report will provide both qualitative and quantitative assessments whilst the Abridged Semi-Annual Report will contain only qualitative assessments. The reports will be shared with the WB6 economies through their MAP Coordinators for review. Comments and suggestion will be incorporated to the maximum extent possible.

The qualitative assessments for each economy will be based on predefined templates for reporting. The reporting from the economies will be at action level (Annex 2), and cumulative assessment for the whole WB6 (Annex 3) will be prepared by the CEFTA and RCC Secretariats at objective and component level.

The process of report preparation will be as described in the flowchart below:

5. Limitations of the methodology

As with any monitoring methodology, the methodology proposed herein has some inherent limitations and challenges, such as:

- **Exhaustiveness of progress indicators.** The progress indicators proposed (“some level of preparation”, “moderately prepared”, “good level of preparation”, etc.) lack the necessary detail to describe often complex developments. To adequately capture performance in all actions and each of the economies, the performance indicators should be coupled with other quantitative indicators and a qualitative assessment to provide context.
- **Complexity of governance and coordination.** The multitude of stakeholders participating in the monitoring process at national and regional level require a strong and concerted coordination effort, especially on behalf of the RCC Secretariat, tasked with producing the monitoring reports.
- **Data availability, methodological consistency and comparability.** Both for qualitative and quantitative indicators it will be imperative to provide clear methodological notes to those institutions and stakeholders acquiring the data and/or providing progress assessments. The wording of some of the MAP actions is fairly broad, and the room for differing interpretations should be narrowed as much as possible to avoid inconsistent assessments or incomparable data.
