**10.00 – 11.30** **Regional Investment Instrument**

SEEIC will reflect on the proposals made and discussed during previous workshop (held on 7 May 2019) and meeting (held on 23 May 2019) of the SEEIC-CEFTA Joint Working Group on Investments (JWGI), particularly on the proposal for an instrument for RIRA formalization, developed by the WBG. In this context, the revised proposal for a RIRA instrument will be taken into a consideration, narrowing the options to Regional Standards for Negotiating IIAs and Investment Policy Statement. The SEEIC will also take into account the conclusions of the JWGI meeting of 23 May and the operational conclusions of the WB6 Sherpas meeting (held on 22 May 2019), suggesting to take into consideration development of standards for negotiations of IIAs. Furthermore, the SEEIC will reflect on the draft of a Ministerial Statement proposed by Bosnia and Herzegovina, revised upon the aforementioned JWGI meeting, so as to reflect the MAP REA language and priorities. This session will aim to reach the consensus among the SEEIC participants on the RIRA instrument as per latest discussions and recommendations, as well as to finalize the Ministerial Statement text, which will be ultimately forwarded for consideration and endorsement of the WB6 Prime Ministers at the upcoming WB6 Summit in Poznan (July 2019).
