This report on the activities of the Regional Cooperation Council (RCC) Secretariat is submitted by the Secretary General of the RCC to the RCC Board in line with Article 10 of the Statute of the RCC. It covers the period 4 May – 5 October 2012.

#### I. Summary of activities

The reporting period was characterized by a continuation of the process of undertaking concrete steps for the implementation of the second phase (2012) of the RCC Strategy and Work Programme (SWP) 2011-2013, particularly aimed at an efficient and target-oriented, regionally owned and all-inclusive regional cooperation, as well as by intensive consultations of the RCC Secretary General (SG) with a number of RCC members (Annex I: Report on the implementation of the RCC SWP 2011-2013 for the period 4 May – 5 October 2012, Annex II: List of events and meetings attended by the RCC SG and the RCC Secretariat officials in the period 4 May – 5 October 2012, Annex III: List of Planned events of the RCC Secretariat in 2012, Annex V: List of Abbreviations).

In parallel, the RCC Secretariat continued to closely monitor the overall developments in the region in particular those related to the regional cooperation activities in general as well as those within the EU Enlargement Agenda.

The seventeenth RCC Board meeting, among other issues, discussed and accepted the Annual Report of the RCC SG on regional cooperation in South East Europe (SEE) for the period 12 May 2011 – 15 May 2012 and approved the Report of the RCC SG on the activities of the RCC Secretariat and on the implementation of the RCC SWP 2011-2013 for the period 6 March - 3 May 2012. The ninth Coordination meeting between the South East Europe Cooperation Process (SEECP) Troika, the RCC Secretariat and European Union (EU) discussed important issues related to the cooperation of the previous and the current SEECP Chair-in-Office (C-i-O) 2012 - 2013 and the RCC Secretariat.

The Fourth RCC Annual meeting and the high-level SEECP meetings have confirmed the key role of the RCC in promoting and developing a comprehensive, sustainable and more stable regional cooperation in SEE and adopted the Annual Report of the RCC SG on regional cooperation in South East Europe (SEE) for the period 12 May 2011 – 15 May 2012.

The meetings also marked the appointment of Mr. Goran Svilanovic as a new Secretary General of the RCC, which becomes effective as of 1 January 2013, as well as the assuming of the SEECP C-i-O by The Former Yugoslav Republic of Macedonia.

The RCC SG actively took part at the Informal meeting of the SEECP MFAs, organized by the SEECP C-i-O 2012-2013, on the margins of the 67<sup>th</sup> UN General Assembly in New York, emphasizing, among the other, the need to consolidate regional cooperation and proposing different steps in strenghtening its essential framework – the SEECP. Prior to the Informal meeting, in a separate bilateral meeting, the Bulgarian MFA N. Mladenov awarded the RCC SG with Golden Laurel Medal for his valuable contribution to and inspiring leadership in promoting tolerance, dialogue, moderation and mutual understanding as essential pillars of regional cooperation in the complex SEE environment.

The RCC SG, within the permanent dialogue with RCC members, held consultations with high-level officials from Prishtina (UNMIK, EUSR and Kosovo\* authorities), Podgorica, Skopje and Washington D.C., as well as with senior officials from the European Commission (EC) and the European External Action Service (EEAS).

The RCC Secretariat, and in particular the Deputy RCC Secretary General (DSG) and the Expert Pool, continued to be intensively involved in managerial and steering bodies of different regional initiatives, to provide support in incubating new projects and organizing important events, to prepare Memorandum of Understandings (MoUs) with key partner organizations, and to promote Regional Initiatives and Task Forces (RI&TFs).

The 11<sup>th</sup> South East Europe Investment Committee (SEEIC) Meeting confirmed that the process of transferring the SEEIC to the RCC proved to be a major catalyst to accelerated development of the SEE 2020 Strategy and that the SEEIC has become a central point on the map of the regional cooperation playing, with the back-up of the RCC, a key role in the development of regional strategies to advance the region's economic development and integration with the EU. The set of nine targets for integrated, smart, inclusive and sustainable growth in the region until 2020 was supported by the members of the SEEIC. The proposed targets for the SEE 2020 Strategy include growing the region's total value of trade in goods and services to more than a quarter trillion USD compared to 2010, reducing the trade deficit, and growing intra-regional trade in goods by over 200%.

The SIDA financed project Women Entrepreneurship (WE) – a job creation engine for SEE to be implemented by the South East European Centre for Entrepreneurial Learning (SEECEL) and the Gender Task Force (GTF) and coordinated by the RCC Secretariat, has been officially launched on 21 September 2012.

The RCC Secretariat was engaged in different activities with the Energy Community Secretariat and in preparation of important regional events in the area of air transport, railways and road safety.

The Third Congress on Roads, organized by the RCC Secretariat and the Association of Consulting Engineers of Bosnia and Herzegovina, under the auspices of the Ministry of Communication and Transport of Bosnia and Herzegovina discussed and analyzed results and future challenges in the development of the road infrastructure in the Western Balkans.

The RCC Secretariat made full use of the existing regional instruments, frameworks and networks in the area of Justice and Home Affairs – *inter alia* the Steering Group on Regional Strategy (SGRS), the Monitoring and Evaluating Mechanism (M&EM) and the Expert Teams on Judicial Cooperation, with the aim of developing a comprehensive and holistic approach to the rule of law sector, together with a judicial and democratic control of regional actions. The RCC Secretariat finalised the commissioning of the data base application designed to collect and integrate the statistical indicators of the M&EM and the first centralized statistical data is available from the end of September 2012.

The RCC Secretariat continued to intensify cooperation between the defense structures and intelligence services of the countries from the region. The 2<sup>nd</sup> conference of the National Security Authorities of South East Europe Countries (SEENSA) adopted a number of specific documents and decisions related to future activities in areas of common interest for the Heads of the Classified Information Authorities. The 4<sup>th</sup> meeting of the South East Europe Military Intelligence Chiefs (SEEMIC) adopted the first regional common intelligence analysis on contemporary challenges.

The role of the RCC Secretariat has grown in the Building Human Capital and Parliamentary Cooperation regional programmes and projects. The focus was put on the implementation of the Regional Strategy for Research and Development for Innovation for the Western Balkans, support to the RCC Task Force on Culture and Society where it has signed with the EC a grant contract regarding the project "Sustaining the Rehabilitation of Cultural Heritage", developing the project "Parliamentary Cooperation in the Western Balkans and Turkey - Support to the Cetinie

Parliamentary Forum". The RCC Secretariat has been engaged in the process of exploring the ways for realizing of the initiative of establishment of the Regional Film Fund, following the interest the countries of SEE expressed in the Declaration of the Annual Meeting of the Council of Ministers of Culture of SEE (CoMoCoSEE), held in Belgrade in April 2012 and the conclusions of the Regional Film Forum, held during the Sarajevo Film Festival in July 2012.

The RCC Secretariat continued with its communication activities and efforts in fostering freedom of media in the region. One of the most important events in this respect was the First Academy on Media Law held under the auspices of the RCC Secretariat.

The RCC Secretariat's Liaison Office in Brussels contributed to the further development of cooperation with the EU institutions and other relevant Brussels based institutions and stakeholders, resulting in a number of important meetings held.

#### II. General and institutional aspects of the RCC Secretariat's activities

#### RCC Board Meeting

The seventeenth RCC Board meeting was held on 15 May 2012. The RCC SG presented his Annual Report on regional cooperation in SEE for the period 12 May 2011 – 15 May 2012, which highlights the wider regional developments in SEE, the state of play of the regional cooperation from the point of view of the RCC activities and in the general context, points to the political and socio-economic difficulties in the region, the state of institutional relations of the SEE countries with the EU and focuses on the results attained in each priority area following the completion of the implementation of the first year (2011) of the RCC SWP 2011 – 2013. The RCC SG also presented his Report on the activities of the RCC Secretariat for the period 5 March – 3 May 2012, briefed on the results of the Coordination meeting between the SEECP Troika, the RCC Secretariat and the EU, on the most important current and incoming activities of the RCC Secretariat and on his intention to continue holding regular consultations with RCC members in view of raising the awareness and importance of further strengthening regional cooperation and enhancing the role of RCC.

The DSG/Head of Expert Pool informed on the activities and results achieved in each priority area of cooperation, in the context of the implementation of the second phase (2012) of the RCC SWP 2011-2013.

The Serbian SEECP C-i-O informed on the process of nominating the Secretary General of RCC, with the RCC Board members reviewing subsequently the proposed candidates. The RCC Board members exchanged views on the procedure of consultation and selection of the candidates, pointing out that the RCC statutory documents on this particular issue are not sufficiently clear and will need to be addressed within the foreseen work on the RCC Statute.

The RCC Board members welcomed and commended the Annual Report of the RCC SG, particularly the comprehensive analysis of the wider regional cooperation process in SEE and of the results accomplished in every priority area of cooperation in the region.

The RCC Board meeting reached the following conclusions: the RCC Board accepted the Annual Report of the RCC SG on regional cooperation in SEE for the period 12 May 2011 – 15 May 2012 with the proposed amendments; approved the Report of the RCC SG on the activities of the RCC Secretariat and on the implementation of the RCC SWP 2011-2013 for the period 6 March - 3 May 2012 and approved the Financial Report of the RCC SG for the year 2011. The RCC Board meeting took the following decisions: 1) Decision on the Amendment to the Budget of the RCC Secretariat

for the year 2012 and 2) Decision on the Adoption of the Addendums to the Financial Management Manual of the RCC Secretariat.

#### Coordination between the SEECP and the RCC

The ninth Coordination meeting of the SEECP Troika – Montenegro, Serbia and The Former Yugoslav Republic of Macedonia - the RCC Secretariat and the EU (representative of the European Commission and the representative of the High Representative of the Union for Foreign Affairs and Security Policy) was held on 14 May 2012.

The agenda of the meeting included: presentation of the Annual Report of the RCC SG on regional cooperation in SEE for the period 12 May 2011 – 15 May 2012; information on the most important recent and future activities related to the priorities of the Serbian SEECP C-i-O and of the RCC, in particular those pertaining to the implementation of its SWP 2011 – 2013; information by the Serbian SEECP C-i-O on the process of nominating the Secretary General of RCC, i.e. review of the proposed candidates and further steps in the process of streamlining regional taskforces and initiatives in SEE.

The Serbian SEECP C-i-O informed on the process of nominating the Secretary General of RCC. The participants, without entering into discussion on the nominated candidates, touched upon the issues related to the procedure of consultation with the RCC Board members and selection of the candidates.

The Former Yugoslav Republic of Macedonia, in its capacity as the SEECP C-i-O for the period June 2012 - June 2013, informed on the activities related to the preparation of their programme.

The RCC DSG/Head of Expert Pool reflected on the current state of affairs of the implementation process of the RCC SWP 2011-2013 and on the steps undertaken in the streamlining of regional task forces and initiatives in SEE.

The conclusions of the Coordination meeting, inter alia, welcomed and appreciated the Annual Report of the RCC SG on regional cooperation in SEE for the period 12 May 2011 – 15 May 2012; commended the achievements of the RCC Secretariat in implementing its SWP 2011- 2013 and expressed full support to its present and future work as well as reiterated the determination of the RCC Secretariat and the incoming SEECP C-i-O to continue cooperating dynamically with the aim of further increasing the synergy and coordination of their activities.

The RCC SG actively participated in the Informal meeting of the SEECP MFAs, organized by the current SEECP C-i-O 2012-2013, on the margins of the 67<sup>th</sup> UN General Assembly in New York. The MFAs reiterated their countries' full commitment to the EU enlargement policy, stressing its transformative and stabilization impact on the region and shared views and ideas on strengthening regional cooperation and consolidating its essential framework – the SEECP such as to hold thematically focused and targeted SEECP Summit meetings, to have more regular meetings of the MFAs, to enhance the position of the RCC National Coordinators, etc. The MFAs pointed out that the work of the RCC Secretariat is an invaluable platform for providing tangible and concrete results in many priority sectors. They called for a smooth transition of the RCC management to the incoming SG and highly praised the work done since the inception of the organization by current RCC SG. The RCC SG, inter alia, expressed support for the suggestions made by the MFA's in particularly those regarding the concept how the countries could support each other on their way

toward EU and NATO and underlined the need of developing joint large trans-regional infrastructural projects and, in general, regional recovery and development plan.

The RCC SG was invited for consultations with the MFA of the current SEECP C-i-O 2012-2013 in Skopje. The parties exchanged views regarding the overall developments in SEE and the perspectives for strengthening regional cooperation in light of the discussions at the high-level SEECP events in Belgrade last June, further improving cooperation and enhancing the coordination between the SEECP C-i-O and the RCC Secretariat, in particular on issues related to the implementation of the priorities of their respective work programmes and organization of important joint activities.

#### RCC Annual Meeting

The fourth RCC Annual Meeting took place on 13 June 2012 in Belgrade, back to back with the meetings of the Ministers of Foreign Affairs and of the Heads of State and Government of the SEECP. The meeting was co-chaired by the Secretary General of RCC and the Serbian SEECP C-i-O and was attended by 37 members of the RCC, including all members of the SEE. The Agenda of the meeting included introductory remarks by the State Secretary of the Ministry of Foreign Affairs of the Republic of Serbia and by the Secretary General of the RCC; the Annual Report of the Secretary General of the RCC on regional cooperation in South East Europe for the period 12 May 2011–15 May 2012 – presentation and endorsement; Presentation of the RCC Secretariat's Self-assessment Report on the First year of the implementation of the RCC Strategy and Work Programme 2011-2013; Endorsement of the nomination proposal for the Secretary General of the RCC.

In presenting the main achievements and challenges of regional cooperation, the RCC SG emphasized that the region reached a point of crucial decisions regarding its EU future, pointed out to the advancements in the process of reconciliation and rapprochement whilst commending the relaxed and widened human contacts across the region. He highlighted the necessity for a consolidated and sustained cooperation process among the SEE countries, especially in the context of the remaining unresolved issues. The RCC SG informed that RCC is half way through the implementation process of the triennial SWP, and has delivered on almost two thirds of the assigned tasks. He also informed the meeting about the formal request received from Kosovo\* to become a member of the RCC in accordance with the EU facilitated Arrangements Regarding Regional Representation and Cooperation.

The RCC DSG/Head of Expert Pool presented the RCC Secretariat's Self-assessment Report on the First year of the implementation of the RCC SWP 2011-2013, focusing on the most important achievements and the ways ahead.

The RCC members that took part in the discussion recurrently emphasised the RCC Secretariat's important role in building and strengthening ties among SEE countries and in promoting regional stability and prosperity, as well as that of the RCC SG, and reconfirmed their full support to the RCC.

They underlined the need to further strengthen the already ongoing prolific coordination of the RCC with the SEECP C-i-O, discussed the potential role of the RCC in the development of the regional transport infrastructure and expressed support to its current initiatives, especially in the field of railways rehabilitation.

They also stressed the importance of preserving the principle of all-inclusiveness as an important prerequisite for fruitful cooperation between all the RCC members. The importance of a financial sustainability of the RCC Secretariat was reinforced by a call to the RCC Board members to allocate their annual financial contributions within the agreed timeframes. The meeting endorsed the Annual Report of the Secretary General of the RCC on regional cooperation in SEE for the period 12 May 2011–15 May 20012 and the nomination proposal of the Committee of the SEECP Political Directors for appointing Mr. Goran Svilanovic as new Secretary General of the RCC.

The concrete results achieved by the RCC in the implementation of its SWP 2011-2013 and the discussions during the RCC Annual Meeting confirmed that a prioritized and project orientated regional cooperation, coordinated with the EU agenda, can serve as an impetus to the multifaceted development of SEE. The meeting provided strategic guidance for the period ahead and reaffirmed the principle of regional ownership and all-inclusiveness. The RCC SG expressed gratitude to the RCC members of the region for their growing awareness of the added value that regional cooperation brings to the national and regional level. He also underlined the pertinent role that the EU and its institutions, particularly the European Commission but also other RCC members outside the region, have in supporting the RCC.

The RCC SG congratulated the new RCC Secretary General and expressed his readiness and that of the RCC Secretariat to assist him during the transition period and to ensure a smooth transfer of duties.

### Participation of the RCC Secretariat delegation at the SEECP high-level meetings of the SEECP C-i-O 2011-2012, held in the period 12 – 15 June 2012 in Belgrade

The RCC Secretariat delegation actively took part at the meetings of the Political Directors, Ministers of Foreign Affairs and of the Heads of State and Government of the SEECP Participating States by providing substantial contribution in the drafting of the SEECP Belgrade Declaration and in the plenary sessions.

The delegations of the SEECP Participating States commended the work of the RCC SG and of the RCC Secretariat, marked by concrete results in the implementation of the RCC SWP 2011-2013, welcomed the RCC Secretariat's Self-assessment report on the implementation of the first year of the RCC SWP 2011 – 2013 and emphasised the important role that RCC should exert in addressing the needs of the region through concrete regional projects, such as, in the field of railway transportation. They also praised the advanced level of synergy between the SEECP and the RCC, stressing that the SEECP should use the institutional backbone provided by the RCC in order to transform the political declarations into concrete projects and agreed to look how to promote further the concept of regional ownership, including through a "Group of the Wise".

The SEECP MFAs approved and, subsequently, the SEECP Heads of State and Government adopted the Annual Report of the RCC SG on regional cooperation in SEE for 2011 – 2012, appointed Mr. Goran Svilanovic as new Secretary General of the RCC and the SEECP Heads of State and Government approved the appointment, which becomes effective on 1 January 2013. The SEECP Belgrade Declaration was not adopted due to differences on one paragraph between two SEECP Participating States. The meetings in Belgrade marked the end of the Serbian SEECP C-i-O and the beginning of the SEECP C-i-O of The Former Yugoslav Republic of Macedonia for the period June 2012-June 2013, as well as the agreement on the SEECP C-i-O of Romania for the period June 2014.

#### Consultations of the RCC Secretary General with RCC members

The RCC SG, in the framework of the permanent dialogue with RCC members, held consultations with high-level officials in Prishtina (UNMIK, EUSR and Kosovo\* authorities), Podgorica, Skopje, Washington D.C. (U.S. Department of State and the World Bank), as well as in Brussels with senior officials from the EC and the EEAS.

The RCC SG presented views on the most important current political and socio-economic developments in SEE and on the dynamics of the EU enlargement process. He stressed the duality of positive trends in the process of European integration, meaning that the countries in general are on the reform path, and by unresolved open issues, by temporary economic revivals and by a lack of a long-term sustainable economic growth, by sporadic attempts at improving social cohesion and by deep social dissonances. The challenges posed by the duality of these developments require collective action and solidarity. Furthermore, the need to continue improving regional cooperation, particularly by ensuring all-inclusiveness and greater inputs from the national authorities of the RCC members from SEE, remains of an utmost importance.

In the light of the SEECP debate on the future of regional cooperation, the RCC SG underlined that the region needs to work on consolidating regional cooperation and assuming greater regional responsibility, including addressing open issues. In this sense, he made suggestions related to development of joint strategic regional economic and infrastructural projects, e.g. on the railways rehabilitation in SEE highlighting that this approach would additionally contribute to durable stability, in particular in light of the open issues and prolonged EU accession process. Following the reference on this issue in the SEECP Summit Belgrade Declaration, the RCC SG launched the idea of organizing an expert meeting, with representatives of the current SEECP C-i-O, SEETO, EC, World Bank, RCC Secretariat, Western Balkans Investment Framework and SEE countries, to be held by the end of 2012.

He also informed about RCC Secretariat's intention to commence the preparatory work on the SWP for the period 2014-2016 to be adopted at the SEECP Summit in June 2013, which overall aim should be to reflect better the priorities of the countries of the region. The top priority of the new SWP, in the opinion of the Secretariat, should be the inclusion of the economic and infrastructure development area, in addition to the main aspects of the most important current activities. The RCC SG presented the main arguments in support of the expressed need by some of the RCC Board members to adjust the present Statute of the RCC or, in the opinion of the RCC Secretariat, to prepare a draft of a new document that would reflect the current realities of the five year existence of the RCC.

The counterparts from the aforementioned RCC members reiterated their support to the RCC Secretariat's activities, reflected on the value of the RCC in promoting regional cooperation, expressed an interest in supporting the process of consolidating regional cooperation in SEE, noted the importance of aligning further the work of the RCC with the EC enlargement agenda and assessed positively the initiative for preparing a new Statute of the RCC.

#### Participation of the RCC Secretary General in other regional meetings and events

The RCC SG participated at a number of high-level regional events and international meetings with a regional dimension such as the XI meeting of the Western Balkans Working Group Committee of the Regions, the international Donor's Conference on the implementation of the Joint Housing Program of Bosnia and Herzegovina, Croatia, Montenegro and Serbia, the Regional Ministerial Conference on Organ Donation and Transplantation, Croatia Summit – State Building and the EU experience, the first Media Law Academy in SEE, the 26<sup>th</sup> meeting of the Black Sea Economic Cooperation Council of MFA, Regional conference on Government's Energy Policy, Bled Strategic Forum, the OSCE Workshop on International Response to Major Natural and Man-made Disasters, South East Defence Ministerial etc, and used the opportunity to present the main activities of the RCC.

#### Cooperation with the EU and other Brussels based institutions

The RCC Liaison Office (LO) in Brussels continued with its contribution to the implementation of the RCC SWP 2011-2013 and, taking into account the importance of regional cooperation as a key element of the Stabilization and Association Process and as a part of the EU Enlargement Agenda, to closely monitor the developments in this area within a wider regional context and those of the individual aspiring countries. The RCC LO further enhanced and intensified the cooperation with the EU institutions, primarily the EC, the European Parliament (EP) and the EEAS and other relevant Brussels based institutions and stakeholders, such as NATO, IFI Coordination Office, European Policy Centre, Friends of Europe etc. In this sense, the RCC LO had a number of meetings with different representatives of the EC, including with the Commissioner for Health and Consumer Protection, the Director General of OLAF, as well as with several MEPs working on the Western Balkans, the Permanent Chair of COWEB, the EEAS policy officer for regional cooperation, etc. The main topics discussed were the current state of implementation of RCC SWP 2011 - 2013, the RCC Secretariat self-assessment report, the EU Enlargement dynamics and the usefulness of further aligning RCC's role with the EU Enlargement Agenda, the practice of RCC's briefings for COWEB, the budget situation of the RCC Secretariat, etc.

Despite all difficulties and challenges, the EU Enlargement process continued and marked several very encouraging results. The Croatia Accession Treaty was ratified by more EU member states, the accession negotiations with Montenegro were opened, the second and third rounds of the High Level Accession dialogue with The Former Yugoslav Republic of Macedonia were held, the candidate status to Serbia was granted, a High Level Dialogue on Accession with Bosnia and Herzegovina was launched, an agreement on a list of deliverables on the key priorities with Albania was reached and a Feasibility Study on Kosovo\* was launched.

The RCC Secretariat, following the interest expressed by the EU institutions, provided appropriate inputs for the Annual Progress Reports and the EC Enlargement Strategy and information on the practical implementation of the Arrangements Regarding Regional Representation and Cooperation.

In the context of regular consultations with the EU institutions, the RCC LO organized and participated in the meetings of the RCC Secretariat delegations with the Deputy Director General for Enlargement in the EC, the Director for the Western Balkans and Turkey in the EEAS, the briefing for COWEB, the Head of Regional Cooperation and Programs Unit and Head of Strategy and Policy Unit in DG Enlargement. In addition, the RCC LO organized a separate meeting of the RCC SG with the Director General for Enlargement in the EC.

The RCC Secretariat representatives presented assessment of the overall political and economic developments in the region of SEE, highlighted the need for consolidating the regional cooperation and elaborated on the possible steps in this regard, including the preparation of a new Statue of the RCC. They also presented an overview of activities in a number of sectors covered by the RCC SWP 2011-2013, informed about the plans for preparing the new RCC SWP 2014-2016, discussed RCC inputs for the Annual Progress Reports and the EU Enlargement Strategy and exchanged views on the future financing requirements for RCC activities.

The RCC LO participated in the meeting of RCC Deputy SG and DG MOVE. The parties discussed the overall coordination between the RCC Secretariat and DG MOVE in the transport area and the Commission's support for the RCC Secretariat application for the Airspace Feasibility Study proposal submitted under the 8th Call for proposals launched by the Western Balkans Investment Framework (WBIF).

The RCC LO took part at the Third RENA Ministerial Meeting with the participation of the Commissioner for Environment and the Environment Ministers from the enlargement countries. The meeting provided an overview of the implementation of the RENA network activities, a forum to discuss and endorse the Road Map for RENA future regional and multi-beneficiary activities in the environmental and climate change fields in the pre-accession context; and the role of RENA network as a platform for exchange of information and experiences.

The RCC LO participated in the DG Employment seminar at which the report of the IFI Coordination Office "Financing Social Sector Projects in the Western Balkans – Challenges and Opportunities for the WBIF" was presented and in the launching of the UNODC new regional program for SEE 2012-2015 "Countering illicit trafficking and organized crime for improved governance, justice and security " where the readiness of the RCC Secretariat to continue its collaboration with UNODC on the implementation of the new program for the benefit of the citizens of the region was conveyed.

The RCC LO participated as a speaker at the EPC event: "The euro-zone crisis, economic developments and policy challenges in the Balkans: what prospects for growth? ", presenting the activities of the RCC Secretariat in the areas of economic and social development, in particular the transfer of the SEEIC from OECD to the RCC Secretariat and the results of the  $10^{th}$  meeting of SEEIC. Regional cooperation frameworks in areas such as free trade, electricity market, transport, investment, agriculture, health and numerous other important fields have emerged, which helps connect the fractured markets in the region, but has also enabled sharing of experience and knowledge which is an excellent opportunity to deepen and strengthen regional cooperation.

The RCC LO representative held regular meetings with the Local Administration Facility (LAF) Team Leader and Project Managers, Institution Building Unit, DG Enlargement, to discuss the arrangements of joint event to take place in October 2012 in Skopje, 'Implementing energy policies at local level'.

#### Regional cooperation in the field of media

The RCC Secretariat, in line with the conclusions of the international seminar South East Europe 20 Years On: Transformation from State to Public Broadcasting continued activities to foster freedom of the media in the region, particularly in the field of public broadcasting.

The most important event in this respect was the First Academy on Media Law, held in Zagreb, under the auspices of the RCC Secretariat and with support of the Friedrich Ebert Foundation, the OSCE Representative on Freedom of the Media, and the OSCE Mission to Bosnia and Herzegovina, and implemented by ARTICLE 19: Global Campaign for Free Expression and the European Association of Public Service Media in South East Europe. The five-day Academy, the first of a kind in SEE, gathered media experts from all countries of SEE who exchanged ideas and sought solutions to common issues concerning freedom of expression and media freedom. They discussed issues aimed at safeguarding media freedoms by enhancing regional cooperation and by building up capacity of media lawyers to use the best national media laws and formulated recommendations for legal reforms based on the best practices in the region in line with international and European media standards.

The RCC Secretariat co-organized, with the RACVIAC – Centre for Security Cooperation, the European Association of Public Service Media in South East Europe and the Croatian Radio-Television, a conference on investigative journalism and data protection as a follow-up activity to the conference on public media and security in SEE (held in November 2011 in Zagreb). The meeting included journalists and spokespeople/public relations professionals from the Ministries of Defence of the SEE countries as well as representatives of relevant international organizations. It discussed ways of increasing regional cooperation by using dialogue and exchange of information, knowledge transfer, views and ideas, with the goal of disseminating international standards related to investigative journalism and data protection and building a more open, transparent and stable environment in SEE.

The RCC Secretariat took part in the 2<sup>nd</sup> OSCE South East Europe media conference in Belgrade and the 1<sup>st</sup> conference on media platform within the EU Strategy for the Danube Region in Vienna.

#### Communication activities

The RCC Secretariat has continued to advance the organization's mission of promoting mutual cooperation and European and Euro-Atlantic integration of SEE in order to inspire development in the region to the benefit of its people, by interacting with the media on a regular basis and by working in developing relationships and positioning the RCC as a key regional player through conducting permanent outreach among politicians, opinion-makers, think-tanks, diplomats, public officials, academia, students, business community, etc.

Following the Fourth Annual Meeting of RCC and the high-level SEECP meetings, the RCC Secretariat organized a briefing for the diplomatic community in Sarajevo to inform of the mentioned events. Further on, the Secretariat met with twelve representatives of six leading Slovenian media.

In the reporting period, the RCC Secretariat organized press coverage of 22 different events, and to the knowledge of/available to the RCC Secretariat, 389 articles, interviews and statements on the RCC were published in South East European and international media, bringing the total to 4,000 available articles published since the beginning of operations of the RCC Secretariat. The same period witnessed 1,728,533 hits, 460,326 page views and 57,966 visits of the website, bringing the total to some 12,652,862 hits, 4,467,982 page views and 386,432 visits over the past four years since the website statistics has been gathered. The RCC currently also has 224 tweets and 211 followers at its Twitter account. Three issues of the RCC newsletter were published, devoted to the following topics: South East Europe Investment Committee, investment promotion, Western Balkan enterprise development and innovation facility (EDIF); RCC Annual Meeting 2012; as well as regional cooperation in justice and home affairs – implementation of the Regional Strategic Document 2011–

2013, and exchange of classified information in South East Europe. The issues included 30 prominent contributors and were circulated to an audience of over 2,700 subscribers. The Secretariat continued promoting RCC activities and other important regional events in SEE by preparing and distributing a monthly overview based on its daily press review, as well as by sharing with members of the RCC Board reports prepared by the RCC Secretariat officials.

#### Evaluation of general and institutional aspects

The reporting period was characterized by a continuation of the process of undertaking concrete steps in the context of the implementation of the RCC SWP 2011-2013, particularly aimed at the efficient and target-oriented, regionally owned and all-inclusive regional cooperation. In order to maintain the momentum of the development of regional cooperation and continue with the affirmation of the principle of regional ownership as well as highlighting the importance of moving towards regional responsibility, the strategic character of relations between the SEECP and the RCC remains pivotal. Drawing on the successful cooperation with the previous as well as incumbent SEECP C-i-O, the regular Coordination meetings of the SEECP Troika and the RCC Secretariat with the participation of the EU proved to be a very useful tool in providing guidance and enhancing overall coordination.

The Fourth Annual meeting of RCC and the high-level SEECP meetings have confirmed the key role of the RCC in promoting and developing a comprehensive, sustainable and more stable regional cooperation in SEE.

The period ahead will be of particular importance for the shape of the regional cooperation in the context of the debate within SEECP and consequently for the future role of RCC. In parallel with the efforts related to the implementation of the remaining objectives of the RCC SWP 2011-2013, the RCC Secretariat, in close cooperation with the RCC Board members of SEE, the EU and the other interested stakeholders, will start the process of preparing the new SWP for the period 2014-2016 which should be endorsed at the SEECP Summit in June 2013. The successful implementation of the current and the new SWP is and will be dependent on timely honoring of the financial contribution of all RCC Board members to the operational budget of the RCC Secretariat. In this respect, the intention of the EC to continue with its contribution for the period beyond 2013 is highly encouraging. Another important issue on the RCC Agenda will be the process of adjusting the RCC Statute to the new realities in SEE.

The appointment of the new RCC SG has been seen as a new opportunity of further upgrading the role of RCC, building up on the results it has achieved so far, and successful fulfillment of its mandate and the expectations the RCC members have expressed in that respect.

Taking into account the very important and challenges tasks ahead of RCC in particular the preparation of the new RCC SWP 2014-2016, the current RCC SG established close communication with the incoming RCC SG in order to ensure a smooth transition of the duties and continuity of the strategic and daily work of the RCC Secretariat. To that effect, it has been agreed, upon the initiative of the Director General for Enlargement, to have a joint trilateral meeting in the course of November 2012. Also, following the consultations with the incoming RCC SG, the current RCC SG has extended the employment contract of the Head of Expert Pool for six months (due to the prescribed age limit in the Policy on Personnel of the RCC Secretariat) and to the RCC Secretariat staff for one year.

#### III. Priority areas of the RCC Activities

#### Activities of the Deputy Secretary General and Head of the Expert Pool

The RCC Secretariat was intensively involved in different activities organized in the SEECP framework, in particular in preparing a number of sectoral meetings to be organized by the current SEECP C-i-O 2012-2013 and related to the RCC Strategy and Work Programme 2011-2013 (parliamentary dimension, ministries of defence, civil society event).

The dialogue with the DG Enlargement continued to be regular and substantial, as well as with CEFTA and OECD Investment Compact. Consultations have been regularly held with other donors interested in regional projects (UNDP, OSCE, IBRD, SDC, SIDA, FES, GIZ, HBS, US AID etc). Furthermore, RCC Secretariat intensified contacts with other DGs in the EC (DG REGIO, DG MOVE, DG Research, Innovation and Science, DG Education and Culture, DG International Cooperation, Humanitarian Aid and Crisis Response, etc) as well as with the specialised units within the External Action Service for security cooperation area. The RCC Secretariat is further strengthening cooperation with other regional structures in SEE and the Western Balkans as it is shown in detail per each priority area.

As part of its activities of coordinating donor efforts in the region, the RCC Secretariat took part in donor-organized activities. The RCC Secretariat took part in USAID's annual meeting for the SEE and Central Asia region to present some of its activities on developing a regional SEE 2020 platform and explore potential joint regional activities. The RCC Secretariat had regular consultations with GIZ and signed a MoU on cooperation with the GIZ Open Regional Funds for South East Europe. Common activities were organized or supported by the SIDA, Swiss Aid, Friedrich Ebert Foundation, DVV etc. The RCC Secretariat and the UNDP extended for another three year period their cooperation on the implementation of the regional activities of South East European Clearinghouse for Small Arms Control.

A permanent dialogue continued with different stakeholders from the region: private companies and associations, NGOs and NGO related organizations (TACSO team, Eco-Social Enterprises Network from SEE, BFPE, ICDT, SEE Change Net etc), operating RI&TFs and newly established regional networks (SEE Public Private Partnership Network, Regional Network of Investment Promotion Agencies etc.) discussing the issues and modes of cooperation and developing common activities. The dialogue further widened to include think tanks from the region and beyond (i.e. LSE Network of SEE researchers, Faculty of Social Sciences, University of Ljubljana) developing and coordinating joint programmes, financial institutions (presidents of the securities regulators and directors of the stock exchanges from Southeast Europe), as well as other EC and IFIs partners. The RCC Secretariat was also represented at the different events relevant for the development of regional cooperation – from think-tank and academic conferences to the EC dialogue with civil society in the region. The RCC Secretariat established and deepened working contacts with regional Civil Society networks in different areas (National Councils of the European Movement from SEE, WB Social Entrepreneurs Network, SEE Public Broadcasting Agencies Network, JHA-related NGOs networks etc) and extended regional coordination with CSO structures.

The RCC DSG organized regular brainstorming on issues related to preparing the next RCC multiannual strategy, strengthening RCC Secretariat's capacities and upgrading the relations with other RI&TFs on the programme and project basis through coordinated programming and defining legal framework for joint actions. Coordination and streamlining of the RCC Secretariat activities were further advanced and an open debate on prioritizing its activities regularly held, especially related to the SEE 2020 framework. The RCC Expert Pool took part and contributed in preparing events of general importance for the RCC (with EC, SEECP C-i-O, RCC Board members, individual donors etc).

The implementation of the CEI-led project "Improving Cooperation in South-East Europe by Actions for Strengthening the Regional Cooperation Council" has started. In the framework of the project, a study visit of a several RCC Secretariat's staff members to Nordic Institutions (the Secretariat of the Council of the Baltic Sea States and the Secretariat of the Northern Dimension Partnership in Public Health and Social Well-being) was held, with the purpose of exchanging know-how among the sister organizations, increasing knowledge and learning from symmetrical experience.

#### 1. Economic and Social Development

#### Investment and Business Enabling Environment

Following the conclusions of the 10<sup>th</sup> meeting of the South East Europe Investment Committee (SEEIC), RCC/SEEIC Team engaged in extensive consultations with the representatives of the SEE governments, ensuring understanding and commitments for their contribution in the development of headline quantifiable targets, indicators and measures with common regional goals for the SEE 2020 Strategy. As a result, the Task Force on SEE 2020 was established and mandated to determine proposals for the main regional headline targets with quantification within each of the priority areas, along with the proposals of corresponding national targets. Two meetings of the Task Force on SEE 2020 have been held during July and September 2012 where proposals for regional baseline and headline targets have been agreed upon.

The 11<sup>th</sup> SEEIC Meeting, co-chaired by the RCC Secretariat and the Republic of Albania, brought together SEEIC Country Economic Teams, representatives of NIPAC offices, EC, International Organizations, and donor and business community, with the main objective of discussing and endorsing the initial SEE 2020 headline targets. The set of nine targets for integrated, smart, inclusive and sustainable growth in the region until 2020 was supported by the members of the SEEIC. The proposed targets for the SEE 2020 Strategy include growing the region's total value of trade in goods and services to more than a quarter trillion USD compared to 2010, reducing the trade deficit, and growing intra-regional trade in goods by over 200%. The Strategy envisages increasing overall foreign direct investment inflows to the region by 150%, increasing GDP per person employed as well as exports per capita, increasing the overall employment rate, and improving government effectiveness by 20%. Together with a common set of regional goals, SEEIC has finalized a draft Statement for the Ministerial Conference of the South East Europe Investment Committee planned for 9 November 2012 in Tirana, integrating the proposed regional targets into a coherent and ambitious document to guide the further development and implementation of the SEE 2020 Strategy. The participants of the meeting underlined that the very process of transferring the SEEIC to the RCC proved to be a major catalyst to accelerated development of the SEE 2020 Strategy and that the SEEIC has become a central point on the map of the regional cooperation and, with the back-up of the RCC, it has a key role to play in the development of regional strategies to advance the region's economic development and integration with the EU.

The RCC Secretariat presented the work of the SEEIC to the Western Balkans Investment Framework Steering Committee with the aim of further positioning the SEEIC as the main regional sectoral project for private sector development. The WBIF SC welcomed the ambitious work programme of the SEEIC, hoping that the Committee would become a key interlocutor on private sector development for the WBIF going forward.

The SIDA financed project Women Entrepreneurship (WE) – a job creation engine for SEE has been officially launched on 21 September 2012. This extensive 3-year project, implemented by the South East European Centre for Entrepreneurial Learning (SEECEL) and the Gender Task Force (GTF) and coordinated by the RCC Secretariat, aims to raise awareness on the specifics of the entrepreneurship of women in the region and to enhance the capacities of women entrepreneurs' networks and associations through constructive policy dialogue between public and private sectors in line with Small Business Act for Europe. Back-to-back with the launching conference, GTF and the RCC Secretariat organized the second strategic expert workshop, including prominent women from business, civil society and government sectors, chambers of commerce, gender experts, SIDA, etc. In addition to providing regional inputs to strategic planning for the 3 year WE project and national activity planning for 2012-13, the meeting provided a forum for identifying entry points for improving the climate for entrepreneurship and especially WE in the framework of the SEE 2020 process and synergy with several existing WE initiatives and events. Nine National Project will be launched during October and November 2012, as well as national workshops for building WE platforms as partners in policy dialogue will be held.

To further the development of public-private partnerships in the region, the RCC Secretariat took part in the Conference on Promoting Public-Private Partnerships in SEE organized by the UN Economic Commission for Europe and the Montenegrin Commission on Concessions. The conference took stock of the progress in PPPs in the region, outlined some of the best practices and determined the viability of establishing a regional PPP Centre of Excellence. The RCC supported the idea, accepted to participate in the Working Group on establishing the regional PPP Centre and suggested stronger links with existing regional sectoral organizations that have been doing considerable work on identifying potential regional projects and priorities.

#### Access to Finance

The RCC Secretariat co-organized, with USAID and SIDA, a conference dedicated to access to finance *SEEnovate*: Supporting Intelligent Growth in South East Europe,, which attracted more than 180 participants, including over 30 venture capital and private equity funds and a number of SME representatives and policy makers. Given the strategic focus of RCC on expanding access to finance for innovative and high-growth SMEs, the event addressed equity finance, including its availability in the region, obstacles to its further development and possible policy options. The RCC Secretariat used the event to showcase some of the new financing facilities becoming available to the SMEs in the region, including the WBIF's Enterprise Development and Innovation Facility (EDIF) and Venture Capital Investment Programme (VCIP) being rolled out by the EBRD.

The RCC Secretariat co-organized, together with USAID, a seminar on the implementation of the regional integration model of SEE capital markets. A proposed "T-REX integration model" was presented by the consultants on the project enabling the creation of a regional marketplace. The project was endorsed by all of the stock exchanges from the Western Balkans as well as the Ljubljana Stock Exchange. Capital market experts from EBRD were also present at the meeting to help with outlining some of the project's dimensions and assessing its possible role.

#### Social Development

The RCC Secretariat organized, in cooperation with Friedrich Ebert Foundation, a conference on New Skills for New Jobs in the Western Balkans. Representatives of governments, social partners, researchers from the Western Balkan countries and international organizations discussed and exchanged experience on the issue of skills and jobs in the region. A common position was reached with respect to the need to establish a regional information base, education and training, local level policy making and innovation, and working together towards a regional approach to accessing

funding and know how. Special attention was dedicated to discussing, with the participants, the concrete regional social headline targets and indicators developed under the SEE 2020 Strategy.

The RCC Secretariat participated at a tripartite regional conference, which was organized by the Friedrich Ebert Foundation to present a regional study on employment policies and discuss specific topics on the current situation, challenges and recommendations for improvement of employment policies.

The First Regional Conference on Organ Donation and Transplantation, organized under the Croatian presidency of the SEE Health Network, aimed at engaging policy makers to provide support and commitment to further developing and strengthening the implementation of successful organ donation and transplantation programs. The 29<sup>th</sup> meeting of the SEE Health Network, organized back to back with the Ministerial Conference, aimed to start and develop the process of the implementation of the 2011 Banja Luka Ministerial Pledge. In light of the Health in All Policies approach to regional cooperation in public health, the RCC Secretariat is well positioned to act as a platform for strengthened cooperation among different regional initiatives that can capitalize on their unique sector strengths to reach common goals. On the other hand, the RCC Secretariat recognized the importance of social determinants of health and contributed to a meeting of the World Health Organization on discussing implications for governance for health equity through action on social determinants of health with a specific focus on Serbia.

The SEE Health Network (SEEHN) Secretariat has been fully established in Skopje in September 2012. The Secretariat will provide the SEEHN with an independent legal base and will assist in preparing strategic plans as well as in the day to day activities of the network.

The RCC participated and contributed to an appraisal mission of the World Health Organization in Serbia on governing for social determinants of health and health equity. The mission confirmed the recognition and increasing interest in the region to strengthen the coherence of actions across sectors for addressing health inequities, while emphasizing the important contribution of health to economic and social development.

#### Information society development

The RCC Secretariat organized a meeting of the electronic SEE initiative as a follow up to the 2011 high level conference for Information Society. The meeting focused on identifying concrete regional actions that can contribute towards the implementation of the eSEE Agenda+ and constitute the region's response to the Europe 2020 Strategy.

The RCC Secretariat participated at the regional forum for Europe on broadband organized by the International Telecommunications Union and Minister for Innovation and ICT of the Republic of Albania, where the role of broadband development for social and economic development was discussed.

#### 2. Energy and Infrastructure

#### Energy

The RCC Secretariat sustained close cooperation with the Energy Community and took part at a few events organized by the Energy Community Secretariat (ECS). Taking into account the RCC Secretariat's involvement in launching and preparing the initiative on creating the Regional Energy Strategy (RES) accepted by the Energy Community Ministerial Council, the RCC Secretariat continued to contribute to the Regional Energy Strategy Task Force (RES TF) established with the aim to prepare the RES. The RCC Secretariat also promoted Energy Community activities in the

environmental area linked to retrofitting of power plants in the Contracting Parties (CPs) to the Energy Community Treaty (ECT).

The RCC Secretariat co-organized, with the Regional Education and Information Centre for Sustainable Development in SEE (REIC), and under the auspices of Ministry of Foreign Trade and Economic Relations of Bosnia and Herzegovina, the roundtable Best Available Techniques for Large Combustion Plants in Western Balkans. The purpose was to back the endeavours of the CPs to the ECT from the Western Balkans, relying on electricity production from low quality coal - lignite, in implementing the Directive on Large Combustion Plants, which is the most challenging requirement within the Annex II of this Treaty. The event also presented and discussed Integrated Pollution Prevention and Control Directive and Industrial Emissions Directive introducing more stringent duties to the accession countries. This regional roundtable will be followed by other events primarily tailor-made national trainings.

The second meeting of the Sustainable Energy Development Regional Initiative (SEDRI) Task Force, co-organized by the CEI, the RCC Secretariat and the Serbian Ministry of Infrastructure and Energy (SMIE), ensured the support of IPF Country Office from Bosnia and Herzegovina and particularly from EBRD for improving project proposals from regional inventory of small scale sustainable energy projects. In addition, INOGATE Technical Secretariat expressed its readiness to support SEDRI beneficiaries from the EU Neighbourhood Policy in improving their project proposals from inventory.

The RCC Secretariat continued to back the network of schools for political studies from the region, led by the Belgrade Fund for Political Excellence (BFPE), in implementing the Project on Strengthening Public Dialogue on Sustainable Energy Use in the SEE currently financially supported by the GIZ and Visegrad Fund. The RCC Secretariat committed to support the network of CSOs led by the SEE Change Net in developing and promoting the Western Balkan Sustainable Energy Strategy. In addition, the RCC Secretariat participated at and contributed to relevant regional energy events such as Institute of Energy for SEE 6<sup>th</sup> SEE Energy Dialogue and World Energy Council Energy Forum National and Regional Energy Policies and Strategies - The Security of Supply.

The RCC Secretariat participated at the 7<sup>th</sup> Energy Community Gas Forum, which gathered representatives of the ministries, regulatory authorities and industry from the Contracting Parties (CPs), participants and observers, as well as representatives of the Donors' Community, business and international organizations. It discussed gas policy and market developments both in the EU and Energy Community, the necessity to implement effectively the 3<sup>rd</sup> Energy Package, gas infrastructure development, the need for strengthened cooperation betwen a variety of stakeholders and exchange of information, particularly during emergency situations and security of gas supply issues.

The RCC Secretariat participated at the 5<sup>th</sup> Regional Energy Strategy Task Force (RES TF) meeting. The event gathered CPs to the Energy Community Treaty (ECT), EC, EBRD, ECS discussed the criteria for the Projects of Energy Community Interest (PECI) selection, indicators and their weights; the questionnaire template for infrastructure project proposals; the approach to project data collection; the methodology for assessing the projects and organization of work building on EU experience; and the EU experience in the identification of Projects of Common Interest (PCI).

#### **Transport**

The RCC Secretariat has prepared, together with the DG MOVE and ISIS Programme Secretariat, a Project Grant Application Form, which was submitted to the Western Balkans Investment Framework (WBIF) for funding of a Study on the Importance of Air Transport Sector in Enhancing

Economic and Social Development and Cooperation in the SEE by assessing the airspace, its capacity and transport links. The study intends to provide an overview of the current airspace structure, air traffic flow and existing air transport links in SEE including recommendation for the reorganization of the airspace and establishment of Functional Airspace Block(s).

The RCC Secretariat co-organized, together with the Implementation of Single European Sky in SEE (ISIS) Programme Secretariat and DG MOVE, the Third ISIS Governing Body meeting. The relevant aviation authorities assessed the current state of play with regards to the transposition and implementation of Single European Sky (SES) legislation in the region, presented their achievements and challenges related to the ISIS II Programme since the last ISIS GB meeting. The RCC Secretariat committed to provide further political support in finalising the second phase of ISIS Programme and beyond. Furthermore, the above-mentioned Airspace Study was presented and supported by the regional civil aviation authorities.

The RCC Secretariat organized the Third Congress on Roads, together with the Association of Consulting Engineers of Bosnia and Herzegovina (ACE BiH), under the auspice of the Ministry of Communications and Transport of Bosnia and Herzegovina. The Conference gathered the relevant authorities in the transport field, regional organizations, transport experts and academics to discuss and analyse up to the date results and future challenges in development of the road infrastructure in the Western Balkans. It established a strong forum for the interactive development process in the roads sector focusing on the issues on road safety, infrastructural planning, environmental protection, available financial instruments as well as on the current developments in relation to the construction of motorways in the region.

#### Environment

The RCC Secretariat continued to support the implementation of the EU Strategy for the Danube Region (EU SDR), in particular by promoting "bottom-up" approach and integrated approach as well as by assisting other institutions and initiatives relevant for EU SDR implementation. In that respect, jointly with the European Commission Local Administration Facility (LAF) and Analytica, the RCC Secretariat took part in preparatory activities for organization of the conference to strengthen local authorities and civil society capacities in establishing and implementing local energy policies and to enhance their communication and cooperation.

It also participated at the International Conference Danube Strategy Implementation – Challenges and Perspectives and the Workshop EU SDR Project Facilitation and Exchange of Experiences, presenting its views on the event's topics and its activities in relation to the EU SDR.

The RCC Secretariat, in view of its role in initiating the mapping of regional climate change adaptation activities and strengthening cooperation between the major regional players in this area, participated at the foundational event and supported the establishment of the SEE Forum on Climate Change Adaptation (SEEFCCA). Its tasks are primarily to link national activities on regional level and foster multi-stakeholder partnerships across the region. The establishment of the SEEFCCA was one of the major achievements of the IPA-funded project designed to strengthen capacities of civil society in the region in the area of climate change adaptation, awareness raising and policy dialogue. In addition, the RCC Secretariat was asked by the SEEFCCA to assist in drafting the agenda for the conference to gather civil society organizations, government officials, representatives of international organizations and researchers in order to discuss recent developments in the field, explore potentials for cooperation and future strategies to address climate change in the region.

#### 3. Justice and Home Affairs

#### Strategic coordination: events and actions

The RCC Secretariat efforts were directed to enhance the convergence, strategic complementarities and growth of reciprocal support among regional cooperation mechanisms. To this purpose, the RCC Secretariat made full use of the existing regional instruments, framework and networks – *inter alia* the Steering Group on Regional Strategy (SGRS), the Monitoring and Evaluating Mechanism (M&EM) and the Expert Teams on Judicial Cooperation - to develop a comprehensive and holistic approach to the rule of law sector, together with a judicial and democratic control of regional actions. In this respect, the RCC Secretariat's actions and active participation in several important events with strategic consequences for the region should be mentioned.

Launching in Vienna the second Regional Program Countering illicit trafficking and organized crime for improved governance, justice and security (2012 – 2015) UNODC increased its contribution to regional cooperation. The Programme comprises 3 sub-programmes: Illicit Trafficking and Organized Crime - Integrity and Judicial Development - Prevention, Treatment and Care for drug users, HIV-AIDS patients, trafficking victims and risk groups. By virtue of the MoU signed on 21 May 2009, the RCC Secretariat and UNODC are sharing a common regional strategic perspective and have established a strong partnership and coordination, constantly supporting and actively participating in common programmes, projects and activities.

The RCC Secretariat participated at the Partner Workshop assessing the results of GIZ Programme (2007-2012) Open Regional Fund for SEE - Legal Reform. The progress findings, the results achieved and the future fields and models of cooperation were discussed, as well as the M&EM presented by the RCC Secretariat.

The RCC Secretariat finalised the commissioning of the data base application designed to collect and integrate the statistical indicators of the Monitoring and Evaluation Mechanism (M&EM) which rests fully on the RCC Secretariat costs. The first centralized statistical data is available from the end of September 2012 and could be presented during the envisaged Joined Meeting between Steering Group on Regional Strategy under RCC coordination and the IPA-MB Strategic Working Group.

The RCC Secretariat organized the First and Second Meeting of the Experts Teams for International Cooperation and Legal Assistance in Criminal and Civil matters. Acting within the mandate established by the SEECP JHA Ministers, the Expert Teams on Judicial Cooperation, during the first round of consultations in this format, decided to develop an inventory of relevant shortcomings in the implementation of the legal and institutional framework on mutual legal assistance, to periodically analyze the conditions and implementation of the EU Regulations, to propose measures and formulate expert recommendations addressing the identified shortcomings, to focus on the needs of citizens and practitioners and the appropriate regional responses to address those needs.

During Brdo Process Ministerial Conference, the RCC SG pointed out that Brdo Process together with SEECP and RCC strategic approaches in the area of Justice and Home Affairs complemented the EC enlargement policy in the Western Balkans. With the RCC Secretariat support, more practical and operational approach in the regional cooperation has been obtained and more concrete and measurable results were acquired in mutual legal assistance and judicial cooperation in civil and criminal matters.

The meeting of the Steering group of Priority Area 11 of the EU Strategy for Danube Region, informed the participants about the activities of the Coordination Bureau and Priority Area

Coordinators (PAC) implemented from the previous meeting. In particular, the meeting included the Europol preparation and presentation of the DOCTA (Danube Organized Crime Threat Assessment), the setting up of the Danube Centres for Co-operation and Information, the introduction of the Police Equal Performance Project, harmonization of the system of border control and documents inspection system and the strengthening the rule of law and combating corruption. The RCC Secretariat representative requested certain changes to be inserted in the text of report in order to reflect clear the position of the Steering Group that existing initiatives from the region have to be involved in the development and implementation of the projects.

The RCC Secretariat, the Executive Directorate of the United Nations Counter Terrorism Committee (CTED), the Southeast European Law Enforcement Center (SELEC) and the Republic of Turkey as the host country, co-organized a SEE Workshop on "Countering Violent Extremism". The event, which brought together representatives of law enforcement agencies from SEE, observer and partner countries, as well as officials of international, regional and sub-regional organizations and mechanisms, discussed regional trends and good practices in countering violent extremism with the aim to enhance regional cooperation in the area. The conclusion underlined that prevention, awareness-raising, advanced use of information and communication technologies, engaged civil society, and public-private partnerships are crucial in countering violent extremism.

The RCC Secretariat participated at the Regional Security (SRS) Conference Crisis Management in the South Caucasus and the Western Balkans: A 'Smart Power' Approach, focused specifically on regional security dynamics and acknowledged the continued prominence of territoriality on the one hand and the necessity to prioritize regional analysis over global, on the other hand, when a systematic learning process from these crises is required.

#### Fighting organized crime

A working level meeting on the Treptower Group introduced new members of the Group-Bulgaria, Interpol, PCC SEE and Federal German Police (BuPol). All partners presented their scope of developmental aid in the Western Balkans. The EC presented IPA MB 2013 Programme and development of EU web based Matrix while the RCC Secretariat presented the M&EM for JHA, its technical aspects and implementation. The High Level Meeting, held in mid-May, in Rome, discussed the issue of strategic coordination of activities implemented by different EU police services in the Western Balkans. A particular emphasize was placed on the trans-border police cooperation in the Western Balkans and more regional than international cooperation, EMPACT Western Balkans, a platform for the fight against organized crime in the Balkans and development of "EU Matrix" (within the CIRCABC Web Site). The RCC Secretariat presented M&EM and noted interest of most of the Treptower Group member countries to have access to the reports created through the M&EM. The last Working Level Meeting was dedicated to developments in this field in Western Balkan countries, overview of the PCC and the RCC Secretariat activities, and current status of the related EU Projects and possibility of financing of EMPACT projects.

The International Conference Balkan Security, Technology and Education: the challenges within cyber infrastructure brought together six Ministers of Interior (Bosnia and Herzegovina, Croatia, Montenegro, The Former Yugoslav Republic of Macedonia, Serbia and Turkey) discussing Cyber Security and International Security of the region, necessary approaches required to tackle the problems including possible strategies for prevention of the problem(s). The Ministerial Joint Statement particularly emphasized responsibility for the security of the citizens and importance of regional cooperation, mutual understanding and coordinated action for an effective prevention and repression of all forms of crime.

#### Anti-corruption

The RCC Secretariat held several consultations with the representatives of Regional Anticorruption Initiative (RAI) regarding the Conference launching the Southeast Europe Judicial Training Network, under the project "Establishment of Framework for Integrated Anti-corruption Legal Education in South-Eastern Europe" financed by US State Department through the RCC Secretariat. At the Conference, it was decided to establish the Regional Network for Judicial Training (RNJT) as a tool for strengthening regional cooperation and exchange of information, experience and best practices in the area with focus on anticorruption legal education. The RAI Secretariat will function as Secretariat for RNJT. The first RNJT national contact points meeting took place in June to prepare and present the forms of cooperation among RNJT, SEELS and other networks.

At the Summer School for Junior Magistrates from South-Eastern Europe classes, the RCC Secretariat representative made a presentation on the SEE networks on judicial cooperation in criminal matters and anti-corruption, focused on the impact of the Lisbon Treaty and the way SEE region is moving forward creating institutions, structures and capabilities to get judicial systems closer to EU and international standards.

#### Strengthen judicial and prosecutorial cooperation in criminal matters

The 20<sup>th</sup> Meeting of the SEEPAG discussed criminal associations, types of organized crime groups, cases processed in the SEEPAG countries and problems that arise in practical work. SEEPAG Member States were called to pay particular attention to experience sharing in practical action. During the meeting, Hungary joined the organization as fully fledged member and presented its judicial system. The representatives of the SELEC informed the participants about launching of SELEC and encouraged members to use in their work secured communication channels available through SELEC. They also briefed about development of SELEC secondary legislation, underlining that SEEPAG is mentioned in the Organization and Administrative Rules of SELEC as well as SELEC Task Force Rules and Procedures as recognition of SEEPAG's importance to SELEC. The RCC Secretariat informed about developments of interest for prosecutors, M&EM, briefed about meetings of the Expert Groups on Cooperation in Criminal and Civil and Commercial Matters and elaborated idea about development of Conventions covering two mentioned areas.

Within the EU funded IPA 2010 project "Fight against organized crime and corruption: Strengthening the Prosecutors' Network", the RCC Secretariat took part at the Expert Working Group Meeting on Data Collection and Data Protection. The representatives from prosecutors' offices, ministries of justice, EUROJUST and independent experts acknowledged that the UNODC lead project "Development of Monitoring Instruments for Judicial and Law Enforcement Institutions in the Western Balkans" prepared Technical Assessment Reports and Programme Guidelines and took note of the conclusions and recommendations of these reports; took note of the Monitoring & Evaluation Mechanism under development of the RCC; acknowledged the importance and relevance of data protection standards and were informed of the standards developed by EUROJUST.

One of the main tasks of the EU funded IPA 2010 project "Fight against organized crime and corruption: Strengthening the Prosecutors' Network" is to develop recommendations to streamline cooperation platforms and initiatives in the Western Balkans and between the Prosecutors' Network and SEEPAG in particular. This project is entrusted to facilitate a sustainable solution with regards to the future of the WBPN and elimination of existing duplication between WBPN and SEEPAG. Integrating WNPB in SEEPAG as a sub-network (BALKANJUST), specifically lifting the subnetwork to a compatible EUROJUST level might be the best option, from which SEEPAG will profit too.

The RCC Secretariat, in cooperation with GIZ, Romania, Serbia and Slovenia, organized the First Meeting of the Southeast Europe Regional Expert Team on Judicial Cooperation in Criminal Matters. Experts decided that, based on regular meetings and the RCC M&EM, to develop an inventory of the most relevant shortcomings in the implementation of the existing SEE legal and institutional framework for mutual legal assistance in criminal matters (MLA), periodically analyze the implementation of MLA conventions and agreements, advance on the path of studying the prerequisites for closer judicial cooperation, police operations, police and prosecution activities in criminal investigations.

The Second Meeting of the Southeast Europe Regional Expert Team on Judicial Cooperation in Criminal Matters focused on specific areas of cooperation: a) extradition and decided to draft a legal text upon a future regional extradition mechanism; b) analysis of the cooperation between regional networks and EU judicial agencies and networks, and c) discussed the strategic goals for the next years.

#### Cooperation in civil and commercial matters

The RCC Secretariat and GIZ co-organized two Meetings of the Expert Team for International Cooperation and Legal Assistance in Civil and Commercial matters. The content of the meetings was described under the strategic coordination chapter. As punctual issues has been agreed to continue the work on a regional Convention, based on the Lugano Convention of 2007, as initiated by the Republic of Slovenia. Membership to the new Convention shall be open to countries from the region of South-East Europe that are willing and able to become members.

#### 4. Security Cooperation

#### Facilitate and support development of regional mechanisms for security cooperation

The RCC Secretariat co-organized, with the Slovenian NSA, the Second SEENSA Conference, which adopted a number of specific documents and decisions related to future activities in areas of common interest for the Heads of the Classified Information Authorities.

The 4<sup>th</sup> SEEMIC Conference adopted the first Regional Common Intelligence analysis on contemporary challenges and agreed on the second Common Annual Intelligence Assessment on Contemporary challenges to be executed by WG of Intelligence experts. The ToR for SEEMIC were adopted and Turkey Military Intelligence officially joined SEEMIC by signing the Statement of SEEMIC. NATO representative took part, for the first time, in the SEEMIC conference.

Consultations for initiating the SEE Counter-Intelligence Chiefs Forum (SEECIC) with RCC Members from SEE Slovenia, Bulgaria, Greece and Turkey and a second round of discussions with the German BfV were held.

The RCC Secretariat participated in the 27<sup>th</sup> RACVIAC MAG meeting. A new director of RACVIAC was elected and different issues related to the 2013-2015 activities were discussed. The idea of organising SEEMIC activities with the support of RACVIAC was introduced.

The RCC Secretariat co-organized with the Bulgarian NSA, the first meeting of the SEENSA Thematic Working Group on Training (TWG T). The coordinators of the TWG T informed other colleagues on the preparatory work done and the results of the analysis made on the answers to the Questionnaire sent. The debate was focused on the Overview of the interest expressed by the SEENSA Members on Trainings. During the meeting the coordinators of the other three TWGs, on Security Agreements, Industrial Security and Cyber Defence presented their proposals for the way forward.

As a follow-up to the SEENSA TWG and SEEMIC meetings, planning discussions were organised with the Coordinator of the SEENSA TWG on Cyber Defence for the next steps and with the management of RACVIAC for the implementation of the activities envisaged by the SEEMIC project.

The RCC Secretariat participated in the seminar Integration and Contribution of SEE to Common Security and Defence Policy (CSDP) of the EU, organized by the TAIEX, in cooperation with the Ministry of Defence of the Republic of Serbia and RACVIAC.

The RCC Secretariat also participated in NATO special training on Grants Programme related to the mechanism of funding projects and activities in the region according to the NATO priorities, in the seminar 'Integration and contribution of SEE to the EU Common Security and Defence Policy (CSDP) and held a meeting with the SEDM Deputy Chief of Defence.

The RCC Secretariat took part in the DCHOD SEDM meeting, which made a review of the SEDM objectives and relationship with the main International Organizations, as well as the current status of SEDM projects – Senior Female Leadership in security and defence, Building Integrity, and SEESIM. Update on the ongoing progress of SEDM Strategic review was delivered. Slovenia presented the Non Paper on Rationalization of Regional Defence Cooperation. The RCC Secretariat representative offered RCC support in the preparation of the assessment and reminded of the document submitted to SEDM upon their request – Overview of Security Cooperation RI&TF.

The RCC Secretariat representatives participated in the work of the SEDM Group of Experts, which was organized by the Italian Chairmanship and was attended by all the representatives of the participating states in SEDM. The WG discussed important aspects having strategic political, diplomatic and military implications over the next developments in streamlining the security cooperation initiatives in SEE, focused on the text of the SEDM Strategic Review. RCC representatives have actively participated with proposals regarding conclusions and recommendations parts, based on the Security Cooperation Overview on Regional Initiatives and Task Forces realised also at the request of the SEDM. The SEDM Strategic Review offers ideas aimed at improving four dimensions: the usability of SEEBRIG, the decision-making process, the linkages with international and regional organizations and initiatives, and the evaluation of SEDM projects based on effective criteria.

The RCC SG participated in the meeting of the Southeast Europe Defence Ministers (SEDM), which brought also representatives of regional and international organizations. RCC aligned itself with the findings of the SEDM WG that nowadays in SEE we are dealing with a new security environment, new challenges and constantly changing security architecture.

The RCC Secretariat representatives participated in the 12<sup>th</sup> SEEC meeting. In the meeting Kosovo\* took part as an observer. There were no Serbian representatives. SEEC – Forum for Western Balkans Defence Cooperation made a review of the on-going projects and regional centres activities. The Slovenian Non Paper on Rationalization of regional defence cooperation was presented and supported by the representatives of Norway, Greece, RCC and USA. The idea of a permanent SEEC Secretariat was discussed. NATO representative suggested that RACVIAC (or another regional organization) can take this responsibility. The issue was left for the DPD to decide.

#### Disaster preparedness and prevention

The RCC Secretariat was officially informed by the DPPI Secretariat that the Ministry of Security of Bosnia and Herzegovina via Ministry of Foreign Affairs of Bosnia and Herzegovina launched the procedure of transfer of the DPPI SEE Secretariat to another DPPI SEE Member State. Ministry of Security of Bosnia and Herzegovina initiated the transfer procedure in order to reduce the total annual costs in relation to overcoming the difficult economic situation in Bosnia and Herzegovina.

#### 5. Building Human Capital and Cross-Cutting Issues

#### Education

The RCC Secretariat took part at the International Conference on Higher Education Reform, which was organised by the Ministry of Education and Sport of Montenegro, in cooperation with the Universities of Montenegro and Novi Sad, in the framework of the Tempus Project "Building Capacity for Structural Reform in Higher Education of Western Balkan Countries". The conference, held under the auspices of the RCC Secretariat and Novi Sad Initiative, gathered representatives of the ministries of education from the RCC members from the Western Balkans and the EU, rectors, vice rectors and professors from the Universities in the region, higher education authorities from the EU, as well as representatives of respective regional and European agencies involved in creation of policies in higher education. The conclusions of Petrovac Conference will serve as valuable inputs in development of a joint roadmap on structural higher education reform in the region, based on rich and diverse regional academic heritage and clear democratic will of regional authorities to continue to work together.

The RCC Secretariat participated at the 5<sup>th</sup> Meeting of the South East Europe Regional VET Network (SEEVET-Net,), which was organised by the National VET Centre of Montenegro and temporary Secretariat of ERI SEE – Center of Education Policy.

The meeting gathered representatives of Vocational education training institutions from the RCC members from SEE and the EU, as well as representatives of relevant international organisations. The focus of the 5<sup>th</sup> SEEVET-Net meeting was on mutual policy learning in VET through the exchange of experience on social partnership among the countries of the SEE and EU Member States.

SEEVET-Net approved presented Work Programme for 2012 and discussed outline of the future regional cooperation activities for the year 2013 in defined areas of joint interest. Experts were informed and asked for suggestions regarding planned regional conference on adult education and lifelong learning, to be organised by the RCC and DVV in the autumn 2012 in Sarajevo.

The RCC Secretariat participated at the Regional Higher Education Strategic (RHES) Forum. The event gathered, apart from the STREW Consortium members, representatives of the ministries of education from the RCC members from the Western Balkans and the EU, rectors, vice rectors and professors from the Universities in the region, higher education authorities and institutions from the EU, as well as representatives of respective regional and European agencies involved in creation of policies in higher education and independent experts. The participants discussed the overall report on the project development, along with the reports concerning each work package, focusing on concrete action plans to be realised by the countries and the region, in order to further develop and disseminate project results and make sure the multiple effects of the project.

#### Science and Research

The Meeting of the Regional R&D Strategy for Innovation in the Western Balkans (RSRDI) Steering Committee, which was followed by the workshop of the project Advisory Body, was held in Dubrovnik. The events were organised by the World Bank, as the project Implementation Agency, together with the RCC Secretariat, in accordance with the implementation plan of the RSRDI and in compliance with the RCC Strategy and Work Programme 2011-2013. The project Steering Committee overviewed the achievements made since its last meeting and discussed possible initiatives that could be included in the future Regional Action Plan, as the follow-up to the Strategy, based on the principles of stable institutions, predictable funding, meritocratic structure and scalable initiatives. Steering Committee made a decision (based on the proposal of the RCC) that the main RSRDI event, Regional Conference of Science Ministers, which will present the Regional Strategy and launch the follow-up activities, will be held in Skopje, under the auspices of the SEECP C-i-O 2012-2013, in March 2013.

The RCC Secretariat participated at the 19<sup>th</sup> International Conference Technology, Culture and Development – Western Balkans on the Road to the European Union, organised by the association "Technology and Society", Science and Technology Policy Research Centre Mihajlo Pupin Institute from Belgrade, Faculty of Electrical Engineering Podgorica and Faculty of Economics Subotica. The event gathered representatives of universities and scientific institutions, governmental agencies, cultural, political and non-governmental organisations, professional associations and private business, who made presentations on selected topics, trying to contribute to a reliable understanding of the reasons, benefits and implications of the EU membership. The participants expressed noticeable dissatisfaction with the results and model of transition, especially economic, and discussed the possibilities to develop new models for reforms and growth.

#### Culture

The main activities of the RCC Secretariat were focused on supporting the RCC Task Force on Culture and Society (TFCS). The RCC Secretariat attended the Third Working Meeting of the RCC Task Force on Culture and Society, organised by the TF CS Secretariat, which discussed and adopted Narrative Report of the RCC TFCS Secretariat for the period 1 April- 15 June 2012. The representatives of the countries participating in Ljubljana Process reported on the state of play in establishment of National Task Forces and development of Priority Intervention Lists. Improvements in both activities were evident since the Second meeting of the TFCS. A simplified procedure was offered for acquiring available direct financial assistance. Crucial role of National Task Forces in the process was reiterated. Improvements to the TFCS website (<a href="http://tfcs.rcc.int">http://tfcs.rcc.int</a>) and Collaborative Platform were explained by the TFCS Secretariat. TFCS discussed possibilities for raising visibility of the Ljubljana Process., including development of printed brochures and electronic presentations of rehabilitation projects.

Negotiations between the RCC Secretariat and the DG Enlargement of the European Commission on the text of the project proposal and draft budget of the project "Sustaining the Rehabilitation of Cultural Heritage" have been finalized and the grant contract was signed by both parties on 28 August 2012. It is expected that the implementation of this project worth EUR 500,000 by the RCC Task Force on Culture and Society will start in mid October 2012, complementing ongoing activities of Ljubljana Process.

The RCC Secretariat has been engaged in the process of exploring the ways for realizing of the initiative of establishment of the Regional Film Fund. The initiative follows the interest the countries of SEE expressed in the Declaration of the Annual Meeting of the Council of Ministers of Culture of South East Europe (CoMoCoSEE), held in Belgrade in April 2012 and the conclusions of the

Regional Film Forum, held during the Sarajevo Film Festival in July 2012. It was agreed that the existing Regional Film Network, in cooperation and coordination with the SEECP C-i-O and RCC Secretariat, should be gathered with the aim to further develop project proposal and related structure of the Regional Film Fund.

#### Parliamentary Cooperation

The RCC Secretariat continued to be actively involved in promoting regional parliamentary cooperation both in SEE and WB frameworks by paying particular attention to strengthening of the parliamentary dimension of the SEECP and to developing the Cetinje Parliamentary Forum for enhancing coordination of parliamentary activities in the Western Balkans, through establishment of a sustainable Secretariat.

The RCC Secretariat has participated at the 6th meeting of the SEECP Parliamentary Dimension (PD) Working Group focused on the most appropriate formula on two potential models of SEECP PD institutionalization: the establishment of the SEE Parliamentary Assembly (proposed by Turkey) or, the establishment of the SEECP Parliamentary Conference (proposed by Bulgaria). During the discussions the Working Group agreed on the aims, objectives and basic guidelines of the future structure, decision making/voting, membership and composition, chairmanship, working language, organizational structure and international and regional cooperation objectives of the future shape, whilst highlighted the need to continue the exchange of views on the remaining components: International Secretariat and the Budget at the next meeting.

The RCC Secretariat is carefully pursuing the final steps in developing the project: "Parliamentary Cooperation in the Western Balkans and Turkey - Support to the Cetinje Parliamentary Forum". The project aimed to strengthen the role and effectiveness of Parliaments in the region in the EU integration process and access to public documents, is finalized and consultations were held with DG Enlargement representatives regarding detailed description of the activities, optimal model for project contracting and respective budgeting. In this context, the RCC Secretariat has started contacts with Montenegrin Parliament for joining efforts on assuring that the next steps of project implementation to be efficient and transparent.

Upon a special invitation, the RCC Secretariat attended the Conference of the Baltic Parliamentary Assembly during which a fruitful exchange of experiences and best practises was made. The experience and the contribution of the Baltic States in the work of the EU institutions and their common efforts to represent interests of the Baltic States, were underlined by the BS representatives, while the progress on institutionalizing the parliamentary dimension in SEE and the discussions on the preparation of a proposal for the creation of a Parliamentary Assembly/Conference for SEE, were part of information delivered by RCC Secretariat.

The RCC Secretariat has continued the fruitful cooperation with the European Parliament in preparing and organizing jointly events in the region. The Parliamentary seminar Modernization of agriculture and implementation of the Common Agricultural Policy, was organized jointly by the EP and the Regional Secretariat for Parliamentary Cooperation in SEE, as part of a series of seminars that aims at strengthening the capacity of parliaments of the Western Balkans in the enlargement process. The event, consisted of several panels on the specific topics in field of agriculture, was a useful tool on the periodic trainings and other capacity-building activities for the parliamentary officials.

#### IV. Operation of the RCC Secretariat

A remaining open issue related to the setting-up of the RCC Secretariat concerns the implementation of the provisions of the Headquarters Agreement between the Kingdom of Belgium and the RCC Secretariat, which regulates the status of the RCC Secretariat's Liaison Office in Brussels. The Kingdom of Belgium has conditioned the implementation of relevant provisions of the Headquarters Agreement between the Kingdom of Belgium and the RCC Secretariat providing for the fiscal privileges and immunities of the Head and Deputy Head of the RCC Secretariat's Liaison Office in Brussels with the issuing of an official authentic interpretation concerning the implementation of Article 17.1.(d) of the Agreement between the Council of Ministers of Bosnia and Herzegovina and the Governments of the other SEECP Participating States, the United Nations Interim Administration Mission in Kosovo on behalf of Kosovo in accordance with the United Nations Security Council Resolution 1244, on the Host Country Arrangements for the Secretariat of the Regional Cooperation Council (Host Country Agreement) by the Parties to this Agreement in which the principle of taxability of the officials of the RCC Secretariat in their countries/places of origin and/or permanent residence would be explicitly confirmed. After a consultation procedure initiated by the RCC Secretary General in August 2008 it became evident that the adoption of an interpretative declaration amending the Agreement would not be acceptable to some of the Parties to the Host Country Agreement, as they consider that such declaration would run counter to the spirit of the current provisions of the Agreement and would lead to its de facto amendment. In light of the principles of general international law, the only recourse in this situation would be to proceed with amending the Host Country Agreement accordingly, in light of the request from the Kingdom of Belgium. This, however, remains subject to the will of the Parties to the Host Country Agreement. In this view, the RCC Secretary General sent a communication to the authorities of Bosnia and Herzegovina in early January 2009, proposing to the Council of Ministers of Bosnia and Herzegovina as a Party to and, at the same time, a depositary of the Host Country Agreement to consider the possibility of initiating the process of amending relevant provisions of the Agreement in order to provide for requested confirmation of taxability. This proposal of the RCC Secretary General is still under consideration by the authorities of Bosnia and Herzegovina.

#### V. Staff Changes in the RCC Secretariat

During the reporting period, pursuant to the rotational principle of the functioning of the RCC Liaison Office in Brussels, the Secretary General of the RCC has decided to appoint Mr. Stanislav Daskalov to the position of the Head of the RCC Liaison Office in Brussels as of 15 July 2012. Following the above principle, the Secretary General of the RCC has decided to appoint Mr. Basil Coronakis to the position of the Deputy Head of the RCC Liaison Office in Brussels. There were no other staff changes in the RCC Secretariat (Annex IV, List of Officials of the RCC Secretariat).
