The Report on the activities of the Regional Cooperation Council (RCC) Secretariat is submitted by the RCC Secretary General to the RCC Board in line with Article 15 of the Statute of the RCC. It covers the period between 1 April and 31 August 2018.

1. Summary of activities

During the reporting period, the activities and efforts of the RCC Secretariat were focused on the implementation of the RCC Strategy and Work Programme (SWP) for 2017 – 2019 and the implementation of the MAP REA - the Multiannual Action Plan for establishing the Regional Economic Area in WB6 in particular. RCC Secretariat's has continued with active engagement in regional political and sectorial activities, thus serving interests of all RCC participants from the SEE region and feeding the aspirations of the region to the good-neighbourly relations, the European and Euro-Atlantic integration, mutual-trust and prosperity.

The Brdo pri Kranju SEECP high-level events (23-24 April 2018), marking the completion of the Slovenian SEECP C-i-O for 2017 – 2018, reaffirmed the importance and commitment to regional cooperation as a key precondition for the stability and prosperity of the SEE region and for progress on the European and Euro-Atlantic integration path. The SEECP participants welcomed in particular the focus placed on regional economic cooperation, growth and development within the region. The SEECP participants approved the appointment of Ms. Majlinda Bregu as Secretary General of the RCC, starting from 1 January 2019 and of Mr. Igor Luksic as Secretary General of the RCC, starting on 1 January 2022; agreed on the SEECP C-i-O's for 2018-2019 (Bosnia and Herzegovina) and 2019-2020 (Kosovo¹) and endorsed the Annual Report of the RCC Secretary General for 2017-2018. High level events praised the role, synergy with and congratulated the 10th Anniversary of the RCC as a truly regionally owned organization supporting the regional cooperation and EU integration of the RCC aspirants. The SEECP participants thanked the incumbent RCC Secretary General Svilanovic for his indispensable contribution to serving regional cooperation in South East Europe over the past almost six years of his tenure as the RCC Secretary General.

Organized back-to-back with the Brdo pri Kranju SEECP high-level events, the 10th RCC Annual meeting exchanged views on the situation in SEE and underlined the valuable role of RCC in promoting strategic coordination of regional cooperation processes, highlighting the importance of the MAP REA implementation. The participants welcomed the renewed momentum in the EU's enlargement agenda and welcomed the progress made by SEE aspirants in this respect. The RCC participants praised the activities implemented by the RCC and endorsed the Annual Report of the RCC Secretary General for 2017-2018, while reconfirming the sound support for the implementation of the RCC SWP 2017-2019.

Overall, the Slovenian Croatian SEECP C-i-O has notably contributed to strengthened regional cooperation and supported Euro-Atlantic aspirations of the SEE participants. Moreover, the issues of economic development, regional economic integration focused on connectivity and digital transformation, security and youth were on the top of the agenda as key areas enabling further progress in SEE.

The activities related to the regional economic area were at the core of the RCC Secretariat activities in the period April-August 2018. The RCC Secretariat has continued to coordinate all MAP REA activities and oversee the overall implementation along its four components. Efforts have been invested in maintaining and facilitating the regional dialogue within MAP structures, monitoring implementation of key deliverables related to MAP REA, identifying next milestones and targets, etc. Successful implementation of key deliverables along the four MAP REA components has been acknowledged by the Economy Ministers Meeting, held on 4 July 2018 in Vienna and forward-looking commitments have been elaborated – to be further systematized in the strategic discussion planned at the upcoming MAP Coordinators meeting in October. The EU-Western Balkan Summit and London Summit have noted the progress toward the establishment of the Regional Economic Area and called upon stepping up efforts in this regard. In addition to the horizontal processes, the RCC actively contributed to the implementation of MAP within the skills and mobility, connectivity and competitiveness flagship.

The fourth cycle of the SEE2020 monitoring cycle was finalised, resulting in Annual Report on Implementation (ARI) of the SEE2020 for 2018 and the fourth edition of the Balkan Barometer (BB) Survey. The ARI was adopted on the 5th meeting of the SEE2020 Governing Board, while the BB 2018 findings were presented on the BB 2018 launching event, taking place in Brussels beginning of July.

In line with renewed momentum of the EU's enlargement agenda, RCC has sustained its active engagement with EU institutions, Brussels-based think tanks and foundations, as well as diplomatic missions to the EU. RCC has intensified and supported cooperation with the following important partners and actors : European Commission (DG NEAR, DG JUST, DG CONNECT, DG EMPL), Joint Research Center (JRC), European Committee of the Regions, European Economic and Social Committee, Press Club, European Policy Center, Friends of Europe, Friedrich Ebert Stiftung, Balkan Traffic Festival, PubAffairs Brussels, Hans-Seidel Foundation, European Endowment for Democracy, German Institute for International and Security Affairs (SwP), Netherlands Institute of International Relations (Clingendael), EuroNavigator, Academic Cooperation Association (ACA).

The Bulgarian Presidency continued with its strong commitment to the EU perspective of the Western Balkans. These efforts culminated in the Sofia EU –Western Balkans Summit on the 17th of May. The RCC SG was invited to this high forum as an acknowledgement of the importance of and role played by the organization in promoting regional cooperation and the European aspirations of the region. A key objective of the RCC is to ensure that the upcoming Presidencies of the EU Council maintain the current focus on the Western Balkans and its future accession.

Together with the Bulgarian EU presidency, the RCC Liaison Office (LO) co-hosted an event "The Western Balkans' European Perspective through Growth, Good Governance and Enhanced Cooperation" on 25 April 2018. RCC Secretary General gave introductory remarks, whereas RCC deputy Secretary-General participated in the panel on "Strengthening the European perspective through regional cooperation".

The regular exchanges between RCC LO and representatives of the European Committee of the Regions were intensified as part of the Enlargement Days, the fourth edition of European Committee of the Regions' flagship event on enlargement policy on 3-4 May 2018.

The RCC Secretary General took part in the Working Party on Non-Proliferation (CONOP) in the Council on 24 May 2018. The meeting was the opportunity to remind the Member States, the European External Action Service representatives, Permanent missions of the six Western Balkan

partners, NATO representatives and other relevant stakeholders about the importance of cooperation in the security field. The Secretary-General also pointed out the successful cooperation between the Regional Cooperation Council and SEESAC, including the integration of the gender mainstreaming approach into SALW policies.

The RCC LO jointly with the German Institute for International and Security Affairs (SwP) hosted a Public roundtable "Why now enlargement in the Western Balkans is good – or bad – for the EU?" on 3 July 2018. RCC Secretary General took part in the panel discussion and used the opportunity to inform the participants about the RCC work to facilitate the EU accession process of Western Balkan partners.

The RCC Secretary General participated and addressed the following high-level events with a regional dimension such as: 10th Anniversary event of the European Fund for the Balkans (16 April 2018, Belgrade); Fifth meeting of NFP P/CVE Group (17 April 2018, Belgrade); Digital Summit (18-19 April 2018, Skopje); RCC - SEEC high level events (23 April 2018, Brdo pri Kranju); Regional Cooperation Day with Bulgarian Presidency of the Council of the EU (25 April 2018, Brussels); 4th Enlargement Day of the European Committee of the Regions (4 May 2018, Brussels); EU-Western Balkans Summit Sofia; The Results of the EU-UNDP Partnership on Disarmament and Arms Control in South East Europe (24 May 2018, Brussels); SALW Commissions meeting and SEEMIC Working Group (28 and 29 May 2018, Tirana); Ministerial meeting on digital skills (7 June 2018, Belgrade); CEI Ministerial meeting (11 June 2018, Split); Launch of Digital Agenda for the Western Balkans (25 June 2018, Sofia); 7th Ministerial meeting – Western Balkans Platforms on Education and Training & Research and Innovation (26 June 2018, Brussels); Berlin Process Economy Ministers meeting (4 July 2018, Vienna); SEE2020 Governing Board meeting (5 July 2018, Brussels); Balkan Barometer presentation (6 July 2018, Brussels); The London Summit (10 July 2018, London) and the WB 6 Prime Ministers meeting (27 August 2018, Tirana).

Implementing SEE 2020 Strategy through Flagship Approach

A.1. "Skills and Mobility", encompassing the policy areas of education, employment, mobility, migration and social policy

A.1.1. Removal of obstacles to mobility of students and highly skilled workers in the region: mutual recognition of academic qualifications

The 2nd meeting of the Working Group on Recognition of Academic Qualifications was held on 26th March 2018 in Podgorica where the concept of Joint Exercise on Recognition of Academic Qualifications was discussed. The meeting was attended by representatives of Ministries responsible for higher education, ENIC/NARIC offices and Quality Assurance bodies of WB6. The participants agreed on the modalities and on the kick-start of a joint exercise on recognition of academic qualifications and the concept of a joint information system which would facilitate better exchange of information on recognition issues in the region. The participants also discussed the model and principles of recognition of academic qualifications as well as agreed to appoint their national coordinators and national teams for the joint exercise on recognition of academic qualifications.

During the reporting period, the RCC activities were focused around preparing a Joint Ministerial Statement stating agreed Principles for automatic recognition of academic qualifications in the Western Balkans adopted at the Meeting of the Ministers of Education under the Western Balkans Platform on Education and Training which took place on the 26th June 2018 in Brussels.

Furthermore on the topic of academic qualifications RCC organised the 3rd meeting of the Working Group on Recognition of Academic Qualifications held on 14th June 2018 in Brussels finalising the concept of Joint Exercise on Recognition of Academic qualifications, reviewing the List of Cases for the Joint Exercise on Recognition of Academic Qualifications, and setting up the timeline for its implementation. The meeting was attended by representatives of Ministries responsible for higher education, ENIC/NARIC offices and Quality Assurance bodies of WB6. At the meeting it was also agreed on the Joint Information System which will facilitate the recognition of academic qualifications in the region and is expected to be up and running by the end of this year.

A.2.1. Removal of obstacles to mobility of professionals: mutual recognition of professional qualifications

With regards to removing obstacles to recognition of professional qualifications, RCC finalised technical preparations and paved the way for economies to start their internal procedures of nominating teams which will represent them in regional negotiations for MRA. Hence the seventh and last meeting of the CEFTA-ERI SEE-RCC Joint Working Group on Mutual Recognition of Professional Qualifications took place on the 7th of May 2018 in Sarajevo. During this meeting participants confirmed the text of the Recommendation on opening of negotiations on mutual recognition agreement of professional qualifications for doctors of medicine, dentists, architects and civil engineers. The governments are to inform the RCC Secretary General of their position on opening negotiations and of the composition of their negotiating teams. It was agreed that following the information on the appointments of the negotiating teams the RCC will convene the first meeting of the negotiators. The 1st Meeting of the lead Negotiators on Mutual Recognition of Professional Qualifications took place on 8th October 2018.

A.3.1. Removal of obstacles to mobility of researchers

On the third component of mobility RCC facilitated a Joint Statement from the Western Balkans on the more prominent inclusion of WB in the new Horizon Europe program which is being currently shaped by the EU institutions and EU Member States (EUMS) and which was also supported by the Ministers in charge of Science of the Western Balkans. This Statement would also be used to lobby further the EU institutions and EUMS in the next period before the HE program is finalised and approved in the EC. RCC convened a meeting of the Working Group on Research & Development which took place on the 13th June 2018 in Brussels, Belgium. At that meeting RCC gathered for the first time EURAXESS contact points from the region and agreed to go forward with the networking and raising capacities of EURAXESS contact points. An initial proposal with trainings needed in more detail will be devised and the first meeting back to back with the first training will be initiated in the last trimester of this year where the strategic element of the trainings will be discussed and shaped in the form of a work plan.

RCC in cooperation with DG JRC also co-organised a workshop on smart specialisation on April 11-12 in Ljubljana. The Workshop resulted in draft Roadmaps for the development of S3 for Albania, BiH, Kosovo* and The Former Yugoslav Republic of Macedonia, while Serbia and Montenegro prepared the EDP plans in accordance with their current preparation phase of S3.

The Employment and Social Affairs Platform (ESAP) - part of the Inclusive Growth pillar of the SEE 2020 Strategy and integrated within the “Skills and Mobility” flagship - is in implementation since March 2016.

During the reporting period three regional peer review workshops on employment policies and programmes were organized between April and June 2018 on the topics of self-employment, employment of persons with disabilities and youth employment. The workshops were hosted by the institutions in Kosovo*, Serbia and Montenegro, respectively, and brought together representatives of Ministries of Labour and Public Employment Services from the region to discuss and share good practices, promote dynamic mutual learning and policy transfers among the participating economies.

A regional meeting was organized in Brussels on 19 – 20 June 2018 with the aim of presenting to beneficiaries of the ESAP project from the Western Balkans and key Brussels-based stakeholders the findings of the main analytical ESAP reports on the labour market trends, active labour market policies, employment data sources, mutual learning reports on employment programmes and bench-learning.

Following the implementation of the bench-learning exercise among the Public Employment Offices of the Western Balkans, a regional comparative overview of Public Employment Services’ performance management in the region has been prepared. The report highlights the main strengths and weaknesses, drivers of Public Employment Service performance and provides recommendations for their future development.

In light of the important role that informal employment plays in the regional economies, ESAP conducted in-depth reviews of direct and indirect policy approaches and institutional set-ups for employment formalization in each of the 6 Western Balkan economies. Additionally, the applicability and transferability of the best and most relevant EU policies into the regional context has been analysed. Expert recommendations from the reports will feed into policy discussions with national stakeholders. Furthermore continuous technical assistance actions have been implemented to address national employment and labour market priorities.

A.2. The “Connectivity” flagship seeks to provide support through interventions designed to spur digital transformation of the region, ensure uninterrupted supply of energy and transport services promoting clear sources and technologies with the view of protecting the environment and addressing climate change as the key challenges of sustainable development.

A.2.1 Digital integration agenda

The Multi-annual Action Plan for a Regional Economic Area adopted by WB leaders at the occasion of the 2017 Trieste Summit, Statement of Support for the WB Digital Agenda of the Sofia Summit and the Digital Agenda for the Western Balkans launched on 25 June 2018 set clear path for digital transformation of the region. Therefore, our activities in the reporting period were concentrated on transforming MAP objectives and commitments of regional leaders into concrete actions in close cooperation with the national Governments, the European Commission and other regional and international stakeholders supporting digitalisation of the region and reaping variety of its benefits.

In the reporting period focus of RCC activities was on the preparation of the WB Digital Summit (DS) as a permanent high level dialogue on digital transformation of the region. Also, various activities were performed aiming at harmonization of roaming and spectrum policy, as well as decreasing

roaming prices with the aim of ensuring full coverage of WB customers. Cooperation with relevant stakeholders and initiatives is reinforced and cooperation with national Governments resulted in many achievements in the reporting period. The Western Balkans Roaming Policy Meeting organized in the beginning of April initiated a regional dialogue among ministries responsible for ICT and Regulators on roaming policy harmonization and opened discussion on possible extension and/or renewal of the Regional Roaming Agreement. The first regionally-owned WB DS was hosted by The Former Yugoslav Republic of Macedonia on 18th and 19th April in Skopje. At this occasion the Prime-Ministers and Ministers for digital society agreed the next steps and framework of future cooperation related to digital agenda for the region. In the light of this agreement RCC maintained regional cooperation and supported defining the Statement of Support for the Digital Agenda for the Western Balkans agreed by the leaders of the EU in consultation with regional partners. As the result of the Statement of Support, our activities supported preparation and endorsement of the Digital Agenda for WB while our work for defining roadmap for decreasing roaming prices continues. In line with commitments foreseen by the MAP, RCC also initiated regional cooperation on coordination and harmonization of spectrum policies in line with the World Radio-communication Conferences (WRC) and ITU framework, aiming at overcoming problems of cross-border interference and freeing up certain bands of spectrum.

Furthermore, in the reporting period RCC provided a platform for sharing experience and lessons learned from the first WB DS among partners involved in organization and initiated preparations of the second one with the Serbian Government as the Host of the 2019 WB DS.

Moreover, with the aim of analyzing regional market and providing analytical basis for further roaming policy harmonization and decreasing of costs, RCC commissioned a study on roaming prices and telecommunications market which should provide a baseline report on prices, services, prospects and models for creating a roaming free region. The study is expected to be finalized by the end of 2018, while its findings will serve as inputs for development of a Roadmap to facilitate lowering the cost of roaming as well as analytics for the Roaming Agreement to ensure full coverage of regional consumers.

A.2.2. Sectoral support in environment, energy and sustainable development

In the reporting period RCC continued with activities designed to support implementation of actions stemming from Bonn Ministerial Declaration. Our activities were focused on coordinated implementation of projects of regional importance and coordination of numerous partners active in the area. Thus series of consultations and common activities with partners in the environment have continued during the reporting period.

In cooperation with GIZ Open Regional Fund (GIZ ORF) for Biodiversity and IUCN ECARO² who acts as the Biodiversity Task Force (BD TF) Secretariat, RCC continued supporting the work of the regional BD TF and regional presence at the 14th meeting of the Conference of the Parties to the Convention on Biological Diversity (CoP 14) to be held in November in Egypt. The area of conservation and sustainable use of biodiversity continues to be important while partners in this initiative have organized additional consultations in Kolašin (Montenegro) and are planning to organize final consultation (in October in Belgrade) and define regional approach and official poster for the CoP 14. BD TF continued to work on the implementation of the biodiversity Work Plan which identifies priorities in this area for the region.

In line with continual process of regional high-level cooperation, the Regional Working Group on Environment (RWG Env) met in Skopje and reviewed the progress achieved in the implementation of Bonn Ministerial Declaration. The RWG Env also initiated preparation of the next high-level panel on environment. The meeting will be co-hosted by RCC and the Ministry of Environment and Physical Planning of The Former Yugoslav Republic of Macedonia and will take place on 21st November in Skopje.

Successful implementation of the two projects developed under the SEE 2020 Strategy (water-food-energy Nexus and ClimaProof) continued in the reporting period. Coordination and regional ownership of these projects is ensured through Bonn Ministerial Declaration, while coordination role is played by the RWG Env. Preparations for the second Regional Roundtable on “The path towards Water, Energy, Food and Ecosystems Nexus in South East Europe”, to take place in October in Skopje, have already started. A Summer School for representatives of regional hydro-meteorological institutes, under the ClimaProof project, has been organized in July this year. This project is also progressing with the implementation providing training and developing useful software for analysing climate impacts on road infrastructure development.

A.3. The “Competitiveness” flagship activities in the reporting period were focused on development and finalization of the Regional Investment Reform Agenda (RIRA) and proposal for the regional programme on capital markets integration, as stipulated within the Investment Pillar of the Regional Economic Area. Industrial development is linked with the Smart Growth Pillar and development of the smart specialization schemes in the region, while sectoral activities were dedicated to implementation of the “Triple P” Tourism project.

A.3.1. Investment integration

The RCC, in cooperation with the World Bank Group, intensified activities on regional dialogue on harmonization of investment policies which led to finalization and endorsement of the Regional Investment Reform Agenda (RIRA) at the SEE Investment Committee Ministerial Meeting on May 11 2018, followed by confirmation of this agenda by the region’s Economy Ministers at the meeting in Vienna on 4 July and Prime Ministers at the WB6 Summit on 10 July in London. Prior to intensive regional dialogue on finalization and endorsement of the proposal, the RCC also organized consultations with individual economy MAP REA Investment Contact Points and other institutions in charge of policies put forward by the RIRA, within the scope of the Regional Investment Policy and Promotion project, in order to ensure that the respective individual-economy priorities are properly addressed within the agenda. RIRA is a first initiative of a kind in the region and is to provide for greater harmonization of regional investment policies with the EU standards and international best practices, within the framework of the SEE 2020 Strategy, CEFTA and EU pre-accession and accession processes. It is comprised of a reform schedule for a wide set of investment pertinent policies on investor entry and establishment, retention and protection, and promotion. In regards to the latter, the RCC has facilitated, in cooperation with the World Bank, a detailed proposal for Joint Investment Promotion Initiative (JIPI) in the context of RIRA, and commenced series of capacity building initiatives for the region’s Investment Promotion Agencies – the first one that took place with a study visit to German Trade and Investment Agency during the reporting period. RIRA policy set to be further enhanced by the upgrade and development of the network of International Investment Agreements and Bilateral Investment Treaties. Therefore the RCC has intensified cooperation of experts in charge of investment treaties with those from the judiciary and mediation in investment disputes, both from within the region and the EU practitioners in this field, in the form of capacity building and knowledge sharing on investment arbitration. In this respect, the regional experts have

had the opportunity to learn about the latest development on the topic of Multilateral Investment Court, and have agreed to commence preparation of the needs and relevant proposals for further improvement of the networks of International Investment Agreements (IIAs) and Bilateral Investment Treaties (BITs) under the auspices of the RCC.

The work on investment integration is intensively coupled with the integration of capital markets in the region, also under the framework of MAP REA. During the reporting period, the RCC has officially established Working Group on Capital Markets (WGCM), encompassing relevant line ministries (finance), central banks, securities commissions, and stock exchanges. The corresponding Terms of Reference for the WGCM was endorsed by the participants, who have expressed high expectations in terms of this agenda and the role of the RCC to coordinate this process both on political and expert level, given that increasing competitiveness of the region's capital market is of interest to all parties involved. Consequently, a proposal for a regional programme has been put forward for preparation and implementation of regional strategy on capital markets and its translation into individual economy policy reforms efforts. This proposal also entails supporting development of alternative sources of financing and access for business (particularly SMEs), advisory for initial public offerings for state owned enterprises and upgrade of regional online securities trading platform.

A.3.2. Industrial Development

During the reporting period, industrial development efforts were linked with Smart Growth, within the priority of Smart Specialization under the MAP REA. In this respect, the RCC facilitated and supported the process of establishment of a governance structure (S3 platforms) for preparing smart specialization strategies in those economies where not existing (Albania, Bosnia and Herzegovina, Kosovo* and The Former Yugoslav Republic of Macedonia), and also provided opportunity for advanced training on entrepreneurial discovery process (EDP) to participants from Montenegro and Serbia where the governing structures for smart specialization strategy are already in place. As a result, draft Roadmaps were prepared for the development of S3 platforms for Albania, Bosnia and Herzegovina, Kosovo* and The Former Yugoslav Republic of Macedonia, while Serbia and Montenegro prepared the EDP plans.

In support to the strategic sectors, the RCC has commenced the implementation of the "Triple P" Tourism project, financed by the EU, by establishing the project team comprised of: Team Leader, Key Expert on Cultural Tourism, Key Expert on Adventure Tourism, Communications Officer, Grant Officer, Project Officer, and Administrative Assistant. The project intensively focused its activities on tourism product development, policy reform and pilot projects development through a small grants scheme. Upon executing consultations in each economy with relevant institutional and private/civil sector stakeholders and re-establishing the Tourism Experts Group (TEG), the Triple P Tourism Project was officially and publicly launched on 28 June 2018 in Sarajevo. Parallel to this, industry assessments were performed in prioritized sector niches (culture and adventure tourism), and further advanced by the regional focus group discussion in each priority niche. Consequently, the main lines of regional tourism products development were defined, in cultural tourism: i) integration of archaeological sites of the Western Balkans into the existing Roman Emperors and Danube Wine Route through close collaboration with Danube Competence Centre and the Council of Europe; ii) development of the concept of Crossroad of civilizations as a shared overarching regional identity, with the focus on fortifications that communicate diversity of heritage and legacies iii) development of brand new regional route dedicated specifically to art and design of post-World War II monuments and buildings, while in the area of adventure tourism, expansion of Via Dinarica trails has been prioritized, together with creation of its joint regional management structure and

coordination mechanisms. The project and its goals and activities have been promoted at the EUSAIR meeting of the Steering Group for sustainable tourism (Zagreb, April 2018), Sarajevo Business Forum (April 2018), Triple P Launch event (Sarajevo, Jun 2018), Sarajevo Film Festival (August 2018), with an extensive communication strategy and plan prepared for further promotion. On policy reform, online tourism policy survey has been developed and released to the relevant stakeholders from governmental, civil and private sector, resulting in identification of the main barriers and key gaps in both culture and adventure tourism. Next steps will involve developing proposals for prioritizing and addressing these barriers.

At the Weekend Media Festival (Rovinj, 20-23 September) special presentation on the regional cooperation in tourism development and the actions and goals of the RCC Triple P Tourism in SEE project were delivered as a part of the event official program. In addition, a group of 6 journalists from the WB6 economies were supported to participate in the event. This support served to establish the core group of journalists/media in the region as the “project media pool” that will over the project period assist communicating the goals and objectives to wider audiences. The effort was also a push in upgrading the media capacity to follow and report on tourism development addressed through a selection of presentations, debates and workshops that participating journalists attended.

The RCC Triple P Tourism project took part in the 8th Annual Advisory Forum of the Council of Europe Cultural Routes on 26-28 September. This annual event offers an opportunity to debate priorities, review progress and share experiences. The 2018 Forum focused on the theme of the Routes connecting values, heritage, sites and citizens: strategies and synergies in a global perspective with the aim to strengthen cooperation between and among EU programmes, UNESCO World Heritage sites and other international, national and regional organisations. Series of discussions, roundtables, seminars and workshops were held during the event. The RCC Triple P Tourism project attended the event with the goal of gaining deeper insight into the processes of cultural route development and in particular the certification process, and to establish contact and open communication with those routes that are present within the Western Balkans to explore their interest and readiness to expand with new sites from the region.

To support further the infrastructure for regional tourism product development, Grants Work Programme and Grant Applications Guidelines has been in accordance with the EU and RCC rules on small grants. To ensure quality of applications with appropriate information dissemination, info days were organized in all 6 Western Balkans economies with attendance of total 349 industry participants. Subsequent publishing of the first Call for Proposal: “Support to the implementation of the RCC Triple-P Tourism in SEE: Promotion, Policy, and Pilots Grants Work Programme” resulted in significant application number from each eligible economy: total of 221, out of which 97 applications have met the deadline and administrative requirements. Evaluation process of the submitted concept notes has been completed, where 37 applicants have been invited to submit their full applications by 8 October 2018 for further evaluation. Envisaged 10+ grants are to be awarded for full eligible allocation of this call, in the amount up to 54,000 EUR maximum per application.

B. Governance, Rule of Law and Security Cooperation

B.1 “Public Administration Reform”

B.1.1. Public consultations on draft laws and public policy documents

Within the reporting period in the field of Public Administration Reform, the following has been implemented: following the broad consultation process over the previously developed Methodology on peer review missions to implement the Recommendation on Public Participation, the draft Methodology was presented at the Meeting of the Regional Working Group on Better Regulations, hosted by the RCC in April. Based on the endorsed methodology, the preparations for the first peer review mission which is to take place in October are underway. Finally, within the reporting period, the RCC in cooperation with ReSPA engaged international expert to conduct the peer missions in the region, with the purpose to enable peer learning exercise on public participation performance as well as to accommodate the existing best practices, thus implementing the regional standards on public participation on the most efficient way.

Additionally, regional conference was organised in partnership with ReSPA and supported by Centre of Public Administration Research KDZ from Austria on the topic of unlocking the benefits of public participation in decision making. The conference had regional coverage and resulted in raised awareness on the need to effectively organize and conduct public participation.

B.2. Rule of Law / Justice Reforms

B.2.1. SEE networks (judicial training institutions and associations of mediators), regional trainings and Western Balkans Working Group on Justice (WGJ)

The measures undertaken in the field of Justice during the first quarter of 2018 opened the way for the activities implemented during the reporting period:

The RCC was engaged in consultations with Council of Europe (CEPEJ – CoE Commission for efficiency of justice and HELP – CoE Human Rights Education for Legal professionals) regarding future cooperation. The aim is to organize different judicial training activities in WB6, with CoE's active participation.

Discussions have been held with Council of Europe (CEPEJ and HELP) to prepare the regional conference that will be held on 21-22 November 2018. The RCC has prepared the agenda and the list of topics for discussion in that meeting. CEPEJ (Commission on the efficiency of justice, Council of Europe) will participate in RCC SEE JTI Network meeting on 21-22 November 2018. It will present the latest data on the efficiency of judiciaries in SEE. For the purpose of that meeting, further consultations were undertaken with the representatives of European Judicial training Network (EJTN), SEELS (SEE Schools of Law Network) and University of Graz.

TAIEX started with preparation to organise regional workshop for judges and prosecutors based on RCC's proposal and concept note on judicial ethics. The workshop will be organised by Judicial training Centre in Podgorica, with the RCC organisational support.

On RCC's initiative and under RCC's organisation, CoE HELP is preparing a regional seminar for judges and prosecutors on cross-border cooperation in criminal matters (planned for December 2018).

RCC organised the 3rd Meeting of SEE Network of Associations of Mediators on 24-25 April 2018. Participants proposed to develop the guideline with concrete recommendations in alternative dispute resolution area and to organise meetings in cooperation with Judicial training institutions under the RCC auspices. The Network asked RCC to map the projects in mediation and to enhance promotion of mediation by raising public awareness.

The RCC organised regional judicial training institutions meeting “Judicial training in the Western Balkans: The role of judicial training in the appointment and career of judges and prosecutors” that was held on 7-8 June 2018. The representatives of ministries of justice, councils for judiciaries and judicial training institutions participated at the meeting together with the representatives of EC – DG NEAR, SEELS and EJTN (contact person for RCC in regional judicial training field). Based on one of the conclusions of the meeting the RCC published open call for expert in order to identify common standards in regional judicial training.

Back-to-back with these meetings in April and June 2018, the RCC organised the 9th and the 10th meetings of WB6 Working Group on Justice. The participants discussed and evaluated past activities and agreed on the future activities in the area of justice. WB WGJ concluded that regional cooperation in the area of justice enabled by the RCC continues to be very important support to the WB governments in achieving EC standards and fulfilling benchmarks related to Chapter 23 and 24 of accession negotiations.

The RCC and GIZ Open Regional Fund – Legal Reforms (GIZ ORF-LR) are continuing the implementation of the 20-months sub-project on ‘Improving the Regional Cooperation between Western Balkans’ Judicial Training Institutions’, developing regional database of legal experts in European law to be finalised in October 2018.

B.3 “Anti-corruption”

B.3.1. Support in conducting sectoral corruption risk assessment / anti-corruption assessment of laws

During the reported period, RCC together with RAI provided support to Montenegrin Anti-corruption Agency in developing its Questionnaire for assessment of efficiency and effectiveness of Integrity Plans in healthcare sector. Along this assistance, RCC together with RAI and the Montenegrin Anti-corruption Agency organized workshops in Budva and Podgorica, with the aim to enhance capacities of the Montenegrin stakeholders in conducting the preventive measures in line with the RCC’s Regional Methodologies on the same matters.

Within the reporting period the RCC had finalised the Study - Checklists on Corruption Risks in the Healthcare Sector. The Checklist is published on the RCC website³.

B.4. Security cooperation

Under **the security component** of the Stability and Rule of Law, efforts were focused on continuous implementation of the **Regional CVE-FTF Platform** and support to existing specialized regional security cooperation formats in SEE.

The Fifth meeting of SEE National Focal Points Group (SEE NFP) took place in Belgrade on 17 April 2018. The participants welcomed the progress made by the governments from SEE in legal framework, P/CVE national coordination mechanisms, updating the legal and institutional framework and enhancing regional and international cooperation in countering violent extremism and

radicalization leading to terrorism and foreign terrorist fighters. It has been underlined that the efforts should also be focused on: better prevention of VE through normative and legal approach and ways how to criminalize online radicalization while respecting the right of freedom of speech. It has been agreed to put the emphasis on prevention, disengagement, rehabilitation, reintegration of former FTFs, raising awareness, especially among youth and the phenomena of local radicalization. Participants emphasized that engagement of the civil society, local and religious communities, youth, as well as education are important for the success of P/CVE efforts. The need for developing clear indicators (both, at institutional and societal level) in dealing with radicalization was also mentioned.

As a continuation of the meetings in UK and Montenegro, the RCC has actively participated at the preparatory meeting and MoU drafting conference dedicated to the security agenda of the London Western Balkans Summit within the framework of the Berlin Process, held on 15 May 2018 in the Former Yugoslav Republic of Macedonia. The participants agreed on the following: 1) Ministers of interior in London will discuss and adopt a Joint Declaration; 2) Participants of the Berlin process London Summit are expected to also fully endorse “A Call to Action to End Forced Labor, Modern Slavery and Human Trafficking” launched on the 19th September 2017 during the 72nd Meeting of the UN General Assembly; 3) The Joint Statement on strengthening regional cooperation and regional commitments towards Small Arms and Light Weapons will also be part of the London Summit conclusions and 4) Technical protocols on information-exchange (e.g. on ballistics, terrorist threat, illicit trade, financial intelligence) will be discussed and agreed on a later stage involving relevant stakeholders from WB6 economies. It has been decided that the implementation of aforementioned commitments will be monitored by the Berlin Process – Security Commitments Steering Group whose formation will be officially endorsed by the Ministers of Interior of the WB at the London Summit. The Group, composed of high level officials from relevant Ministries and security agencies will be created in September 2018 and will meet twice a year. It will be chaired by the UK for the year after the date of the 2018 London Summit, and beyond that by a chair to be decided by the participants.

The 10th SEEMIC Working Group meeting held in Tirana, 29 May 2018 has agreed on the draft Draft OSINT 2018 report “Challenges to Critical Cybersecurity Infrastructure in SEE” and will be presented to Military Intelligence Chiefs at their annual gathering planned for November 2018. The document is structured around five subtitles: 1) Cyberattacks to critical infrastructure as a raising threat; 2) Public-private partnership in critical cybersecurity infrastructure; 3) Regional and international nature of cybersecurity; 4) Cybersecurity challenges to military infrastructure and 5) Human factor in cybersecurity.

C. Horizontal and supporting activities

C.1. Coordination, monitoring, programming

C.1.1 Programming activities

During the reporting period, RCC finalised the fourth cycle of monitoring process of the SEE2020 Strategy. The data collected through the online platform were transferred into the SEE Score Board platform (SEEDS), which is now available to the wider public. The monitoring process finalised with the preparation of the SEE2020 Annual Report on Implementation for 2018, which was agreed with the national authorities through the SEE2020 Monitoring Committee. The final report was endorsed by the SEE2020 Governing Board, held on 05 July 2018 in Brussels. The next steps include preparation for the next monitoring cycle of the SEE2020 Strategy implementation.

C.1.2. Monitoring activities

Within this period the RCC finalised the fourth edition of the Balkan Barometer (BB 2018). The survey covered the business and public opinion for the current year, including comparative measurement of the findings in all four editions. The survey also provided analysis of the perception across the WB6 on the MAP REA aspects, in particular in the areas of mobility, investment and digital agenda. The findings of the BB 2018 were presented on a launching event in Brussels on 06 July 2018. The meeting was covered by regional (Sarajevo, Belgrade, Pristina, Tirana, Podgorica, Skopje and Sofia) and Brussels media, thus ensuring the regional coverage and dissemination of the findings. For the purposes of dissemination of the findings, the RCC also developed Balkan Barometer brochure with infographics and a video presenting the main findings.

Next steps include preparatory activities for the start of the next Balkan Barometer survey.

C.1.3. Coordination activities, grants

Work continued also on implementing the RCC grant facility call for proposals (4th CfP) in the total amount of (approx.) 80.000 EUR. The specific objective of the 4th CfP is to support the implementation of the Multi-annual Action Plan for a Regional Economic Area in the Western Balkans (MAP REA). The 4th CfP evaluation procedure was finalized and the successful applicants started with the project implementation.

C.1.4. Horizontal activities related to the MAP REA

Several activities to ensure the MAP REA implementation have been organized during the reporting period.

The second meeting of the MAP Component Contact Points (MAP CCPs) was held in Tirana on 15 May 2018 to review the progress on the MAP measures and discuss on the first draft Annual Report on MAP REA implementation, prepared by the RCC and CEFTA Secretariats based on inputs provided by WB economies. The MAP CCPs had an informed discussion on the draft report and agreed in principle with its structure and main features. Next steps for validation of the main findings from the report were also agreed.

RCC, tasked with the overall coordination and monitoring of the MAP REA, finalized the first Annual Report on MAP REA implementation. The report was presented during the MAP CCPs meeting and validated by the economies through electronic consultation, with afterwards comments and suggestions duly reflected in the final draft. Moreover, MAP Brochure is prepared – progress at regional level and each economy along the four components presented and next steps systematized.

RCC contributed in the preparation of the Economy Minister's Meeting of the London Summit, held on 4 July 2018, and led the panel discussion related to MAP REA presenting the key achieved deliverables and next commitment. The Economy Minister's Meeting recognised the pivotal role of RCC in MAP REA implementation, highlighted the progress made in so far and welcomed the preparation of the forward-looking commitments.

RCC has continued to maintain regular reporting to MAP structures and WB PM's representatives. On this note, RCC has presented during the Sherpa's meeting, respectively held on 11 April and 20 June

2018, progress made at regional and, at each economy level based on the letters of Commissioner Hahn sent to WB6 on priority measure relevant to MAP REA.

On the **Roma Integration 2020 programme**, under the RCC framework, the Roma Integration 2020 Action Team organized a regional conference on the topic of "Holistic Approach to Housing for Roma in the Enlargement Region" on 31 May and 01 June 2018. The regional conference brought together the National Roma Contact Points (NRCs) from the Western Balkans and Turkey, along with the primary responsible government officials dealing with the priority area of housing, as well as officials dealing with local level governance, employment and social care programming. The regional workshop also provided for participation of one Roma civil society representative per participating economy. Guests and panellists of the workshop included relevant persons from the enlargement region active in the field of housing, including representatives of relevant NGOs and international organizations.

This workshop was an effort to increase the knowledge and understanding of public officials on the advantages of a holistic approach to housing and serve as a platform to discuss ways in which the approach can be applied when preparing and implementing future housing initiatives. The main topics of discussion were housing legalization and social housing and how these solutions can be integrated into a holistic approach. A number of successful stories and appropriate legislative solutions were presented.

The Roma Integration 2020 also established a regional Working Group on Roma Responsible Budgeting comprised of the NRCs and representatives of the Ministries of Finance of the enlargement region. Such an initiative came from the participating economies in order to initiate the process of developing guidelines on Roma responsible public budgeting which will be completed by the end of 2018.

The Action Team co-organized with the NRCs Public Dialogue Forums in Albania, Montenegro, and Serbia with the participation of representatives of relevant central and local government units, European Union Delegations and civil society. The aim of the forums was to present the progress reports for 2017 on the implementation of the Roma Integration Action Plans and discuss these reports with the civil society. The Action Team issued policy briefs summarizing the main conclusions and recommendations from the meetings.

On **Communication**, the RCC continued to implement its triannual Communication Strategy which reflects the agenda of the organisation, upgrades the established RCC profile to reflect its increasingly regionally-owned, active and all-inclusive role and influence. The primary objective is to keep building the understanding on what the RCC does, increasing political, financial as well as public support for its activities, but also to keep raising awareness of the organisation and the regional cooperation process in general, building and promoting the SEE image based on the RCC's key mission postulates.

RCC continues developing and promoting tools for user-friendly dissemination of information on RCC's role in the region, gaining better understanding and interest from different target audiences regarding RCC's focus and activities. This is resulting with a major increase in media interest and media coverage of RCC's events and projects, and also with general support to the RCC and its activities. As an example of the heightened interest and understanding of the RCC by its major stakeholders, including media, the organisation's website had over 20% more visits and 50% more page views. Social media followers and their engagement either achieved the set target or

overpassed it from 30% to 70%. Comparing to the same period of 2017, the number of media reports rose by more than 300%.

3. Management and operations

A remaining open issue related to the setting-up of the RCC Secretariat concerns the implementation of the provisions of the Headquarters Agreement between the Kingdom of Belgium and the RCC Secretariat, which regulates the status of the RCC Secretariat's Liaison Office in Brussels.

The Kingdom of Belgium has conditioned the implementation of relevant provisions of the Headquarters Agreement between the Kingdom of Belgium and the RCC Secretariat providing for the fiscal privileges and immunities of the Head and Deputy Head of the RCC Secretariat's Liaison Office in Brussels with the issuing of an official authentic interpretation concerning the implementation of Article 17.1.(d) of the Host Country Agreement by the Parties to this Agreement in which the principle of taxability of the officials of the RCC Secretariat in their countries/places of origin and/or permanent residence would be explicitly confirmed. After a consultation procedure initiated by the RCC Secretary General in August 2008 it became evident that the adoption of an interpretative declaration amending the Agreement would not be acceptable to some of the Parties to the Host Country Agreement, as they consider that such declaration would run counter to the spirit of the current provisions of the Agreement and would lead to its de facto amendment. In light of the principles of general international law, the only recourse in this situation would be to proceed with amending the Host Country Agreement accordingly, in light of the request from the Kingdom of Belgium. This, however, remains subject to the will of the Parties to the Host Country Agreement. In this view, the RCC Secretary General sent a communication to the authorities of Bosnia and Herzegovina in early January 2009, proposing to the Council of Ministers of Bosnia and Herzegovina as a Party to and, at the same time, a depositary of the Host Country Agreement to consider the possibility of initiating the process of amending relevant provisions of the Agreement in order to provide for requested confirmation of taxability. This proposal of the RCC Secretary General is still under consideration by the authorities of Bosnia and Herzegovina.

The RCC Liaison Office keeps regular contact with the Protocol of the Belgian Ministry of Foreign Affairs regarding the ratification process of the Headquarters Agreement between the Kingdom of Belgium and the RCC Secretariat (signed in 2008).

4. Key challenges in the reporting period

The situation with regard to risks and challenges to the implementation of regional cooperation is expected to remain basically the same also for the foreseeable future. RCC will work to obtain adequate government representation and/or timely action from the beneficiaries' side. As previously, representatives from the economies sometime join the activities with unclear mandate, as well as with inadequate capacities and expertise to take part in various RCC-facilitated processes. The multifaceted challenges the economies of the region are facing domestically tend to move away their attention from cooperation at regional level.
