The Report on the activities of the Regional Cooperation Council (RCC) Secretariat is submitted by the RCC Secretary General to the RCC Board in line with Article 15 of the Statute of the RCC. It covers the period between 1 September and 31 December 2017.

1. Summary of activities

In the reporting period, the RCC Secretariat's activities were focused on the implementation of the Strategy and Work Programme (SWP) for 2017 – 2019 through the flagship approach – skills and mobility, connectivity and competitiveness and on the start of implementation of MAP REA - the Multiannual Action Plan for establishing the Regional Economic Area in WB6. The RCC Secretariat continued to uphold a regional cooperation framework conducive to the implementation of the strategy by actively engaging in regional political and sectorial activities, as well as by maintaining partnerships with regional and international stakeholders involved in supporting the regional cooperation in SEE.

The 33rd meeting of the RCC Board held on 18 October 2017 provided operational guidance and supervision of the organization and accepted the Report of the RCC Secretary General on the activities of the RCC Secretariat for the period April - August 2017. Moreover, the RCC Board: a) adopted Decisions on the dates of the RCC Board meetings for 2018, and on the Budget of the RCC Secretariat for 2018; b) took note of the priorities and calendar of activities of the Slovenian SEECF C-i-O; c) took note of the progress made in the implementation of the SWP 2017-2019 and RCC's role in the implementation of Multi-annual Action Plan for a Regional Economic Area (MAP REA) in the Western Balkans; d) approved the signing of the Memorandum of Understanding (MoU) between the RCC and the Regional School of Public Administration (ReSPA), the extension of the MoU with the European Training Foundation and witnessed a presentation by the Police Cooperation Convention for South East Europe Secretariat. The 19th meeting of the Financial Sub-Committee to the RCC Board was held on 14 September 2017. The members of the Financial Sub-Committee reviewed the preliminary financial results of the RCC Secretariat for the year 2017 and recommended to the RCC Board to adopt the draft Budget of the RCC Secretariat for the year 2018.

The RCC Board meeting was preceded by the 25th Coordination meeting between the SEECF Troika, the RCC Secretariat and the EU. The meeting provided a context for discussing the most important activities related to the priorities of the Slovenian SEECF C-i-O for 2017-2018 and of the RCC Secretariat, in particular those related to the implementation of the RCC SWP 2017-2019.

Under the motto "SEE 4 Future" and in line with the priorities - enlargement, youth, security, digital agenda, parliamentary cooperation and further enhancement of the economic cooperation in SEE, the Slovenian SEECF C-i-O organized a number of high level events at the outset of its Chairmanship.

The informal meeting of the SEECF Ministers of Foreign Affairs, with the participation of the HR of the European Union for Foreign Affairs and Security Policy and Vice President of the EC, held on 5 September 2017, underlined the importance of continuing the EU enlargement policy and the role of regional cooperation in this respect. The RCC Secretary General presented the RCC's activities on regional economic integration, skills and mobility, the digital agenda, rule of law and security cooperation.

As a follow up to the Western Balkans Summit in July 2017, the RCC Secretariat organized the informal meeting with the MFAs from the WB, which included the participation of the Commissioner for European Neighborhood Policy and Enlargement Negotiations, on 20 September 2017 in New York. The meeting was focused on the enlargement process, implementation of MAP and RCC's role and deliverables in this respect.

Moreover, the meeting of the Standing Committee of the SEECP Parliamentary Assembly took place on 16 December 2017 in Ljubljana. The participants exchanged views on future activities within the SEECP framework, commended RCC's engagement in fostering a multilayered regional cooperation and witnessed a presentation of the priorities of the incoming Bulgarian Presidency of the Council of the European Union.

Overall, the dialogue established between the Slovenian SEECP C-i-O and the RCC Secretariat paved the way for greater synergy, better alignment of priorities and further fostered the regional cooperation process in SEE.

The RCC Secretary General, in the framework of his permanent dialogue with the RCC participants, held consultations with high-level officials from Slovenia in its capacity as the C-i-O of the SEECP, Bulgaria, United Kingdom and the State Department of the U.S.A. The consultations maintained and galvanized support for the activities of the RCC Secretariat in the context of the implementation of the RCC SWP for 2017 - 2019.

In the light of the growing EU focus on the WB and its European integration, the RCC Secretariat has intensified its communication and cooperation with EU institutions and bodies, and in particular representatives of the Western Balkans permanent missions in Brussels, European Commission (DG NEAR, DG CONNECT, DG JUST, DG JRC, DG EMLP, DG CONNECT, DG EAC, DG RD), NATO, CEFTA, European Economic and Social Committee, Friends of Europe and European Policy Centre.

The RCC Secretary General used his high-level meetings with the EU institutions to present RCC's key activities in three flagships, focusing on central areas of MAP, how they feed in the SWP and their value added to the entire SEE Region, including the Western Balkans EU aspirants, EU member states from SEE and other participants from the region. The meetings ensured strong commitment of the EU to the implementation of MAP, support to enhanced regional cooperation and European perspective of the WB.

During the reporting period, the RCC Secretary General participated and addressed high-level events with a regional dimension such as: 12th Bled Strategic Forum (Bled, Slovenia, 4 September 2017); Brdo Process Ministerial Meeting – IISG kick-off conference (Brdo pri Kranju, 8 September 2017); Meeting of the Western Balkans Steering Platform on Research and Innovation (Belgrade, 28-29 September 2017); 7th Belgrade Security Forum (Belgrade, 14 October 2017); Wilton Park Conference, Security, the Western Balkans and the UK: working together to address shared challenges (Wilton Park, 20 – 21 October 2017); Ministerial Meeting on Roma Integration 2020 (Tirana, 10 November 2017); Participation at the Fifth Belgrade NATO Week (Belgrade, 16 November 2017); The Western Balkans High-level Meeting on Environment and Climate Change (Bonn, 17 November 2017); UNCTAD Investment Policy Review for SEE (Geneva, 21 November 2017); 2nd Berlin Global Forum (Berlin, 23 – 24 November 2017); Friends of Europe : Western Balkans at a Crossroads (Brussels, 5 December 2017) and the Rome Investment Forum 2017/Financing Long-Term Europe (Rome, 16 – 17 December 2017).

The Consolidated Multi-annual Action Plan on Regional Economic Area (MAP REA), endorsed in Trieste, on 12 July 2017 put forward a structured agenda for regional economic integration aiming at furthering trade integration, introducing a dynamic regional investment space, facilitating regional mobility, and creating a digital integration agenda. The MAP REA and its related activities were at the core of the RCC Secretariat activities in the period September-December 2017. The RCC Secretariat, in close cooperation with the CEFTA Secretariat and the National Authorities, has undertaken several activities to support the implementation of the MAP REA actions.

The Balkan Barometer Business Opinion Survey 2017 and Balkan Barometer Public Opinion Survey 2017 were officially launched and presented by the RCC Secretariat on 9 October 2017 in Brussels. Both editions are aimed at tracking progress in the implementation of the SEE 2020 Strategy and at providing data on the most pressing issues in the region.

Furthermore, enhanced cooperation in the areas of justice reform, judicial cooperation, migration, border management and counter-terrorism and radicalization were key topics debated at the EU-Western Balkans Justice and Home Affairs Ministerial Forum, organized under Estonian Presidency with the EU on 26-27 October 2017 in Sofia.

A. Implementing SEE 2020 Strategy through Flagship Approach

A.1. “Skills and Mobility”, encompassing the policy areas of education, employment, mobility, migration and social policy

A.1.1. Removal of obstacles to mobility of students and highly skilled workers in the region: mutual recognition of academic qualifications

- Advancing its Mobility agenda, on 14 December 2017 the RCC organised in Belgrade the Seminar on Recognition of Academic Qualifications. The seminar provided an opportunity to discuss the recognition of academic qualifications from key stakeholders in the process, namely representatives of the Ministries of Education, ENIC/NARIC offices, higher education institutions and students. Back to back with the seminar, the 1st formal meeting of the Joint ERI SEE – RCC Working Group on Recognition of Academic Qualifications took place on 15 December 2017. The Joint ERI SEE - RCC Working Group on Recognition of Academic Qualifications was tasked to prepare, coordinate, monitor and report on the activities aimed at supporting and implementing the commitments outlined in the Multiannual Action Plan on the Regional Economic Area (MAP REA) on recognition of academic qualifications. At the 1st formal meeting of this Joint Working Group the Terms of Reference and the Action Plan on Recognition of Academic Qualifications were discussed by the representatives of the Ministries of Education of the Western Balkans Six economies. The Terms of Reference and the Action Plan of Recognition of Academic Qualifications have been shared with the Ministries of Education and Mobility MAP coordinators on 19 December 2017 for written comments and approval, expected by 15 January 2018.
- As part of the substantial set of measures in Investment, Mobility and Digital Agenda which address the R&D and innovation systems in the Western Balkans, on 6 December 2017 the RCC organised in Brussels a workshop on Smart Specialization for the RCC’s Research and Development (R&D) and Industrial Working Group. The meeting was attended by the representatives from the Ministries responsible for R&D and innovation and the representatives from the respective Ministries of economy responsible for industrial policy to discuss the actions on Smart Growth with a focus on the development of Smart Specialization Strategies in Western Balkans Six (WB6). With regards to the coordination and operationalisation of the Smart Growth component of the MAP REA, the participants agreed to have a meeting in spring 2018 in an appropriate format which will include representatives from Ministries of R&D, Economy (but not only industrial policy) and digital innovation, to discuss the overall set of actions in smart growth component and how to support the operationalisation of actions at a regional level.
- The workshop on smart specialisation was preceded by the R&D Ministries participating at the 5th meeting of the EU member states network of national points of reference on Scientific Information which took place on 5 December in Brussels. Western Balkan economies contact points for Open Science and RCC have been invited, together with the EU member states, to present the latest developments and activities in the field of Open Science at this meeting. RCC

supported the participation of 14 participants from the Ministries responsible for research and development from the six Western Balkans economies plus Turkey, who are also participants to the RCC's Open Access Working Group (OAWG). The EC's regular report on the implementation of the Recommendation on Open Access will for the first time include a section dedicated to the Western Balkans. The Western Balkan economies have been also invited to contribute to the revision of the Recommendation on Access to and Preservation of Scientific Information and more importantly the initial steps were made to include the Western Balkans into the OpenAIRE National Open Access Desks (NOAD). The EC strongly supported the collaboration of NOADs and NPRs, especially for reporting to the Commission on the OA/OS policies. The EC also supported the initiative for RCC to facilitate the connection with OpenAIRE to see whether participation of Western Balkan economies is possible in the future. One of the items on the Agenda of the meeting was the regular report on the implementation of the Recommendation which will for the first time include a section dedicated to the Western Balkans. The members of the RCC Working Group on Open Science have set an ambitious goal of implementing the Recommendation into their national R&D policies and systems. The work of the Working Group on Open Science has been supported by the European Commission's Directorates-General for Research and Innovation (DG R&I) who have invited the Western Balkans to participate in the regular EU member states' reporting process.

- The **Employment and Social Affairs Platform (ESAP)** - part of the Inclusive Growth pillar of the SEE 2020 Strategy and integrated within the "Skills and Mobility" flagship - is in implementation since March 2016:
 - During the November – December 2017 period, representatives of Public Employment Services (PES) of the Western Balkan economies have delivered on the implementation of the bench learning initiative. This has entailed a combination of self and external assessment of important areas and aspects that affect the performance of PES offices. Workshops and working group meetings have contributed to a better understanding of the process and have enabled PES officials to fill in the national self-assessment template. Six external assessment visits were also conducted by a team of peer assessors (senior PES experts from PES offices from the region and experts). The resulting external evaluation reports will provide a better and more profound understanding of performance management, as well as achievements and main challenges in the operational processes of PES offices.
 - Regarding the peer reviews process of employment policies or programmes, which is modelled against the EU mutual learning exercise, work is underway to produce national and regional reports for the peer review events on employment of people with disabilities in Serbia, self-employment in Kosovo* and youth employment in Montenegro. Additionally, the topics for the peer reviews on the other three Western Balkan economies have been identified as follows and implementation will continue in the coming period: internship programme (The Former Yugoslav Republic of Macedonia), local employment partnerships (Bosnia and Herzegovina) and on the job training for youth (Albania).
 - An analysis of recent trends in the Western Balkan labour markets, focusing on conditions for job creation and factors leading to the employment challenges of the region has been prepared.
 - The demand driven technical assistance instrument of the ESAP project has been utilised by the Ministries of Labour and Social Affairs and Public Employment Services of the Western

Balkans. The assistance consisted of the support for developing a single integrated electronic system for all databases under their responsibility, an analysis of the vocational training centres and the initiation of a technical assistance effort to upgrade their Information Technology system in line with EURES requirements in two beneficiaries, while other participating economies are developing further requests.

A.2. The “Connectivity” flagship continues to be an important domain where numerous interventions in the sector of transport, information communication technologies (ICT), energy, environment and climate change were implemented in the reporting period.

A.2.1 Digital integration agenda

- Intensive consultations with the Western Balkan Governments, the European Commission and regional and international stakeholders on regional measures supporting the digital transformation of WB6 through the implementation of the Multi Annual Action Plan for a Regional Economic Area (MAP) continued in various formats.
- As foreseen by the Declaration of the Italian Chair of the Trieste Western Balkans Summit 2017, the RCC initiated a continuous regional multi-stakeholder dialogue on digital transformation which will culminate in a Western Balkans Digital Summit to be organized each year. The preparations for the first Summit have officially started with the establishment in October 2017 of the Steering Committee that consists of the representatives of the WB6 Governments, the RCC, EC, German Government, industry and other stakeholders. The regionally-owned first Summit will be hosted by The Former Yugoslav Republic of Macedonia in mid-April 2018, followed by Serbia which will host it in 2019. The established dialogue and the Summit itself are designed as a process which will spur the digital transformation of the region, facilitate necessary digital infrastructure development to go hand in hand with improvement of legal framework and enable reaping various benefits of digitization of WB.
- Moreover, the RCC carried out the stock taking and needs-assessment analysis in the area of digital integration in WB and is presently working on the finalization of the report on status, actions and priorities in areas of digital infrastructure development, improving trust and digital security, enhancing digital skills of citizens and IT specialist through the region and strengthening cooperation and stimulating transformation to digital economy. In cooperation with the EC, RCC commenced work on analysing the impact of abolishing of roaming charges in the EU on WB economies. The findings of this analysis will serve as inputs for development of WB Roaming Roadmap to be presented at Western Balkans Summit in May in Sofia.
- In cooperation with International Telecommunication Union (ITU), the RCC organized a training for representatives of Cyber Security Incident Response Teams (CSIRTs) and initiated a regional dialogue and information exchange among them with the aim of creating regional CSIRTs network in the future, as required by NIS Directive¹.
- During the reporting period, through various initiatives Western Balkans economies were encouraged to take part in current EU digital processes and frameworks (to participate in the Digital Skills and Jobs Coalition; to join cross-border Internship programme; to participate in the EU’s Cybersecurity Agency work as observers; to join EC’s work on preparing WiFi4EU pilots in WB; to participate in the newly established Broadband Competence Office Network; to

participate in ENISA activities, at least as observers; etc.). A significant milestone in this period is the opening of the Western Balkans Investment Framework support for digital sector, which will be eligible for technical assistance for broadband connectivity projects in the future.

- Also, the first results of the field visit phase of the World Bank-led study on Western Balkan Digital Highway have been presented to the WB Governments (line ministries and regulators). In addition, the preliminary results of industry-led Study on Potentials and Impact of Digital Transformation in WB6 have been presented to the WB Digital Summit Steering Committee, while the final findings and conclusions of both initiatives will be presented on the occasion of Western Balkan Digital Summit in Skopje, in April 2018.

A.2.2. Sectoral support in environment, energy and sustainable development

- A series of consultations with partners in the environment dimension have continued. As a result of the existing process and work carried out by the Regional Working Group on Environment (RWG Env) as well as conclusions of the Podgorica Declaration, the Western Balkans ministers of environment and climate change convened in a meeting organized by the RCC in November in Bonn, on the margins of the 23rd Conference of Parties (COP23)². The Ministers and high-level representatives adopted the “Bonn Declaration”, thereby reconfirming their readiness and commitment to strengthen regional cooperation and make additional efforts to protect and preserve the environment, to mitigate climate impact and increase adaptive capacities on their way towards the EU accession. The Ministers also expressed readiness to coordinate important regional projects through the RWG Env in the future, to ensure cross-sectoral cooperation and integrated energy and environment planning and consideration in line with the EU 2030 climate and energy framework goals.
- With the aim of strengthening regional efforts and cooperation in the area of conservation and sustainable use of biodiversity, the Biodiversity Task Force (BD TF) was established in November 2017 as an implementing body of the RWG Env. The Task Force is composed of experts in charge of biological diversity and nature protection from 6 WB economies and Croatia is participating as observer. This initiative is a result of the cooperation between the RCC, GIZ Open Regional Fund (GIZ ORF) for Biodiversity and IUCN ECARO³ who acts as the BD TF Secretariat. The BD TF is now in the process of preparation of a regional Biodiversity Work Plan which will identify priorities in this area and which is expected to be finalised by the end of January 2018.
- Two projects of regional importance, developed under the SEE 2020 Strategy (water-food-energy nexus, dealing with establishing balanced and prudent use of the three resources, and Climaproof on integrating climate consideration in road transport infrastructure development) and implemented by the RCC partners, continued with implementation, while coordination and regional ownership will be ensured through the RWG Env in the future.
- The RCC commissioned a Regional Study on Climate Change in the Western Balkans and its Impact on Economic Development, which should evaluate the expected changes of climate in the upcoming decades and assess their impact on certain economic sectors (agriculture, water management, forestry and human health). The Study is in the final phase of preparation and will be ready by the end of January 2018. It will serve and help policy makers and experts in the WB region, providing better informational basis for development of national strategies and legislative frameworks. The Study will assess perspectives and facilitate the meeting of the

commitments stemming from the Paris Climate Agreement, and/or Climate Change Strategy goals (as for Kosovo*, not being part of UNFCCC).

A.3. The “Competitiveness” flagship activities served to (1) launch the smart specialization and capital markets integration platforms within the WB6 Multi-Annual Action Plan for development of Regional Economic Area, (2) continue the development of investment reform agenda and (3) a number of sectoral activities.

A.3.1. Investment integration

- The Final Regional Investment Policy Review (IPR) benchmark study has been published in November 2017 and publicly presented at the UN Office at Geneva. The IPR Study complements the efforts of the “Berlin Process” in general and in particular the Multi-Annual Action Plan for Regional Economic Area in the Western Balkans. Under the MAP, development and implementation of the regional investment reform agenda was stipulated as one of four priorities. The region, under the RCC umbrella, is soon to start working on constituting a set of policies to undergo reforms to better combine competition with cooperation. The investment reform agenda would include a heterogeneous mix of policies, involving a wide scope of stakeholders – such as authorities in charge of labor, tax, fiscal incentives, international investment agreements, joint investment promotion, etc. as well as the private sector.
- The Regional Investment Policy and Promotion project is on track, steered by the RCC’s Joint Working Group on Investment (JWGI), implemented by the World Bank and financially supported by European Commission. Baseline data collection within the project is already done, and currently work is taking place on identification and stocktaking of key investment policy barriers in the WB6 with the expected deliverables in the form of FDI mapping report and investor database during 1st quarter of 2018.
- The RCC has intensified activities related to capacity building and knowledge sharing of international investment experts in the form of small scale focused technical workshops on the topics of International Investment Agreements (IIA’s) and Investor State Dispute Settlement (ISDS). During the meeting of the JWGI in November 2017, the RCC and the SEE government experts on investment policy, promotion and dispute settlements have reviewed the actions of the regional investment agenda on investment analytics (mapping and data harmonization), policy reform (through joint regional dialogue on priority policies subject to reform, national reform implementation and monitoring), joint investment promotion (targeted and focused on priority sectors) and investor state dispute settlement (awareness raising and establishment of centralised investment dispute settlement mechanism). Furthermore, the RCC has intensified cooperation of SEE government experts in charge of investment treaties with those from the judiciary and mediation in investment disputes, with the aim to work on the future development of dispute prevention and mediation mechanisms.
- On the occasion of the South East European Investment Committee (SEEIC) meeting held in November in Geneva, the economies were briefed on the ongoing activities within the investment agenda and what is expected in terms of detailed development of activities and implementation of the WB6 Multi-Annual Action Plan for Regional Economic Area. The SEEIC participants have reiterated their support and dedication to implementation of priority

measures through the existing SEEIC platforms (technical/working groups, plenary, and ministerial).

- Together with WB CIF (Western Balkans Chamber of Investments Forum), RCC is preparing a Regional Online Investment Platform (OIP), which shall serve as a one-stop window for foreign and domestic investors looking to invest in the WB. On one hand, the Platform will serve to promote the region as a unique business destination, to inform potential investors about the region and lead them to the investment decision and, on other hand, to make it easier for SMEs to invest as well and help WB6 governments in removing barriers and fostering transparent business environment to growth in the region.
- At the meeting in December 2017 of the Capital Market Development Working Group, the RCC has established a regional platform for SEE financial markets integration, comprised of representatives of line ministries, securities commissions and stock exchanges of the SEE economies. The platform will serve to help identifying the needs on capital markets development based on existing analytics and reform initiatives. This new initiative expressed high level of interest and dedication to work in this particular area under the umbrella of RCC and agreed to invest best efforts in outlining needs for capital markets development and consequently designing a regional strategy for capital markets development, which is anticipated to be rolled out into concrete roadmap by the next WB6 PM Summit.

A.3.2. Industrial Development

Within the reporting period, under the agenda item “**A.3.2.6. Support to sectoral development**”:

- The RCC finished the Final Project application for the “Triple P” tourism project and the contract with the EC was signed by the EC and RCC’s Secretary General at the end of December. The RCC has engaged in public announcements for hiring the project team and the preparation of the launching event for the project.
- The RCC established a regional dialogue with the aim of knowledge exchange on developing Smart growth strategies based on EU experience and support the development of smart specialization, research and innovation strategies in the WB6 to ensure strategic structural investments and to build competitive advantage. Industrial development efforts will be directed to the MAP measure on smart growth, by alignment of industrial policies with smart specialization.

B. Governance, Rule of Law and Security Cooperation

B.1 “Public Administration Reform”

B.1.1. Public consultations on draft laws and public policy documents

- The RCC finalized the activities aimed at improving public participation practices in the Western Balkans economies. The draft Recommendation on Public Participation, developed and broadly discussed throughout the course of the year, was endorsed at the Meeting of the Regional Working Group on Better Regulations hosted by the RCC on 21-22 September 2017. The document lays down the processes, methods and principles that are recommendable to use in

order to enable a genuine dialogue with those likely to be affected by the policy changes. It was finally endorsed by the Western Balkans ministers in charge of public administration in Tirana on 6 November 2017. The project was supported by ReSPA, SIGMA, Council of Europe, USAID and Western Balkans Enabling Project for Civil Society Monitoring of Public Administration Reform (WeBER) Project.

- Following the adoption of the Western Balkans Recommendation on Public Participation, in order to streamline its enforcement by national institutions, the RCC has produced the Methodology on Peer Reviews for Western Balkans' Recommendation on Public Participation implementation. The Methodology foresees the processes of creation of teams, bases of assessment, organization of reviews, expected results, indicators, key questions for assessments, and review template report. The document will serve for the follow-up phase of the Recommendation implementation, which will be carried out in 2018 – 2019.

B.2. Rule of Law / Justice reforms

B.2.1. SEE networks (judicial training institutions and associations of mediators), regional trainings and Western Balkans Working Group on Justice (WGJ)

- On 24-25 October 2017, the RCC organized in Zagreb the 2nd Meeting of the SEE Network of Associations of Mediators. The meeting provided information about the European Judicial Network (EJN)/European Law Institute (ELI) project on alternative dispute resolution, similarities and differences but also advantages and disadvantages of mediation and arbitration as tools for enhancement of business-friendly environment.
- As a focal point of the Working Group on Justice, the RCC kept continuous communication with Directorate General for Justice and Consumers (DG JUST) and DG NEAR to make sure that the activities in this area are based mostly on the EC progress reports in the area of justice (Chapters 23 and 24 for the negotiating EU candidates). At its 8th Meeting on 6-7 December 2017 the WGJ continued its assessment of the ongoing RCC's activities and advised to continue with its focus on judicial training and alternative dispute resolution as tools for reducing court backlog and creating more accountable judiciaries in WB. The members of the WGJ agreed upon the indicators proposed by the RCC and started collecting the requested data in the area of justice.
- The work of the WB Judicial Training Institutions JTIs continued to be focused on enhancing mutual legal assistance between judiciaries in the region, on cross-border cooperation in civil and commercial matters, as well as on improving competences of judges in EU case law and mediation skills, aiming at improving capacity and independency of training institutions. The second meeting of the WB JTIs with European Commission and European Judicial Training Network (EC/EJTN) was held on 6-7 December 2017. It agreed on the need to continue with the support to the institution building processes of training centres and to start implementing the recommendations of RCC's commissioned Study on the existing systems of judicial training in Western Balkans. The Study incorporates a map of ongoing projects in the area of judicial training and proposed measures at regional level to improve independence and support institution building of WB JTI.

- The RCC and GIZ Open Regional Fund – Legal Reforms (GIZ ORF-LR) are continuing the implementation of the 20-months sub-project on ‘Improving the Regional Cooperation between Western Balkans’ Judicial Training Institutions’, targeting the training of trainers for judges and prosecutors at regional level and developing regional database of legal experts in European law. Meetings of the project Steering Committee are held back-to-back with JTIs meetings

B.3 “Anti-corruption”

B.3.1. Support in conducting sectoral corruption risk assessment / anti-corruption assessment of laws

- The RCC presented the developed Checklist for Corruption Risks in Healthcare Sector to relevant anti-corruption authorities in Western Balkans economies. The Checklist enables national institutions to apply their existing mechanisms of risk assessments in public institutions or anti-corruption assessments of laws in a very specific sector. After a number of consultations, the State Commission for Prevention of Corruption of The Former Yugoslav Republic of Macedonia agreed to apply the Checklist in the field of health insurance through conducting corruption proofing analyses of the main laws and bylaws regulating the sector. The Anti-corruption Agency of Montenegro decided to apply the Checklist in respect of hospitals, and in marketing and distribution of pharmaceuticals and pharmaceuticals devices. A specific training on the use of the Checklist will also be delivered to relevant bodies of The Federation of Bosnia and Herzegovina.

B.4. Security cooperation

Under the security component of the Stability and Rule of Law, as a part of the EU supported efforts to respond to challenges in P/CVE area, the RCC actively participated at the Kick-off Conference for the Integrative Internal Security Governance (IISG) Initiative, which took place on 8 September, 2017 in Ljubljana. The Conference focused on achievements and challenges of the regional cooperation in the area of the rule of law and security, with emphasis on prevention and countering violent extremism and terrorism. In the same context, the First Coordination Meeting for the IPA II 2016 Regional Action was organized on 19 September 2017 in Ljubljana. The current state of play and forthcoming activities of the IISG were discussed, and the Roadmap for implementation of the Regional Action agreed.

The RCC Secretariat has continued with the implementation of the **Regional CVE-FTF Platform** and support to existing specialized regional security cooperation formats in SEE.

The 7th South East European National Security Authorities Forum (SEENSA) and the 5th Meeting of the “6S” Initiative was organized on 5-6 October 2017 in Belgrade. The participants exchanged information, views and good practices on organizational structure of national security authorities (NSA’s), their respective role in national cyber and industrial security strategies as well as on regulatory framework for critical infrastructure protection.

The 9th South East European Military Intelligence Chiefs forum (SEEMIC) at the Directors’ level was organized on 7 November 2017. The Open-source intelligence Assessment (OSINT) entitled “Use of Social Networks by Violent Extremists” was adopted and various regional security topics discussed.

In line with Platform’s priorities, the regional expert workshop on “Prosecution, Detention, Rehabilitation and Reintegration of Returning Terrorist Fighters” was held on 28 November 2017 in Rakitje. Participants exchanged views on specific examples and changing trends in P/CVE engagement from national and international perspective.

The Second Regional Coordination Conference in the area of Counter-Terrorism, Prevention and Countering Violent Extremism (CT and P/CVE) co-organized by the RCC and Slovenian SEECF Chairmanship-in-Office, was held at Brdo pri Kranju, on November 30, 2017. In addition to the work in plenary session, the Conference had separate, simultaneous sessions of the NFP Group and two other regional CT and P/CVE formats: PCC SEE – led CT Network and Slovenia-led CTI Network. The Conference was another step forward in enhancement of regional security cooperation, especially in the CT and P/CVE area. Main findings and recommendations of the newly commissioned RCC study entitled „A Waiting Game: Assessing and Responding to the Threat from Returning Foreign Fighters in the Western Balkans“, were also presented at the Conference.

C. Horizontal and supporting activities

C.1. Coordination, monitoring, programming

C.1.1 Programming activities

- The reporting period served to launch the new programming cycle of the SEE 2020 Strategy for the period 2018-2020. The next steps in terms of programming are to implement the consultation process in the beneficiary economies and also with the designated regional dimension coordinators. The next steps also include implementation of the donor activities, including the 4th Annual Donor Coordination Meeting in the Western Balkans.

C.1.2. Monitoring activities

- The RCC held the 5th meeting of the SEE2020 Monitoring Committee which kick started the new monitoring cycle, including the agreement on the new timetable for collection of data on the Strategy's implementation for the Annual Report on Implementation (ARI). For the purposes of the new monitoring cycle, analysis of the main challenges was carried out and ways to address them were identified, based on which the scope and timeframe for 2018 was agreed, including the distribution of roles and responsibilities among national administrations, regional dimension coordinators and the RCC. Another SEE 2020 monitoring tool - Balkan Barometer Survey 2017 – has been finalized and launched on 9 October 2017 in Brussels. Moreover, the launch of the Balkan Barometer Survey for 2018 has also started.
- The next steps in terms of monitoring include collection of the statistical data from national and international sources for the 2018 cycle, collection of activity reports from the RDCs and preparing the first draft of the BB 2018 Survey.

C.1.3. Coordination activities, grants

- The successful candidates that responded to the 3rd Call for Proposal under the small grants program finalised the implementation of their contracts by 31 December 2017; the preparations for the 4th Call for Proposals started;
- The coordination process for the new programming and monitoring cycles with the regional dimension coordinators (RDCs) was held in the reporting period, through the SEE2020 Coordination Board, which took place in Vienna beginning of December 2017.

C.1.4. Horizontal activities related to the MAP REA

- During the reporting period the national coordination mechanisms for the MAP REA were established. The National Coordinators and Component Contact Points were appointed. The first meeting of the MAP Coordinators was held in Brussels, on 31 October 2017 to review the progress on the MAP measures and present future activities and deliverables. In addition, B2G discussions were held back to back with the first MAP NCs meeting to ensure greater synergies among different actors. Following the conclusions of the first meeting, the Guidelines on Governance, Coordination and Reporting for the MAP REA were endorsed by the MAP National Coordinators. A shared calendar of activities on MAP REA is launched to keep all actors informed and updated and other tools, such as the leaflet and video on MAP REA, were produced to increase visibility and awareness on REA.
- The RCC, tasked with the overall coordination and monitoring of the MAP REA, initiated the drafting of the Stock Taking and Needs Assessment report to take stock of the measures and resources needed to implement the key objectives set out in the MAP. National consultations on needs assessment in 4 economies are completed, with two more to be completed early 2018.
- The PM Sherpa's meeting held on 18 December 2017 reviewed the progress per MAP pillars and discussed progress in the connectivity agenda. The preparations for the Donor Coordination meeting and drafting of the methodology on MAP monitoring and reporting was launched in 2017 - a very first draft of the concept for the Donor Coordination meeting and the main outline of the methodology were prepared.

On the **Roma Integration 2020 programme**, under the RCC framework, the Roma Integration 2020 Action Team continued with the cycle of Public Dialogue Forums on Roma integration, co-organized by the Action Team and the governments in Ankara, Sarajevo and Pristina. At the forums, the National Roma Contact Points and inter-ministerial bodies, along with the Action Team, discussed the progress in the implementation of the Roma integration policies and the plans for the upcoming period, notably in terms of the upcoming budgeting and reporting requirements.

On 21-22 September 2017, the second Task Force meeting of the Roma Integration 2020 was held in Belgrade. The National Roma Contact Points from the region, along with the European Commission, the Open Society Foundations and the RCC representatives participated at this meeting. The project Action Team presented the report from the implementation of the project by the date, while the participants assessed the project implementation and provided an input to the formulation of the second phase of the project which is currently being negotiated. The process of monitoring and reporting covering the year of 2016 was elaborated and the Task Force adopted the monitoring and reporting template as final, agreeing to follow up by introducing the template as part of the official Roma integration policy. Finally, the Task Force also agreed that in the upcoming period the Action Team should pay more attention to providing assistance to the governments in more efficient public budgeting for Roma integration policies.

The Roma Integration 2020 Action Team also organized a regional conference titled "Filling in the Budget Gaps in Roma Integration Policies" in Tirana on 10 November 2017. Around 60 officials from the enlargement region participated at the conference and debated with representatives of several significant donor organizations on Roma integration budgeting priorities, cycles, requirements and opportunities, with specific focus on the financially most demanding areas – employment and housing.

On communication, the RCC Secretariat has continued with implementation of its triannual Communication Strategy which reflects the new agenda of the organisation, focusing primarily on promotion of overall RCC's activities with special attention dedicated to awareness raising and promotion of the latest core activity – MAP REA for WB6. The primary objective is to keep building

the understanding on what the RCC does, increasing political, financial as well as public support for its activities, but also to keep raising awareness of the organisation and the regional cooperation process in general, building and promoting the SEE image based on the RCC's key mission postulates.

The RCC Secretariat has produced a number of promotional materials, such as videos, brochures and infographics with the goal of explaining RCC products – Balkan Barometer, activities – MAP REA and projects – Roma Integration 2020 and ESAP. These focused materials as well as the user-friendly website combine information for different target audiences and provides overall picture of what RCC is, what are the major fields of organization's work, goals etc. The RCC Secretariat continued to maintain partnership relations with relevant regional initiatives and organisation's in promoting activities of common interest.

The last quarter of 2017 included summarizing of the monitoring results introduced with the 2017-2019 Communication Strategy. The monitoring process measured results achieved against the targets set at the end of 2016, which included significant increase in quantitative indicators as well as introduced the qualitative ones. The categories measured include: Website page views, Total number of website visitors, Average website session duration, Website bounce rate, Media reports, Media reports on RCC programming activities, Media advisories, press releases and news items and Social Media – Facebook, Twitter and YouTube. The results show that the RCC communication activities have yielded desired results and the targets were met and exceeded.

3. Management and operations

A remaining open issue related to the setting-up of the RCC Secretariat concerns the implementation of the provisions of the Headquarters Agreement between the Kingdom of Belgium and the RCC Secretariat, which regulates the status of the RCC Secretariat's Liaison Office in Brussels.

The Kingdom of Belgium has conditioned the implementation of relevant provisions of the Headquarters Agreement between the Kingdom of Belgium and the RCC Secretariat providing for the fiscal privileges and immunities of the Head and Deputy Head of the RCC Secretariat's Liaison Office in Brussels with the issuing of an official authentic interpretation concerning the implementation of Article 17.1.(d) of the Host Country Agreement by the Parties to this Agreement in which the principle of taxability of the officials of the RCC Secretariat in their countries/places of origin and/or permanent residence would be explicitly confirmed. After a consultation procedure initiated by the RCC Secretary General in August 2008 it became evident that the adoption of an interpretative declaration amending the Agreement would not be acceptable to some of the Parties to the Host Country Agreement, as they consider that such declaration would run counter to the spirit of the current provisions of the Agreement and would lead to its de facto amendment. In light of the principles of general international law, the only recourse in this situation would be to proceed with amending the Host Country Agreement accordingly, in light of the request from the Kingdom of Belgium. This, however, remains subject to the will of the Parties to the Host Country Agreement. In this view, the RCC Secretary General sent a communication to the authorities of Bosnia and Herzegovina in early January 2009, proposing to the Council of Ministers of Bosnia and Herzegovina as a Party to and, at the same time, a depositary of the Host Country Agreement to consider the possibility of initiating the process of amending relevant provisions of the Agreement in order to provide for requested confirmation of taxability. This proposal of the RCC Secretary General is still under consideration by the authorities of Bosnia and Herzegovina.

The RCC Liaison Office keeps regular contact with the Protocol of the Belgian Ministry of Foreign Affairs regarding the ratification process of the Headquarters Agreement between the Kingdom of Belgium and the RCC Secretariat (signed in 2008).

During the reporting period, there were two completed recruitment processes: the post of Head of Political Department and the post of an Expert on Regional Economic Integration.

4. Key challenges in the reporting period

The situation with regard to risks and challenges to the implementation of regional cooperation is remained and also for the foreseeable future will basically be the same. RCC will work to obtain adequate government representation and/or timely action from the beneficiaries' side. Previous experience shows that in addition to sometimes unclear mandate, the lacking of proper capacities and expertise of nominated participants to take part in various RCC-facilitated processes, as well as the multifaceted challenges the economies of the region are facing domestically tend to move away the attention from cooperation at regional level.

The streamlining of the regional cooperation mechanisms, helped by the study initiated and commissioned by the European Commission's DG NEAR, could perhaps address at least partially those concerns and challenges.
