The Report on the activities of the Regional Cooperation Council (RCC) Secretariat is submitted by the RCC Secretary General to the RCC Board in line with Article 15 of the Statute of the RCC. It covers the period between 1 September and 31 December 2016.

## **1. Summary of activities**

The report traces the progress made by the RCC Secretariat in the implementation of the Strategy and Work Programme (SWP) for 2014-2016 and in transitioning to the SWP for 2017-2019. The RCC Secretariat engaged in regional political and sectorial activities and consolidated partnerships with key regional and international stakeholders, thereby remaining seized of the most important regional trends in SEE and generating, as appropriate, inputs germane to advancing economic and social development and the European integration process.

The RCC Board, which held its 30<sup>th</sup> meeting on 12 October 2016 in Sarajevo, provided operational guidance and supervision pertinent to the well-functioning of the RCC Secretariat. The RCC Secretary General informed the participants of the Board on the activities of the RCC Secretariat and, together with the Croatian SEECF Chairmanship-in-Office (C-i-O), summarised the conclusions of the Coordination Meeting between the SEECF Troika, the RCC Secretariat and the EU. The RCC Board accepted the Report on the activities of the RCC Secretariat for the period April - August 2016 and noted the progress made in the final stage of the implementation of the SWP 2014-2016 and the main priorities of the new SWP 2017-2019. The RCC Board adopted the Decisions on the dates of the RCC Board meetings in 2017 and on the Budget of the RCC Secretariat for 2017. Furthermore, the RCC Board adopted the “Statement of Principles on Mainstreaming Gender into the RCC SWP 2017-2019”.

The RCC Board witnessed and took note of the presentations of the RCC project “Employment and Social Affairs Platform”; the Austrian Regional Cooperation Strategy for the Danube and Western Balkans Region 2015-2020; and the Special Report “EU pre-accession assistance for strengthening administrative capacity in the Western Balkans: a meta-audit” presented by the representative of the European Court of Auditors.

The Coordination Meeting between the SEECF Troika<sup>1</sup>, the RCC Secretariat and the EU, which was held back-to-back with the meeting of the RCC Board on 11 October 2016 in Sarajevo, served as a framework within which the participants exchanged views on the priorities of the Croatian SEECF C-i-O and of the RCC, particularly those stemming from the SWP 2017-2019. The Croatian SEECF C-i-O and the RCC Secretariat agreed to explore the areas where joint action can be undertaken and, in general, on the ways the RCC can effectively support the implementation of the calendar of activities of the C-i-O.

The Croatian SEECF C-i-O convened, at the outset of its chairmanship, a number of high-level meetings, thereby setting the regional tone around the themes – Connection. Communication. Cooperation. - deemed important for the South East European (SEE) region.

Connectivity, transport, energy, political dialogue and European integration were at the centre of the discussions at the informal meeting of the SEECP Ministers of Foreign Affairs (MFAs) held on 22 September in New York on the margins of the 71<sup>st</sup> session of the United Nations General Assembly. The SEECP MFAs assented to the need for better connection within the region and between the region and the EU, enhancing cooperation around projects dealing with hard and soft infrastructure, greater solidarity in response to the ongoing migration crisis, as well as for strengthening cooperation on energy security and energy supply.

A follow-up to the Western Balkans Summit, held in July 2016 in Paris, took place a day before the informal SEECP Ministerial, on 21 September. The informal meeting convened the MFAs from the Western Balkans, including the Commissioner for European Neighbourhood Policy and Enlargement Negotiations. The emphasis was on the implementation of the measures agreed in Paris; streamlining of regional initiatives and the pilot project on Young Professionals.

Furthermore, a SEECP ministerial meeting on SME Competitiveness and Growth, organised on 2 December 2016 in Zagreb, focused on the enhancement of competitiveness of small and medium enterprises through entrepreneurial learning and SME engagement. The ministerial meeting concluded with the Zagreb Charter on Lifelong Entrepreneurial Learning as a Keystone for Competitiveness, Smart and Inclusive Growth and Jobs. This will represent a steppingstone in the promotion of a cooperation model between the education and business sectors in SEE. The MPs from the SEECP Parliamentary Assembly (PA) participated in the ministerial meeting upon the invitation of the Croatian SEECP C-i-O. In the same context, the meeting of the Standing Committee of the SEECP PA, which took place on 3 December 2016 in Zagreb, has endeavoured to address outstanding issues related to the activities of the SEECP PA.

The RCC Secretary General participated in the aforementioned meetings of the SEECP and briefed the SEECP participants on the results attained in the implementation of the SWP for 2014-2016. The RCC Secretary General pointed out the main priorities of the SWP for 2017-2019, with a particular emphasis on the activities envisaged to be rolled out in support to the implementation of the triennial SWP.

The RCC Secretary General continued his regular dialogue with RCC participants with the aim of ensuring support for the RCC and its mission. In the reporting period, meetings were organised with officials from the EC, the MFA of Croatia (SEECP C-i-O), the MFA of Montenegro, the U.S. State Department, the Regional Bureau for Europe and the Commonwealth of Independent States of the UNDP and the Federal Foreign Office of Germany.

These consultations in particular served as opportunities to keep RCC participants abreast of the main activities of the RCC Secretariat, particularly those pertaining to the SWP 2017-2019, and to galvanise support for the regional cooperation process and its potential to serve as a catalyst for the European and Euro-Atlantic integration process.

Steps have been made by the RCC in order to deepen cooperation with EU institutions and bodies, in particular with the EC, EEAS and EP.

More specifically the RCC Secretariat, through its Liaison Office (LO) in Brussels, focused on raising awareness of the role of regional cooperation in the EU accession process. This included a presentation in COELA, the EU Council's Working Party on Enlargement, meetings with representatives of different DGs of the EC and relevant NGOs. The RCC Secretariat contributed further to strengthening links between the RCC and EU macro-regional strategies, in particular with the EUSDR.

The RCC Secretary General continued to represent the RCC at high-level events and international meetings with a regional dimension such as Concluding Meeting of the OSCE Economic and Environmental Forum; Belgrade Security Forum; the international conference of the United Nations Economic Commission for Europe (UNECE) "Laying the foundation in the UNECE region for economic integration and sustainable development towards 2030"; 13<sup>th</sup> Vienna Economic Forum; Friends of Europe Policy Summit; 23<sup>rd</sup> Meeting of the OSCE Ministerial Council; EU - Western Balkans Ministerial Forum on Justice and Home Affairs.

The Friends of Europe Policy Summit entitled "Balkans: Boosting Connections on the Road to the EU" was organised by the Friends of Europe, with the support of Konrad Adenauer Stiftung, the RCC, United Nations Development Programme, Trans Adriatic Pipeline and U.S. Mission to the EU. The event gathered high-level participants, including the Commissioner for European Neighbourhood Policy and Enlargement Negotiations, around the topics of EU membership; attracting businesses and investments by boosting regional connectivity; migration, youth, jobs and the perils of radicalization.

Moreover, the efficiency and cooperation of judiciaries, cooperation in matters such as migration, border management and internal security, including counter-terrorism and firearms trafficking were the main topics discussed at the EU-Western Balkans Ministerial Forum on Justice and Home Affairs held under the Slovak Presidency of the Council of the EU in Brdo on 15-16 December 2016. The RCC Secretary General highlighted RCC's actions supporting the independence, efficiency, integrity and competency of judiciaries in SEE economies.

On the **programming** side, the RCC finalised the consultation process on the SEE 2020 Programming Document 2017-2019 with both the national governments and regional partners. The process included discussions with the six SEE 2020 Strategy beneficiaries, as well as discussion with all regional dimension coordinators. The result achieved through this phase is an all-inclusive programming document, developed by keeping in consideration the national needs and translated into concrete activities. The future steps include finalisation of the draft Programming Document and its endorsement by the Programming Committee. The endorsed document will serve as a basis for the continuation of the donor consultation process.

With regard to the small grants programme, the Grant Work Programme 2017-2019 was developed and adopted. The third call for proposals was published on 25 December 2016 on the web page of the RCC. The call seeks for proposals for the implementation of the actions under the SWP 2017 - 2019 in the SEE region with financial assistance from the RCC Small Grants Instrument in the total amount of 150.000 EUR.

On the **monitoring**: the third meeting of the SEE 2020 Monitoring Committee that took place on 30 November 2016 supported the RCC in launching the monitoring cycle 2017 and approved the RCC proposal to launch the data collection process on 15 January 2017.

The meeting decided to provide for continuity of the process, and to ensure the stability of the set of indicators and comparability of results over the years. Thus, the Monitoring Committee decided to preserve the existing set of indicators, while it agreed on the necessity of an online data submission platform that RCC will work to establish. It also asked RCC to quantify the new headline indicators by the time of the meeting of the Governing Board of SEE 2020 Strategy.

After the meeting, RCC started to work on preparing the set of templates and the guidelines for data collection for national authorities and regional dimension coordinators.

The work on the attitudes and perception based indicators covered by the third edition of Balkan Barometer started. This year the Balkan Barometer 2017 has been expanded to include general public and business community of Turkey. The work on survey design, sample preparation, survey development, field work, data input, data processing and analysis was done.

With regard to **Gender Mainstreaming**, upon the successful closure of the project “Women Entrepreneurship – A Job Creation Engine in South East Europe”, the RCC has ensured sustainability of supporting gender equality in the region by mainstreaming it through the RCC Strategy and Work Programme 2017-2019 activities. Concrete measures have been proposed under the Statement of Principles on Mainstreaming Gender into Regional Cooperation Council’s Strategy and Work Programme 2017-2019, which has been approved by the RCC Board during its meeting held on 12 October 2016.

In addition to the developments related to programming, monitoring and coordination, **the implementation of the RCC Annual Work Plan 2016 continued as planned:**

- Within the **Integrated Growth pillar**, the RCC, in cooperation with UNCTAD, solicited the initial inputs for the Regional Investment Policy Review benchmark study, and thoroughly discussed the initial findings with the representatives of the SEEIC-CEFTA Joint Working Group on Investments (JWGI) during its regular meeting session in November 2016. The RCC and UNCTAD will work further with the participating economies on gathering the additional inputs to the study from each of them, with possible field visits and individual economy consultations for this purpose. The final draft report is expected to be ready by mid-2017. As follow-up, the recommendations of the Investment Policy Review benchmark study will be integrated into the implementation of investment policy reforms project that the JWGI will be working on together with the World Bank and with support of the European Commission in 2017.

During this reporting period, the RCC and GIZ have added two more activities to the investment agenda that contribute to the improvement of business and investment environment: (1) setting up the business friendliness standards and (2) implementing the electronic systems for construction permitting throughout the region. At its first meeting held in October, the Working Group on Business Friendliness Certification reviewed the state

of play in the development and implementation of business friendliness standards throughout the region and discussed the possibilities of implementing it in the economies that have not yet done so. The first meeting of the Working Group on Spatial Planning, Building and Infrastructure (WGSBI) was also held at the end of October 2016. It reviewed the status of implementation of already existing electronic building permitting and spatial planning systems throughout the region, as well as explored the possibilities of replicating these systems from one economy to another. It was agreed that the schemes proved as successful in these areas will be further used – after being adapted to the specificities of individual economies - for implementation throughout the region. This will be subject to the work of the respective working groups throughout 2017.

- Under the **Smart Growth pillar**, with regard to the **process of preparing the negotiations for the multilateral agreement on mutual recognition of professional qualifications**, at the 4<sup>th</sup> meeting of the CEFTA-ERI SEE-RCC Joint Working Group on Mutual Recognition of Professional Qualifications (15 December 2016, Tirana) the participants reached a tentative agreement based on their preliminary positions to open negotiations in both health and construction sector for all four prioritised professions (Doctors of Medicine, Dentists, Architects and Civil Engineers). Based on the agreement made, an official Note to the Governments to open the negotiations on four multilateral agreements on recognition of professional qualifications for Doctors of Medicine, Dentists, Architects and Civil Engineers will be drafted and agreed upon in the first quarter of 2017.
- Furthermore, to help design and launch a three-year action plan on the Mobility of Researchers in the WB6, the RCC commissioned a study on the topic of **Mobility of Researchers in the Western Balkans**. The focus of the study was to evaluate the present level of mobility of the WB researchers, the present policy framework, and the perceived barriers to mobility by both researchers and policy makers, as well as to develop a roadmap to overcome these barriers. For the first time in this region, the study collated comparative data on research mobility in the Western Balkans and identified a set of barriers to research mobility. Based on the study and in order to improve the research excellence of young researchers (doctoral candidates and higher), an action plan has been drafted aimed at facilitating mobility of researchers in the wider Western Balkans region, to EU-MS and beyond. The action plan will be discussed at a meeting of the Ministries of Research/Science from the region in the first quarter of 2017. The meeting is expected to adopt the action plan and establish a working group on removing obstacles to mobility of researchers.
- With the support of DG Research and Innovation and representatives of Ministries of Research/Science of the WB6 economies, the **Working Group on Open Science** has been established under the RCC auspices. The representatives of Ministries in charge of research and science have agreed to focus the work on: defining clear policies for the dissemination of and open access to scientific publications and research data resulting from publicly funded research; ensuring synergies among national e-infrastructures at European and global level; and on designating a National Point of Reference for Open Access.

- Under the **Digital Society dimension**, activities continued on the regional roaming and broadband initiatives, as part of the overall efforts for digital transformation of WB. Comprehensive consultation and validation process was launched on the findings of the first regional legal and market impact assessment of the roaming agreement. The policy dialogue platform on roaming, established by RCC, was instrumental in triggering concrete developments towards prospective joinder of new signatory parties (amendments to legal framework initiated in Albania). Given the voiced interest from Eastern Partnership beneficiaries to investigate the possibilities to replicate the regional roaming agreement currently in force in the four WB economies, RCC facilitated a process of best-practices exchange. In the framework of the broadband initiative, RCC, in cooperation with EC services, supported the regional coordination on the broadband reform structural measures that will be included in Economic and Reform Programmes for 2017-2019 and on the upcoming World Bank financed Balkans Digital Highway study.
- In **Sustainable Growth, Environment** dimension, RCC continued its efforts to strengthen regional cooperation and ensure streamlining of regional actions in the **areas of environment and climate change**. Under RCC auspices, members of the Regional Working Group on Environment (RWG Env) gathered in December to discuss future regional activities. Using this unique intergovernmental platform RCC continues further headway in enforcement of commitments agreed by the Ministers of SEE economies and articulated through the Podgorica Declaration (adopted in April 2016), as well as implementation of regional activities contributing to achieving the commitments arising from the Paris Climate Agreement. Through the RWG Env and the consultations held, RCC has also strengthened and deepened cooperation with key players/stakeholders in the areas of environment and climate change in the region such as: REC, SWG RRD, GIZ ORF, WWF, IUCN, UN Environment, UNDP, EBRD, Austrian Development Agency, Austrian Environmental Agency, Energy Community, and others.
- Related to the **regional connectivity agenda**, RCC, in cooperation with REC, worked on addressing infrastructure sustainability aspects (piloting a methodology for rapid assessment of climate resilience of core transport corridors in WB). Analytical work continued in the framework of RCC-supported comprehensive analysis of road ancillary infrastructure along TEN-T Core extension in WB and the pre-feasibility study investigating the prospects of introducing an electronic Border Queuing Management System on the extended TEN-T Road Core Corridors in WB. A Conference on Air Transport Connectivity, bringing together representatives of the principal air transport policy-makers in the WB, was co-organised with SEETO and JSPAI, to discuss the future development prospects of the air transport sector in the region.
- On the **Energy dimension**, RCC, in cooperation with the Energy Community Secretariat, initiated a regional dialogue with the ministries in charge of energy and ministries in charge of transport, aiming to improve sustainable use of energy in the transport sector. Given that sustainable use of energy in the transport sector has been a largely under-investigated area, characterised with almost non-existent progress in terms of achievement of mandatory (10%

RES in transport) targets, RCC and EnC Secretariat have provided initial targeted capacity building for use of alternative and renewable energy sources in transport.

- Within the **competitiveness** area, the SEEIC Working Group on Industrial Policy (WGIP) has reviewed the first draft of the study on economic corridors. The study focuses on strategic sectors of SEE with the goal to initiate discussions on the selection of the third priority sector of the SEE 2020. While taking into account the national strategic document priorities (ERPs priorities) and in addition to mapping the economic corridors, the study is also focused on an in-depth analysis for the prioritisation of a third sector. Due to different priorities of the participating economies and taking into account the difficulties of choosing a single sector, a cross-sectoral approach is proposed, involving automotive, machinery and mechanical industries that could jointly form a successful regional value chain. WGIP has requested further study elaboration and a more extensive proposal for the third regional priority sector. It will include a proposal on the concrete activities that would be used in the development and utilisation of the regional value chain that is going to be prepared by the RCC and external consultants (TEPAV). The proposal will be subject to discussion and final decision of WGIP in the course of 2017.

In support to the strategic sectors, the project for “Triple P” tourism concept developed by SEEIC Tourism Expert Group (TEG) has been proposed under the scope of the SEE 2020 Programming Process to the EC - MC IPA for financing, anticipating a positive decision by mid-2017. The project entails development and promotion of joint regional products, proposed policy responses to the main sector barriers, and implementation of minor-scale pilot project(s). Furthermore, the project proposal has undergone a series of intra-governmental consultations, not only within the TEG, but also with National IPA Coordinators. TEG has already started deliberating on development of regional tourism routes, which would be subject to forthcoming project implementation.

- In the **Inclusive Growth**, coordination mechanisms were established with the key beneficiaries of the ESAP project (Ministries of Labour and Social Affairs and Public Employment Services) and a detailed, demand driven work plan was approved.

In this regard, ESAP provided targeted support to the Ministries of Labour and Social Affairs from Western Balkans and Turkey in preparation of the Economic Reform Programmes (ERPs). Secondly, an analysis of employment policies and targeted analysis of active labour market policies (ALMP) based on the EUROSTAT methodology was conducted. Based on this analysis, a structured peer-review exercise aimed at building national capacity to develop a coherent set of employment policies and ALMPs will be launched in 2017. In regard to the modernisation and capacity building of PES, a process of establishing a bench-learning exercise<sup>2</sup> was launched aimed at delivering regular systematic and comprehensive analysis of PES performance and its drivers; preparing recommendations for its improvement (from a comparative as well as a PES-specific perspective); and establishing networks of partners for organisational learning and development of PES. Additionally, demand driven technical assistance instrument of the ESAP project has been launched. The Ministries of Labour and

Social Affairs and Public Employment Services from the Western Balkans - as the direct beneficiaries of this assistance - are in the process of identifying specific national needs so that they can apply for assistance in this regard.

- With regard to **health sector**, the 38<sup>th</sup> high level pre-ministerial forum of the SEE Health Network took place in Chisinau on 14-15 December 2016. While the main topic of the agenda was the future of SEEHN and how to further strengthen the network, the meeting agreed to extend the Presidency of Moldova by spring 2017 and to present the candidate to the ministers for appointment as the Head of the SEEHN Secretariat. RCC also supported the study on “Establishing a cross-border platform for emergency and response in South Eastern Europe” that will feed into the work of the Ministerial Forum of the SEEHN. It intends to identify the strengths and weaknesses of existing emergency and response services of the public health systems in all SEE economies, as well as to identify possibilities, but also legal constraints and requirements to establish a cross-border platform on emergency and response.
- There were several key developments in the area of **Governance for Growth and the Rule of Law**.

Within the **Rule of Law**: the RCC started to function as a hub for the two established SEE Networks (Judicial Training Institutions and Associations of Mediators), which serve as platforms for sharing information at regional level on events and activities, as well as a link to European training institutions. Meanwhile, the 6<sup>th</sup> meeting of Working Group on Justice organised by RCC in November in Belgrade made a positive assessment of the implementation of the Regional Action Plan on Justice (June 2014 - June 2016) and supported its continuation.

Following the consultations held with DG NEAR and DG JUST, RCC's activities focused on the efficiency and competency of the judiciaries, on enhancing the exchange of information, good practices and experiences among the participants and on organisation of regional trainings in EU law. The joint meeting of the WGJ and the Judicial Training Institutions Network, with participation of representatives from DG JUST and EU Delegation, took place on 9 November 2016 in Belgrade with the aim to map the existing national and regional projects in the judicial training field.

In addition, RCC agreed with GIZ ORF-LR to jointly implement a 20-months sub-project on “Improving the regional cooperation between Western Balkans’ Judicial Training Institutions”.

On **Anticorruption**: following the study on corruption proofing of legislation, RCC and RAI delivered a tailored training on the topic to the relevant authorities of The Former Yugoslav Republic of Macedonia and non-governmental organisations. The training provided the participants with in-depth knowledge on terminology of corruption proofing, detailed explanations on corruption risks in legislation, as well as reviews of Laws on Customs Service and Law on Procurement.

In addition, RCC and RAI organised the Annual Meeting of the SEE Coalition on Whistle-blower Protection in November 2016. With its organisation, the RCC has contributed to the SEE2020 Strategy key measure related to public awareness (researchers, whistle-blowers, media and other agencies should be actively supported and their findings considered and given ample publicity). The meeting held in Zagreb built on the results achieved so far, providing additional boost to the promotion and protection of whistle-blowers in the region. It contributed to the overall efforts encouraging the national governments to seek better legal solutions and to work more intensively on establishing policy implementation mechanisms.

In cooperation with RAI and the Bulgarian Commission for Prevention and Ascertainment of Conflict of Interest, the RCC organised the 3<sup>rd</sup> Regional Meeting of Oversight Bodies for Conflict of Interest and Asset Disclosure in October 2016. The event was attended by high level representative of anti-corruption bodies, as well as representatives of ministries of justice from SEE. The participants discussed the Draft Agreement on Exchange of Data for Verifying Assets Declarations at technical level, and agreed on the next steps in order to start official negotiations.

**Under the security** component of the Stability and Rule of Law, the RCC Secretariat continued to facilitate and support the development of effective regional cooperation mechanisms. Moreover, the RCC Secretariat has further advanced in the implementation of the regional CVE-FTF Platform.

The activities of the **specialised security cooperation formats in the region** have continued with the support and guidance of the RCC. The 6<sup>th</sup> South East Europe National Security Authorities' forum (SEENSA), held on 29 September 2016 in Podgorica, resulted in an agreement on the SEENSA web page; deepening cooperation on cybersecurity and industrial security. The participants were encouraged to focus on the conclusion of bilateral agreements on exchange of personal data. The 8<sup>th</sup> annual meeting of the South East Europe Military Intelligence Chiefs' forum (SEEMIC), held on 20 October 2016 in Chisinau, adopted the Open Sources Intelligence Assessment (OSINT) entitled "Migration crisis, roots of radicalization and violent extremism leading to terrorism in SEE". A decision was also taken on the next SEEMIC chair (Montenegro) and the topic of the next OSINT Assessment ("Use of social networks by violent extremists").

On the **regional CVE-FTF Platform**: the Regional Coordination Conference in the area of Counter-Terrorism (CT), Prevention and Countering of Violent Extremism (P-CVE), held on 11 November 2016 in Tirana, enabled exchange of information and good practices among the main P-CVE stakeholders in SEE and a greater coordination of regional efforts. The 2<sup>nd</sup> meeting of the RCC's SEE Group of National Focal Points for CVE and Foreign Terrorist Fighters (FTF) was held back-to-back with the regional coordination conference and the meetings of PCC and CTI bodies. The conference was a major step forward in strengthening regional cooperation and coordination in the area of CT and P-CVE.

The workshop on "Foreign Terrorist Fighters (FTF) – Challenges for SEE" held on 23-24 November 2016 in Rakitje (Croatia) focused on border security, rehabilitation of former terrorists and violent extremists, and human rights in the context of counter-terrorism (CT). Moreover, the RCC Secretariat

continued to support the work of SEESAC, which is a joint project of the RCC and UNDP, in the implementation of the EU-funded project on Small Arms and Light Weapons (SALW).

On the **Roma Integration 2020 programme**: under the RCC framework, the Roma Integration 2020 Action Team organised five public dialogue forums in Belgrade, Sarajevo, Pristina, Skopje and Podgorica during October-November 2016. These forums provided for discussions on national policies and priorities on Roma integration, budget proposals for 2017, including sources of funding for the proposed measures, and discussions on relevant mainstream socio-economic policies to be used for advancing Roma integration. The public dialogue forums mirrored the EU National Roma Platforms and involved a wide range of stakeholders.

The Action Team organised the first Task Force meeting of the Roma Integration 2020 on 9 November 2016 in Belgrade. This meeting gathered all National Roma Contact Points, civil society representatives and representatives from the EC, RCC and OSF. The Task Force serves for steering the project within the general political processes relevant for Roma integration in the region.

The Action Team also organised the first regional workshop on the topic of monitoring and reporting on Roma integration policies on 12-13 December 2016 in Vienna. The workshop gathered participants from the region, including the National Roma Contact Points, and representatives of line ministries dealing with education, employment, housing, health, civil registration, finance and statistical offices, as well as Roma civil society representatives. The workshop focused on acquainting participants with the methodology and application of the annual reporting template (to be used by the participating economies) and exchanging good practices in data collection and reporting.

The RCC Secretariat's **Communication** efforts continued to raise awareness about the organisation and its activities, through spreading organisation's messages to different publics, gathering pertinent media interest and media coverage. Moreover, the new RCC Communication Strategy 2017-2019 has been produced in order to reflect the new endeavours of the RCC stipulated by its new Strategy and Work Programme for 2017-2019.

### **3. Management and operations**

A remaining open issue related to the setting-up of the RCC Secretariat concerns the implementation of the provisions of the Headquarters Agreement between the Kingdom of Belgium and the RCC Secretariat, which regulates the status of the RCC Secretariat's Liaison Office in Brussels.

The Kingdom of Belgium has conditioned the implementation of relevant provisions of the Headquarters Agreement between the Kingdom of Belgium and the RCC Secretariat providing for the fiscal privileges and immunities of the Head and Deputy Head of the RCC Secretariat's Liaison Office in Brussels with the issuing of an official authentic interpretation concerning the implementation of Article 17.1.(d) of the Host Country Agreement by the Parties to this Agreement in which the principle of taxability of the officials of the RCC Secretariat in their countries/places of origin and/or permanent residence would be explicitly confirmed. After a consultation procedure initiated by the RCC Secretary General in August 2008 it became evident that the adoption of an interpretative declaration amending the Agreement would not be acceptable to some of the Parties to the Host Country Agreement, as they consider that such declaration would run counter to the spirit of the current provisions of the Agreement and would lead to its de facto amendment. In light of the principles of general international law, the only recourse in this situation would be to proceed with amending the Host Country Agreement accordingly, in light of the request from the Kingdom of Belgium. This, however, remains subject to the will of the Parties to the Host Country Agreement. In this view, the RCC Secretary General sent a communication to the authorities of Bosnia and Herzegovina in early January 2009, proposing to the Council of Ministers of Bosnia and Herzegovina as a Party to and, at the same time, a depositary of the Host Country Agreement to consider the possibility of initiating the process of amending relevant provisions of the Agreement in order to provide for requested confirmation of taxability. This proposal of the RCC Secretary General is still under consideration by the authorities of Bosnia and Herzegovina.

The RCC Liaison Office keeps regular contact with the Protocol of the Belgian Ministry of Foreign Affairs regarding the ratification process of the Headquarters Agreement between the Kingdom of Belgium and the RCC Secretariat (signed in 2008).

During the reporting period, the following staff members have joined the RCC Secretariat: Mr Zoran Popov, Political Advisor; Mr Radu Cotici, Expert on Governance for Growth (Public Administration Reform and Anti-corruption); Mr Radovan Nikcevic, Expert on Connectivity (Energy and Environment); and Ms Ivana Gardasevic, Expert on Competitiveness.

#### **4. Key challenges in the reporting period**

The situation with regard to risks and challenges to the implementation of regional cooperation remains basically unchanged. As for the previous reporting periods, in some of the regional processes it was difficult to obtain appropriate government representation and/or timely action from the beneficiaries' side. Notwithstanding the sometimes unclear mandate, the lacking of proper capacities and of proper expertise of nominated participants to take part in various RCC-facilitated processes, and the multifaceted challenges the economies of the region are facing domestically, influenced somehow moving away the attention from cooperation at regional level. Therefore, the RCC should continue to stress the importance of well mandated representation to the participating governments using also the upcoming consultative workshops in the region's capitals.

The reduction of the budget for 2017 has put an additional strain to the planning of activities for 2017. In parallel with more focused planning of activities in the prioritised areas of cooperation, RCC must work to find alternative funding sources to facilitate and/or implement those needed processes and activities for which funding is not available in the 2017 budget.
