


The Youth Policy Lab is a flagship initiative within RCC' Western Balkan Youth Lab project funded by the European Union that aims to provide opportunities for youth to participate in decision-making. Based upon conclusions of Sofia EU-Western Balkan Summits held in 2018 and 2020, Youth Policy Lab is designed to provide a safe space for youth, enabling young women and men to work jointly and at equal basis with policymakers. As such, it is seen as an important instrument which can further support the implementation of the EU Youth Dialogue concept idea in the Western Balkans.

The nature of Youth Policy Lab and its reliance on substantial contribution from youth and policy makers are best reflected in its motto: **Everyone's contribution equally matters**.

Youth Policy Lab is consisted of regional events to be attended by the Regional Pool of Experts including Kick-Off of the Thematic Regional Youth Policy Lab on Youth Unemployment, Mid-Term Review Regional Meeting and Final conference. Between each of these, National Youth Policy Labs and activities of the Working Groups at economy level will provide the opportunity to adjust the recommendations and policies to circumstances at the national level as well as enable their implementation in all WB6.
