



Balkan Barometer 2018 vs (2017)

- Perception - importance of Roma integration for
 - regional cooperation - 2.8 (2.6)
 - EU Integration - from 3.0 (2.7)
 - support remains below average
- Perception - support for affirmative measures
 - education - 76% (73%)
 - public employment - 73% (70%)
 - housing - 71% (66%)
- From 2019 - question on social distance



Monitoring Reports 2017

- Improved reports and monitoring capacity
- Increased budgetary allocations

- Remaining issues:
 - impact indicators
 - disaggregated information
 - institutional capacities
 - lack of mainstreaming
 - 54% measures implemented; 47% of budget executed

- Follow up - Meetings with Statistical Offices

Regional overview - Education

- increased enrolment and completion at all levels of education

NEEDS RESOLVING:

- from project based to institutional action
- affirmative action: improve and scale-up existing models
- **transition from one level of education to another**
- support dropouts and children returnees
- review curricula + more materials in Romani
- segregation



Regional Overview - Employment

- improved outreach
- increasing number of Roma in ALMMs

NEEDS RESOLVING:

- monitoring in period after initial employment / establish real number of unemployed
- **recognizing needs** of Roma in employment programmes
- **participation criteria** (not accounting for Roma)
- Representation of Roma in public sector
- short duration of employment programmes



Regional Overview - Housing

- construction continues (predominantly donor funding)
- more mapped territory (continue)
- introducing holistic and participative approach (implement)
- eviction and alternative accommodation criteria (continue)

NEEDS RESOLVING:

- adjust legalization criteria / do Roma benefit?
 - increase government funding
 - local level capacities & participation, discrimination
 - include Roma settlements in urban plans
 - comprehensive social housing database
 - prioritize Roma - mainstream policies

Regional Overview - Health

Outreach activities:

- health insurance
- preventive services
- awareness raising

NEEDS RESOLVING:

- over-reliance on health mediators / insufficient institutional ownership
- lacking mainstream support and information



Regional Overview - Institutional Capacities/Structure/Mechanisms

- **IDBs**
 - structure unchanged
 - meet rarely
 - should provide more inputs and decisions
- **Staffing of NRCPs offices**
- **Lack of connection to budgets - Lack of personnel dealing with expenditure for Roma integration**



Roma Responsible Budgeting Initiative

- Working Group (WG) Formed
- In-economy and WG Meetings Concluded
- Document developed

- **Main Findings:**
 - different stages of programme budgeting
 - **policy ↔ budget** (lack of/insufficient connection)
 - **exact expenditure cannot be established**
 - lack of capacities

- NRCPs in budget hearings
 - amend budget circular (expenditure reporting)





Intervention Logic


IMPACT:

*To reduce the **socio-economic gap between the Roma and non-Roma population** in the Western Balkan and Turkey.*

SPECIFIC OBJECTIVE:

*To increase the **rate of implementation** and the **budgetary allocations** for the Roma integration policies by the governments of Western Balkans and Turkey as part of the EU accession.*

Objectives (intermediary outcomes)



Improved **capacities and practices** of the governments and the civil society of the Western Balkans and Turkey **in formulating, budgeting, implementing and monitoring** their Roma integration policies, including a specific focus on mainstreaming Roma integration priorities in sector strategies and reform.



Enhanced **regional cooperation and exchange** of know how among the governments and the civil society of the Western Balkans and Turkey on the issue of integration of Roma, including concrete actions.



Increased **input** of the governments of the Western Balkans and Turkey to the process of Roma integration in the context of **EU accession**, as well as on the post 2020 EU policy on Roma integration.


Outputs: 1. Policy Capacities

- Institutional structure and policy documents.
- Mainstreaming in sector strategies and budgets.
- Actions in:
 - housing legalization, and
 - formalizing undeclared work.



Outputs 2: Regional cooperation

 - budgeting,

- Public support.





Output 3: EU Accession

 - Annual monitoring and reporting




A1.2. Sectoral Roma Integration Actions

- Implementation




A1.3. National Platforms on Roma Integration

- Link with Roma Seminars




A2.1. High level meetings on Roma integration


- Evidence for policy input





- Follow up on topics and long-term coverage




