I. BACKGROUND

Purpose

The purpose of the consultancy is to provide expert support to the State Statistical Agency (SSA) of the Republic of North Macedonia to elaborate a methodology for Roma survey. The elaboration of the methodology must be in line with the <u>Poznan Declaration</u>, indicators identified by the relevant institutions in coordination with the National Roma Contact Point, National Roma Integration Strategy and Operational Conclusions, previous regional surveys on Roma, and <u>EU's Fundamental Rights Agency's Roma Survey</u>.

Background Information

The Roma Integration 2020 action is implemented by the Regional Cooperation Council's (RCC) Roma Integration Action Team. It is funded by the European Union and the Open Society Foundations. The action is in line with the EU Framework for National Roma Integration Strategies and the EU enlargement process.

The overall objective of the Roma Integration action is to contribute to reducing the socio-economic gap between the Roma¹ and non-Roma population in the Western Balkans and Turkey in the areas of employment and housing, as well as education, health and civil registration. Specifically, the action supports the governments in the region to increase the implementation rate and budgetary allocations for Roma integration policies, through:

- direct support and technical assistance to the governments to advance existing institutional and policy framework and mechanisms for Roma integration, including promotion of proper budgeting, monitoring and reporting;
- annual assistance to reporting and review of reports in line with the EU reporting;
- direct support and technical assistance to the governments for mainstreaming Roma integration into relevant sectoral policies and reforms, and implementation of effective measures, particularly in employment and housing;
- National Platforms on Roma integration issues;
- regional fact-finding analyses and informed regional discussions through conferences for exchange of knowledge and regional standard setting;
- participation and input at EU level processes related to Roma issues;
- mainstreaming Roma issues within the core work of RCC;
- media dissemination activities challenging negative narratives on Roma integration, as well as action's visibility activities;
- regular high level/task force discussions on Roma issues at regional level.

The consultant's assignment fits in the overall Roma Integration 2020 action and shall be guided by the Roma Integration Action Team.

II. DESCRIPTION OF RESPONSIBILITIES

Objectives and scope of the assignment

The objective of the assignment is to develop a comprehensive methodology for Roma Survey for the State Statistical Agency of the Republic of North Macedonia.

The elaboration of the methodology must be in line with the <u>Poznan Declaration</u>, indicators identified by the relevant institutions in coordination with the National Roma Contact Point, National Roma Integration Strategy and Operational Conclusions, previous regional surveys on Roma, and EU's Fundamental Rights Agency's Roma Survey. It should be formulated in a way to provide relevant data for key processes, including Roma integration public policy, the EU integration process (sector

working group on Roma Integration and other relevant processes, including IPA planning and monitoring), FRA Roma Survey, Poznan Declaration progress, etc.

The methodology should incorporate the metadata, indicators, methods of sampling and data collection, statistical units, scope, objectives, and all necessary information required for a successful survey. It should also develop survey instruments – questionnaires, data recording and storing system, analytical tools and instructions, reporting instructions, etc.

Tasks:

- Elaborate a report where the expert should present the practices from other economies in the region and within EU with regard to the Roma related surveys. The aim of the survey is to propose the most appropriate approach for North Macedonia for this particular survey. The proposal for the methodology and approach should be selected and elaborated taking into account the available budget, resources available in SSA as well as the timing. The report should also elaborate on the links of the Roma survey with all other relevant policy documents, including the Poznan Declaration, National Roma Integration Strategy, EU Framework for NRIS up to 2020, FRA's Roma Survey, previous regional Roma surveys, EU integration process (sector working group on Roma integration), etc.
- Present the report and discuss with SSA, NRCP, RCC Roma Integration 2020, EU Delegation (and possibly other relevant actors) about the framework of the methodology geographical coverage, target groups, questions and toolbox of sociological instruments to be applied.
- Elaborate the methodology based on the requirements provided by SSA, NRCP and RCC Roma Integration 2020.
- Elaborate a toolbox to support SSA to carry out the survey in a quality manner.
- Provide training to SSA to build its capacities to carry out Roma survey.
- Supervise the results of the survey on Roma Inclusion.

Deliverables

During the course of the assignment, the consultant is expected to produce the following deliverables:

- 1. Report on best practices in other economies in the region and the EU regarding possible options for the Roma Survey and linkages with all other relevant documents and processes.
- 2. Training workshop for SSA staff on the variety of methodologies that may be used and discussion on the most appropriate methodological approach based on the needs of the Republic of North Macedonia.
- 3. Proposal of the methodology for Roma Survey.
- 4. Final Methodology for Roma Survey.
- 5. Toolbox to support the implementation of the methodology.
- 6. Training for SSA staff in how to use the proposed methodology.
- 7. Final report of the assignment.

Lines of Communication and Reporting

The consultant(s) will submit all reports and timesheets in English language to the Roma Integration Action Team for review and approval of deliverables. The consultant(s) will work closely with the Action Team, which shall provide guidance to efficiently conduct the work and approve deliverables. The Action Team shall also ensure the required communication of the consultant(s) with the relevant officials from the governments and other relevant stakeholders to the extent possible.

Timeframe

The Roma Integration 2020 Action Team will engage 1 consultant in the period from 03 August to 31 September 2020, for 15 days.

The support of the Roma Integration project must be recognised in the deliverables, and the support of the consultant(s) may also be recognised.

Technical offer:

For individual consultants:

- Letter of Interest, with reference to a Roma Integration participating economy for which candidate is applying for;
- CV outlining relevant knowledge and experience as described under Profile and Competencies;
- Work plan outlining the proposed action, sources of information to be used, timeline and tools to be employed by the consultant;
- Reference list including contact details (e-mail addresses) of referees;
- Submission Form (Annex I);

For legal entities and consortia of individual consultants:

- Legal entities' profile, including a brief description (up to 2 pages) of the entity. In case of a bidding consortium, the team leader should submit the profile of the consortium;
- Copy of Legal Entity's Registration Certificate (in case of consulting companies/legal entities). In case of a bidding consortium, a corresponding written authorisation, power of attorney is treated accordingly;
- Financial records balance sheet and profit-and-loss statement for the past 2 years (only in case of bidding of consulting companies);
- CV of an expert, with reference to a Roma Integration participating economy the candidate is applying for, outlining relevant knowledge and experience as described in the Terms of References, along with contact details (e-mail addresses) of referees;
- Work plan outlining the proposed action, sources of information to be used, timeline and tools to be employed by the consultant;
- List of references for relevant activities implemented over the past 5 years demonstrating relevant experience in the subject matter;

- Submission Form (Annex I);
- Signed Statements of Availability (Annex III).

Financial Offer, Annex II Budget

When preparing the financial offer, the applicant should take into account the following:

- All figures should be expressed in EUR;
- The proposed budget should include daily fee rate for consulting services broken down by tasks; the fee rates should be broadly consistent with the framework rates applicable in the region for these types of professional services.

Please make sure that the application is submitted in two separate folders one containing Technical Offer and the other Financial Offer. The documents should be submitted in a form of copies of the originals.

V. EVALUATION AND SELECTION
