

## ***Terrorism***

### Article 97

(1) Whoever aims to seriously intimidate population, compel a government or an international organisation to perform or abstain from performing any act, to seriously destabilise or destroy the fundamental constitutional, political, economic or social structures of a country or an international organisation, or commits one of the following acts that may seriously harm a country or an international organisation:

1. attacks upon a person's life which may cause death;
2. attacks upon the physical integrity of a person;
3. kidnapping or hostage taking;
4. causing destruction to a government or public facility, a transport system, an infrastructure facility, including an information system, a fixed platform located on the continental shelf, a public place or private property likely to endanger human life or result in major economic loss;
5. seizure of aircraft, ships or other means of public or goods transport;
6. manufacture, possession, acquisition, transport, supply or use of weapons, explosives or of nuclear, biological or chemical weapons, as well as research into, and development of, nuclear, biological and chemical weapons;
7. release of dangerous substances, or causing fires, explosions or floods the effect of which is to endanger human life;
8. interfering with or disrupting the supply of water, power or any other fundamental natural resource the effect of which is to endanger human life; or
9. whoever possesses or uses radioactive substances, manufactures, possesses or uses devices to activate, disperse or emit radioactive material or ionising radiation, uses or damages a nuclear facility, which results or may result in release of radioactive material, or whoever, by use of force or threat, demands radioactive material, devices to activate, disperse or emit radioactive material, or a nuclear facility

shall be punished by imprisonment from three to fifteen years.

(2) Whoever threatens to commit a criminal offence referred to in paragraph 1 of this Article shall be punished by imprisonment from six months to five years.

(3) If a criminal offence referred to in paragraph 1 of this Article causes extensive destruction or death of one or more persons, the perpetrator shall be punished by imprisonment for not less than five years.

(4) A perpetrator who in the course of committing a criminal offence referred to in paragraph 1 of this Article deliberately takes the lives of one or more persons shall be punished by imprisonment for not less than ten years or by long-term imprisonment.

### ***Terrorist financing***

#### Article 98

(1) Whoever provides or collects funds, directly or indirectly, with the intention that they should be used or with the knowledge that they are to be used, in full or in part, in the commission of one or more of the criminal offences referred to in Article 97, Articles 99 to 101, Article 137, Article 216, paragraphs 1 to 3, Article 219, Article 223, Article 224 and Articles 352 to 355 of this Code or a criminal offence intended to cause death or serious bodily injury to a civilian or another person not actively involved in armed conflict in order to intimidate population, or to compel a government or an international organisation to perform or abstain from performing any act shall be punished by imprisonment from one to ten years.

(2) The punishment referred to in paragraph 1 of this Article shall be imposed on whoever provides or collects funds, directly or indirectly, with the intention that they should be used or with the knowledge that they are to be used, in full or in part, by a terrorist or a terrorist association.

(3) The funds referred to in paragraphs 1 and 2 of this Article shall be confiscated.

### ***Public incitement to terrorism***

#### Article 99

Whoever publicly states or disseminates ideas that, directly or indirectly, incite the commission of a criminal offence referred to in Article 97, Article 98, Article 137, Article 216, paragraphs 1 to 3, Article 219, Article 223, Article 224 and Articles 352 to 355 of this Code shall be punished by imprisonment from one to ten years.

### ***Recruitment for terrorism***

#### Article 100

Whoever solicits another person to join a terrorist association to participate in the commission of a criminal offence referred to in Article 97, Article 102, Article 137, Article 216, paragraphs 1 to 3, Article 219, Article 223, Article 224 and Articles 352 to 355 of this Code shall be punished by imprisonment from one to ten years.

### ***Training for terrorism***

#### Article 101

Whoever provides instruction in the making or use of explosives, firearms or other weapons or noxious or hazardous substances, or in other specific methods or techniques, knowing that the skills provided are intended to be used in the commission of a criminal offence referred to in Article 97, Article 98, Article 137, Article 216, paragraphs 1 to 3, Article 219, Article 223,

Article 224 and Articles 352 to 355 of this Code shall be punished by imprisonment from one to ten years.

### ***Terrorist association***

#### Article 102

(1) Whoever organises or directs a criminal association whose objective is the commission of a criminal offence referred to in Articles 97 to 101, Article 137, Article 216, paragraphs 1 to 3, Article 219, Article 223, Article 224 and Articles 352 to 355 of this Code, or of another criminal offence intended to cause death or serious bodily injury to a civilian or another person not actively involved in armed conflict in order to intimidate population, or to compel a government or an international organisation to perform or abstain from performing any act shall be punished by imprisonment from three to fifteen years.

(2) Whoever becomes a member of a terrorist association referred to in paragraph 1 of this Article or commits an act with knowledge of the fact that it will contribute to the objectives of a terrorist association shall be punished by imprisonment from one to eight years.

(3) A perpetrator of a criminal offence referred to in paragraphs 1 and 2 of this Article who, by the timely disclosure of a terrorist association, prevents the commission of a criminal offence referred to in paragraph 1 of this Article, or a member of a terrorist association who discloses the association before committing a criminal offence referred to in paragraph 1 of this Article as a member of the association or for the association may be remitted from punishment.

### ***Planning criminal offences against the values protected by international law***

#### Article 103

Whoever plans the commission of a criminal offence referred to in Articles 88 to 91 and Article 97 of this Code shall be punished by imprisonment from six months to five years.
